

## **COMPASSION PERSONIFIED**

Norma Crooks retired from her nursing career with the Calgary Health Region in August of 1993, and promptly began volunteering with Hospice Calgary's Living with Cancer Program. When in May of 1996, Hospice Calgary opened Rosedale Hospice, Norma moved over to this team as a palliative patient care volunteer. In this role, she supported Hospice Calgary for an incredible 17 years, up until just this spring.

On top of her volunteer shifts at Rosedale, for two and a half years, Norma was also the volunteer lead, which involved training and mentoring new recruits, as well as scheduling all of the other patient care volunteers. Even following her retirement from this role in the spring of 2010, Norma continued to volunteer with patients—always being accessible to listen and provide advice and encouragement to everyone around her.

Given her practical expertise, great compassion and gentle presence, Norma is loved and respected by all of Rosedale's nursing staff, volunteers, patients and families. Her presence will be greatly missed at Rosedale, but she will continue to be a member of the Hospice Calgary family.



# 2012-13: COMPASSIONATE SUPPORT AT A GLANCE

- Over 2,000 children, teens and adults received support through Hospice Calgary Sage Centre counselling and group programs, and Rosedale Hospice 24-hour hospice care. Up 5.5% over last year.
  - Over 2,200 professionals, volunteers and community groups participated in Sage Centre workshops and training related to end-of-life care and grief support. Up 13.4% over last year.

Whether through direct service of Hospice Calgary clients or fund development & administration, 290 incredible volunteers provided 11,010 hours of service.

### **OUTCOMES IN DETAIL**

887 individuals grieving a loss due to illness, sudden or expected death, accessed grief counselling and/or group programs

612 patients and family accessed end-of-life care and support at Rosedale Hospice

439 individuals with a palliative illness accessed counselling

140 individuals with advanced cancer diagnoses and family, accessed the Living with Cancer Program.

## **END-OF-LIFE SUPPORT**

Hospice Calgary provides a continuum of compassionate end-oflife support.


At Sage Centre or in the home, individuals and families who are living with a life-threatening illness may receive information, guidance and support.

In the peaceful, home-like setting of our Rosedale Hospice, physicians, registered nurses and personal care attendants work with counsellors, a spiritual care coordinator and volunteers, to provide adult cancer patients who are at the end of life with medical care, physical comfort and support.

### C

A compassionate environment for sharing feelings and developing positive ways of coping can make life's most difficult changes a little easier.

When life-threatening illness, sudden or expected death impacts a loved one, Hospice Calgary's counsellors provide information, guidance and support. We offer counselling at Sage Centre, in the home or elsewhere for families living with life-threatening illness. As well, we specialize in grief support for children, teens and families who are coping with sudden or expected death.



## **SAGE CENTRE WORKSHOPS**

Hospice Calgary is committed to offering high quality education and is an approved provider of "A Level" social work continuing education credits.

At Sage Centre, we provide accredited workshops and training for health care professionals, social workers, teachers, psychologists, funeral directors and volunteers who want to broaden their understanding of palliative and hospice care; or enhance their skills with youth and families impacted by life-threatening illness, sudden or expected death. Children and teens often feel different and alone when faced with the life-threatening illness, sudden or expected death of a loved one. Through our support groups—Kids Club, Dream Catchers and Mentoring through Grief—Hospice Calgary connects youth with others in similar situations.

Focused on camaraderie and quality of life, Living with Cancer is our weekly program for adults with advanced cancer. Facilitated by staff and trained volunteers, participants learn from each other about ways to live each day to the fullest while transitioning towards the end of life. Family and friends are always welcome.
