# The Health Care Reform Center

The Patient Protection and Affordable Care Act (the "PPACA") of 2010 ranks among the most sweeping pieces of US legislation ever signed into law. No individual, organization or business entity has been left untouched by the health care reform legislation.

As a result of its sheer breadth, the PPACA has also emerged as one of the most litigated acts in US history. While the US Supreme Court recently decided in favor of the act's constitutionality (thanks to a crucial vote by Chief Justice John Roberts), numerous interpretive challenges to its substance and the form of its implementation will likely remain for years to come.

The law implicates diverse areas of law, including ERISA, health care, insurance, labor and employment, litigation, regulatory compliance, privacy and tax. It has substantial financial effects on every US citizen, business and governmental entity, and drastically affects the delivery of health care.

Given its sheer scope, how do employers, health care providers and insurance companies begin to tackle the challenges involved in understanding, implementing and complying with this vast law? Enter the Hunton & Williams Health Care Reform Center.

A cross-disciplinary team of lawyers from throughout the firm's offices, practices and industry-focused groups, the Health Care Reform Center is an innovative legal-services platform that offers clients comprehensive, coordinated solutions to the challenges and opportunities created by this new law.

The team is led by L. Scott Austin (Employee Benefits, Atlanta and Dallas), Mark Hedberg (Health Care, Richmond), David Mustone (Employee Benefits, McLean), Leslie Okinaka (Employee Benefits, New York) and Greg Robertson (Labor & Employment, Richmond). The team leapt out of the gate in mid-2010 with a series of client alerts, webinars, presentations and other events to help get employers up to speed on the implications of the new law. Team members are now working one-on-one with clients to help them develop and implement the policies and procedures that will ensure compliance with this complex legislation.

# Listening to Clients: 'What Do We Do Now?'

"From the beginning, this legislation was marked by uncertainty," says Austin. "Not only was it unclear whether the Administration would prevail in moving the PPACA through Congress, but, almost immediately after it was signed, a series of courtroom and legislative challenges were mounted in order to repeal or modify the act in part or in its entirety."

Adds Hedberg, "We knew that clients had many questions about the act and its implications. Everyone — employers, senior executives, health care providers, trade associations and governments — wanted to get their arms around the many issues involved. Most important, businesses were asking, 'What should we do now?' No one



wanted to be caught unprepared, even if they weren't sure of the end result of the many challenges to the act."

The first step was to get organized. Tapping leading lawyers from our offices across the country and from many key practice areas, the firm created a multidisciplinary health care reform steering committee. In addition to their own areas of concentration, members of the steering committee are familiar with the PPACA, the associated regulatory and judicial processes that continue to unfold and potential effects of the law on individuals and employers.

The team then created the Hunton & Williams Health Care Reform Center website, at www.huntonhealthcarereform. com. The site includes a news and alerts section that provides information about recent courtroom and legislative developments related to the PPACA. A publications page offers links to copies of the HITECH Act, the PPACA and the recent Supreme Court decision, as well as to articles that analyze specific aspects of the law. Other pages feature links to firm practice descriptions and blogs, as well as access to key lawyer contacts from various practice groups and offices.

Once the core team was assembled, the group launched a series of open webinars. Aimed at a broad spectrum of existing and potential clients, including businesses, industry groups and concerned individuals, these webinars covered many of the fundamental aspects of the PPACA and attempts to provide practical guidance about what businesses needed to do at the moment. Some were broad overviews of the two laws, while others were focused on specific aspects, such as open enrollment, accountable care organizations ("ACOs") and health information technology.

# Finding Certainty in Uncertainty

In addition to these webinars, firm lawyers fanned out across the country, attending industry meetings, participating in roundtables and making presentations on the legislation. Members of the team advised clients on actions they should take now and helped them plan ahead for features of the law that, if left intact, will go into effect over the next several years.

One of the greatest challenges in complying with the PPACA is the uncertainty that has surrounded its implementation. In one sense, "the horse has left the barn": many believe that some form of health care reform will stay in tact even if certain aspects of the law change as a result of future legislative action. Clients need to know however, where they can allocate their efforts and resources most effectively.

Notes Mustone, "Now that the Supreme Court has ruled on the act's constitutionality, attention is turning to the upcoming election. Future litigation on the proper interpretation of certain aspects of the law may well have effects on certain provisions of the PPACA, but the primary question on everyone's mind now is how the post-election balance of power in Washington might affect the efforts of Republicans to repeal the act and of Democrats to uphold it."

While no one can predict the future, one advantage of the firm's cross-disciplinary approach is that it brings in voices and ideas from various disciplines that may not always have been heard when making key decisions. Says Mustone, "In the past, for example, we might have answered a health care-related employee benefits question based on the knowledge of our employee benefits lawyers and our experience with best practices. Today, through the Health Care Reform Center, we draw on that same background — and bring in regulatory, tax, government relations and other lawyers who can offer new options and insights so that clients get the best result possible."

# Demonstrating the Firm's Strengths

"Hunton & Williams has long been known as the law firm of choice in a number of important areas of law," says Austin. "What clients haven't always known is that, working together, we regularly develop creative, comprehensive solutions that multiply the value of our counsel. The Health Care Reform Initiative is just one way of demonstrating these strengths."

"The key to the success of the initiative is not that every lawyer knows every aspect of the legislation," says Robertson. "What is most important is that we know where to go for answers, and that we have a process for communicating with each other to provide clients with the information and counsel they need. The end result? Our clients will be better prepared for health care reform, no matter what form it takes."
