- Adjusted RTD annual budget down for revenue by 2017 to \$30 million
- No capability to borrow or bond until 2026
- RTD estimates forgone revenue of approximately \$1.1 billion due to recession

- \$3 billion of private development around Union Station
- \$1 of transit infrastructure investment = \$4 injected in the local economy

Eagle P3 Update

Eagle P3 Project (A, B, and G Lines)

The first transit project of its kind in the U.S.

- A 34-year Public-Private-Partnership (P3) Concession in which Denver Transit Partners performs design, build, operations and maintenance, and provide partial financing
- Three commuter rail lines (A, B & G), rolling stock (trains), & maintenance facility (CRMF)
- Project cost: \$2.1 billion total, \$1 billion Full Funding Grant Agreement (FFGA), TIFIA loan, regional sales tax
- Regulatory agencies: Federal Transit Administration (FTA), Federal Railroad Administration (FRA), and Colorado Public Utilities Commission





Eagle P3 Update

University of Colorado A Line opened in April 2016

- Average weekday ridership 22,500
- ~94% on-time performance year to date (RTD Board adopted goal is 90%)
- 12 at-grade crossings with 2 attendants at each crossing 24/7

• B Line opened in July 2016

- Average weekday ridership 1,800
- ~98% on-time performance year to date
- 1 private crossing, attendants removed October 16 (FRA approval)

• G Line is fully built since 2016

- Ready for final testing, was scheduled to open in October 2016 (over \$500 million infrastructure investment)
- Currently in violation of FFGA and TIFIA revenue service date of December 31, 2016, recovery plan submitted to FTA and TIFIA
- 16 grade crossings (including 1 private), 15 crossings with 2 attendants each 24/7 for 4-6 freight movements a day using similar grade crossing controls as before the Eagle Project
- RTD petitioned the PUC in May 2017 to remove crossing attendants, denied by Commission




Eagle P3 Update

Current Regulatory Status


- FRA issued a 5-year waiver for the University of Colorado A Line and the B Line on September 28, 2017 (essentially accepting grade crossing design and operation)
- FRA issued a conditional approval for RTD to complete testing on the G Line, including crossing systems on October 11, 2017
- FRA approved removal of crossing attendants on the B Line private crossing on October 16, 2017
- RTD submitted motions to amend 3 crossings on the University of Colorado A Line.
 The Commission denied the motions on the September 27, 2017 docket (except for certain civil items)
- RTD submitted motions to amend the G Line crossings to complete grade crossing testing. The Commission denied the motions on the September 27, 2017 docket
- Commission had further discussion on RTD motions on the October 4, 2017 docket
- RTD received written orders from the Commission on October 25, 2017
- RTD will request a rehearing as stated in the orders and provide additional evidence



Steele Crossing







 - Provide concensus-based, fiscally sustainable recommendations to RTD staff





- Construction contract \$26,127,600
- 12 18 month estimated construction schedule
- Designer SEH
- Constructor Mortenson
- Free MallRide service begins November 12
- Grand opening celebration December 15
- All revenue service begins December 17





- Mall is 34 years old original design expected lifespan is 30 years
- Beyond wear and tear, pavers require frequent maintenance in excess of \$1 million/year
- Service disruption and safety issues for all users
- Federal grant in 2012 to rebuild several blocks
- Bids greatly exceeded estimates and budget
- Initiated an environmental process to address transit way surface
- Expanded environmental process is underway (CCD, RTD, DDP)
- Five possible alternatives identified
- Estimated selection of preferred alternative Q1 2018



16th Street Update

- 36 new shuttles
- 100% Battery Electric
- Range: >150 miles or >24 hrs. on the mall
- Capacity: 18 Seated and 88 Standees
- Continuous low floor with a rear window
- 3 wide passenger doors
- Two wheelchair spaces and designated locations for luggage
- Passenger compartment air conditioning and heat
- Approximately \$750,000/shuttle
