

- 1. Call to Order: President Hickey called the meeting to order at 5:05 p.m.
- 2. Association Comment: None.

Request for Endorsement for San Diego County Bar Association Board Thomas Penfield and Victor Torres: Civil attorney Thomas Penfield and criminal defense attorney Victor Torres both requested an endorsement for the San Diego County Bar Association Board of Directors. The election will be held this fall in October-November 2010. Matter discussed in Executive Session. The Board voted not to endorse any candidates in this race other than previously endorsed DDA Patrick Ojeil.

It should also be noted that while the Board recognizes the helpful contribution of the current volunteer attorneys, the Board is committed to having our office remain a career prosecutor office.

# Local cities target pension plans

Governments trying to reduce burden by asking employees for contributions

First with city halls that go dark every other Friday, then with hiring freezes and furloughs, local cities have sliced labor and operating costs amid these rough economic times.

Now, they are trying to reduce the burden of their pension programs. In some cases, that means public-safety employees are contributing to their pension funds for the first time. Elsewhere, new hires are channeled into a "second tier" with lower costs and smaller benefits.

By one count, 10 of the 18 cities in San Diego County have tinkered with pension contributions in the past year. San Diego and Carlsbad each have November ballot measures addressing the topic.

"It's a sign of the times," said Jessica Levinson, director of political reform at the Center for Governmental Studies in Los Angeles. "When cities and counties are so strapped for cash, they're going to ask their public employees for sacrifices."

In cities where employees haven't had a raise lately, the increased contributions amount to a pay cut, said Joan Raymond, president of the city's blue-collar union.

"It's kind of an easy fix compared to other types of solutions," such as increasing fees or raising other revenues, Raymond said.

But to the San Diego County Taxpayers Association, the increases are long overdue.

Lani Lutar, president of the primarily business-oriented consortium, said employer "pickups" of pension contributions were an optional perk that got out of hand.

"That was never supposed to be the norm," she added.

A typical pension under the California Public Employee Retirement System has an employee or member contribution of 7 percent to 9 percent of the employee's salary. (The pensions are an alternative to Social Security, which doesn't cover public employees in California.)

Despite the name, in many jurisdictions all or part of the employee contribution has been paid by the cities on behalf of their workers. Now more cities are saying they can't afford the offset.

In Poway, employee groups this year agreed to contribute an additional 1 percent of their salaries toward pensions even though their pay has been frozen since 2008.

Looking at its revenue and spending projections, the city realized the previous program was "unsustainable," said Assistant City Manager Tina White. "We don't know of any revenue source that will grow as much as we expect our operating expenses, including our pension costs, will grow."

The 1 percent move saves the city \$700,000 annually from a total operating budget of about \$76 million, White said. A second tier for new hires is under discussion for the next round of contracts, she added.

Pension initiatives taken this year in other parts of the county include:

- Oceanside firefighters agreed to pay 4 percent of their salaries toward a 9 percent employee contribution, the first time the city has not shouldered the full cost itself. The agreement, which goes to the City Council for a vote Sept. 22, was part of a contract with a 2.5 percent pay increase and a boost in minimum staffing.
- Solana Beach lifeguards' and firefighters' contributions to their retirement funds, formerly 2 percent or less, will increase to 9 percent. Benefits were reduced for new hires.

• Carlsbad firefighters now shoulder the entire 9 percent employee contribution and police will do so in 2011, the second year of a phased-in change. Both changes were imposed on the labor groups after an impasse in contract negotiations.

If it passes on Nov. 2, Carlsbad's Proposition G would require voter approval for any future increase in pension benefits for public-safety workers.

El Cajon, Escondido, La Mesa, Lemon Grove, National City and Santee also have taken steps in the past year to raise the amount their employees pay toward pension contributions, according to the taxpayers association.

In San Diego, which has a \$2 billion pension debt, changes to retirement benefits account for four of the 10 conditions attached to Proposition D, a half-cent increase in the city's sales tax.

Among other conditions, the city would be obliged to reduce its share of the employee pension contribution for most workers and to eliminate them altogether in employee contributions for elected officials and managers.

Councilwoman Donna Frye, a leading proponent of the Nov. 2 measure with Mayor Jerry Sanders, acknowledged that no dollar figure can be placed on the savings to be derived from most city workers because it depends on the outcome of collective bargaining. The savings from dropping elected officials and managers is estimated at \$400,000 a year.

Frye mentions the same flagging economic conditions cited by critics, such as Raymond, in defending the action.

"When you have high unemployment and people that are losing their homes," Frye said, "the contrast between those who are employed and those who are not becomes even greater."
