## Dear. Ms. Balogh:

You have inquired whether Section 13.2 of the attached Project No. E15-RER-02 Non-Exclusive Professional Services Agreement ('PSA") meets the requirements of the County Ethics Code and whether this section correctly requires that financial disclosure must be filed within 30 days of signing the contract. You advise that this PSA is subject to competitive negotiation.

Section 13-2 of the PSA reads as follows:

13.2 The CONSULTANT shall comply with the financial disclosure requirements of Ordinance No. 77 13 by filing, within thirty (30) days of the execution of this Agreement, one of the following with the Miami-Dade County Elections Department, P.O. Box 012241, Miami, FL 33101:

- A. A source of income statement OR
- B. A current certified financial statement OR
- C. A copy of the CONSULTANT's current Federal Income Tax Return.

Section 13.2 of the PSA cites Ordinance number 77-13 (attached) which amended certain sections of the County Ethics Code (Section 2-11.1(i)) that address financial disclosure requirements. We would therefore recommend that this section of the PSA agreement be changed to include both Ordinance Number 77-13 and the financial disclosure section of the County Ethics Code; Miami-Dade Code Section 2-11.1(i). We further recommend that 13.2(A) be amended to: "An **itemized** source of income statement "to reflect the current language of Section 2-11.1(i) of the County Ethics Code.

We also confirm that the 30 day filing requirement set out in Section 13.2 of the PSA, meets the County Ethics Code at Section 2-11.1(i)(4) which states that all persons or firms which engage in competitive negotiation with Miami-Dade County shall comply with the financial disclosure requirements set out in Section 2-11.1(i) of the County Ethics Code within 30 days of the execution of the contract.
