**Mat Area:** The tournament will use 4 mat areas with electronic scoreboards along with the CARE system.

**Judo Gi:** Blue & White Gis are required for 17 – 20 year olds & Senior Elite Divisions. All athletes and/or clubs must bring their own BLUE & WHITE Belts/Sashes for Juniors, Senior Novice & Veterans. IJF Approved Gis are not required. Official IJF Back patches are not required.

**WEIGH-IN INSTRUCTIONS AND FORMS:** Attn: All Judo Instructors/Club Owners, **This year we are moving our late registration and weigh-ins to the day before Saturday, April 18<sup>th</sup>.** You will be able to **check in at North Jersey Judo between the hours of 11:30am to 4pm again on Saturday, April 18<sup>th</sup>.** There will be **NO LATE REGISTRATION OR WEIGH-INS the day of.** I also have designated weigh-in stations throughout the **NJ, NY, MD, PA, MA & VA region for those coming from far.** In order for those to weigh-in at these stations you have to already be registered online no ifs and or buts. From there the folks designated at those stations will report back to me so I can do the pools sheets that evening and posted online for everyone to see. We are moving to this format because we expect a big turnout and we want our event to start on time and for everyone to know where their mat will be. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and, if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including traumatic brain injury (TBI), permanent disability or death, and severe social and economic losses due to not only my own actions, inactions, or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks, and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. **Release, waive, discharge, and covenant not to sue USJI, USJA, or USJF, Judo of New Jersey, Inc.
