

Message From President MANNON



Since my last message, our union had some great news from Albany. Governor George Pataki signed into law our Residency Bill at the end of December. Chapter 760 of the Laws of 2005 will allow Sanitation workers the option of living in areas outside of the five boroughs and Nassau and Westchester counties. This was a great success for our members and one we can all be proud of.

A few technical amendments need to be made to the bill this year. By working with the Sanitation Officers Association, we presented a unified front to the Governor that helped us get the law signed. Of course, our lobbyist Floyd Holloway also put in a tremendous amount of work to help us and for that we're very thankful.

In early February I attended the Annual Breakfast sponsored by the New York State Public Employees Conference (PEC), of which I am the Treasurer. This breakfast is a gathering of all PEC members, which now total more than 50 public-sector unions throughout the state. The Governor, Senators, Assemblymen and their staffs, and other guests were invited. This is an important event due to the high profile it creates for us. This annual event gives public-sector unions the chance to present our legislative agenda to our statewide Legislators and let them know what bills are our top priority. I attended many meetings before and after this event that provided more of an opportunity to push for benefits that will enhance the lives of our PEC members.

I have been involved with many meetings with the Commissioner and his staff and the City on our contract negotiations. The meetings are moving forward in a progressive way, but not as quickly as I would like. I feel that once the City and the Department get on the same page with each other talks will move a little quicker. I have several more meetings set with both in the days to follow. As I mentioned at the Union meetings, as well as in my last message, I will only bring a contract to the membership when I feel it will be the best I can possibly get. I appreciate your support and patience on this very important matter. It would be foolish for everyone involved to accept a deal simply to say "we have a new contract."

In early January I attended the annual Municipal Labor Committee (MLC) conference held at the UFT headquarters. The theme of this year discussions was "The Next Four Years". Panels were set up to focus on an agenda for the next four years, health care issues and of course, the City's budget. Speakers on all of the panels were very informative and to the point. If you followed the TWU's contract negotiations, strike, contract vote and it's on going aftermath (and who could have missed all that?), we are all in for a rough ride in the next round of bargaining. The MLC speakers expressed the same concerns for us in this coming round. "Tier 5" and Health Care costs will be major issues for us all. Just listen to the Mayor. He is already setting the stage. I have been involved in discussions with other MLC unions about the possibility of coalition bargaining and will be open to this option if it will help all of us get good contracts.

One last update. The Active and Retirees Welfare books have finally been updated. They are currently being reformatted to make them easier to read and follow. The new design will also allow us in the future to make corrections or updates as needed without having to reprint the entire book. Both books will soon be to the printer and then on their way to you. I know this process took a while, but it will be worth the wait.

As you can see, the past two months have been very busy ones for our union. With the new Legislative session underway in Albany, the Governor releasing his final state of the state address in early January, the Mayor presenting his state of the City and his proposed budget, it has left our union with many issues to get involved in during the year. If you have any suggestions or comments, please feel free to get in touch with our office. This is your union. Together we will keep it strong.

Governor Signs Union's Residency Bill into Law

The Sanitation Officers Association received a large Christmas president from Governor Pataki when he signed the union's residency bill into law on December 20 of last year. This new law, Chapter 760 of the Laws of 2005, gives Sanitation officers and workers the residency privileges previously afforded to some uniformed forces.

"This was a great accomplishment for us," said Local 444 President Joseph Mannion. "This is something our members deserve and need for their families. By giving us great options as to where we can live and still maintain our jobs opens up a whole set of doors that were previously closed."

Prior to this new law, Sanitation workers could only live within the five boroughs, as well as Nassau and Westchester counties. The new law extends the allowable counties to include Suffolk, Rockland, Putnam and Orange counties for those employees with more than five years on the job. Union Lobbyist Floyd Holloway said the Legislature has already submitted an amendment to the law to clarify what counties are or are not allowable.

"This new law allows sanitation workers to enjoy the American dream. They can move to the suburbs, buy a home and own property. They won't be tied down to living in the five boroughs," Holloway said.

Mannion said that the legislative sponsors of the bill agreed to make the changes after the bill became law so that the Governor would sign the original bill submitted last year and the union would not have to start from scratch this year.

"I have received many phone calls from members and non-members with their concerns over the changes. I assure you that I have your best interests at heart," Mannion said. "I have made many phone calls to Assembly and Senate members and their staffs expressing our concerns and our needs with this chapter amendment. I have made trips up to Albany and have met with some important 'friends' to discuss our issues."

Mannion said he has been assured by reliable Albany insiders that the Chapter amendment will ultimately give the same benefits to sanitation workers as currently being given to other uniformed unions. "I've been told that Suffolk, Rockland and Putnam are definitely included. Orange County will most likely remain as well. I believe that if the language of Police, Fire and Corrections is used, we will have no problem," he said.

Mannion said that the union owes its thanks to all those Legislators who helped get the original bill signed into law, and are working now to ensure the Chapter amendment's success. In the Senate, the bill was sponsored by Sen. Vincent Leibell (40th District). In the Assembly, the sponsors were Assemblywoman Roann Destito (116th District) and Assemblyman William Boyland, Jr. (55th District). The union also extends its thanks to Edward Bartholomew Jr., Assistant Counsel to Senate Majority Joseph Bruno, and of course Gov. George Pataki for signing the bill into law.

"This never would have been possible without the many hours of hard work by our lobbyist Floyd Holloway, who not only had to put up with my many calls, but also assisted me in the many meetings we had in Albany," Mannion said. "I would like to also thank Harry Nespoli and his lobbyist Robert Bishop. The work Bob did in the City as well as in Albany was much needed to get this done. It goes to show you, as I commented in my last message, when you work together with a common goal we all become winners. I look forward to working with Harry on future endeavors to enhance the lives of all of our members. Thank you all.

Union Prepares New Welfare Fund Books

The Union has just completed a redo of its Welfare Fund Books. They will be sent to the printer shortly and then mailed to members. There are several different types of mailings, however. Active and retired members who have and old book and binder, will receive only the new "guts" to insert into your binders. Discard the old pages to prevent any confusion.

The second mailing is to new Officers and retirees who never received any book. You will receive a binder, tab pages and the new "guts." Please read the updated benefit books and keep them in a safe place.

If you need to replace your book there is a fee. You may, however, go to our web site and print out the book's contents for free. We will let you know when the new text has been posted to the website.

Update Your Beneficiaries

Chances are you have an array of life insurance policies, pensions, IRAs, 401(k)s and other retirement accounts. Every one of them required you to name a beneficiary. Make sure your beneficiaries are current. No matter what your will says, the person(s) named as beneficiary(s) on these accounts will get the money.

Financial advisers say the beginning of the year is a good time to review all your beneficiary information. If you're over 60, do it every January.

To make changes to your pension (preretirement), 401(k)s, 457s and life insurance policies, call the plan administrators to update this information. For IRAs, contact the bank or financial institution where the money is deposited.

After all, you worked hard for your money. You should have peace of mind knowing that when you're not here anymore, only those whom you wanted to have your money, actually inherit it.



A Brief NOTE

NYC TRANSIT VS. PERB As the result of a recent PERB decision extending Weingarten rights to public sector employees, those public employees called into a meeting that the employee reasonably believes might result in disciplinary action have the right to union representation during the meeting. However, employees MUST ASK for the union representation. It is NOT the employer's obligation to ensure that the protection is provided. Any member called into such a meeting should be aware that they have the right to union representation and should call the union office immediately for assistance.

Message From 1st Vice President MAZZOCCHI



In my last article I wrote about the recently signed Pension Loan Repayment Program. I explained in detail how you go about entering the program and how to pay off your loan.

To my surprise I received more than a few calls on this issue, most questioning if it was a wise decision to repay a pension loan and reap the reward of a full pension once and for all.

What I am going to explain now should be looked at by ACTIVE members as well as RETIREES because it involves the old adage "how to make money work for you."

If you are going to retire, you don't "just do it." You have to ensure financial stability for the rest of your life. When you retire, you should have a definitive plan that covers all bases. I can't tell you how to go about that in great detail, but can highly recommend you seek some professional guidance if you're unsure.

However, I do want to address the Pension Loan Program and how to take advantage of it. Taking a loan is your decision, but remember that there are basically two reasons for doing so — need and future allocation.

SCENARIO #1:

The first case example involves a retiree called Tony Tier One. Tony retired in 1989 at age 54 with existing loans totaling \$16,000. This will deficit his pension more than \$90 a month or about \$1,446 yearly. The smaller your pension, the less tax you pay. So on a \$1,446 pension deficit, you will save approximately \$200 a year in federal tax. (Residing in New York you only pay federal tax on your Pension).

It took Tony Tier One a little more than 11 years to equal what he had borrowed from the pension. He is now 69 years old and wants to know if he should pay back the lump sum \$16,000 he borrowed 15 years earlier and reap the reward of getting a full Pension with a little more than \$90 a month increment for the rest of his life.

Remember, it will take 11 years to satisfy the \$16,000. The year will be 2017 (Tony will be 80) before Tony Tier One is receiving what he had not paid into the pension.

SCENARIO #2:

The next scenario involves Philly Frugal Tier Four. (Yes, the bill now includes all tiers.) Philly retired in 2004 and took a loan 10 days before the Close of Business Date. At age 48 the borrowed amount was \$20,000, resulting in almost \$120 less in Philly's pension check every month.

Philly Frugal decides to roll over the full loan amount to an IRA and escape paying the 1099 form generated by the pension bureau. It will take more than 14 years before the borrowed money is exhausted and the deficit will continue.

Philly Frugal shops for an IRA with interest and secures a commitment with 5.5% interest over the span of the IRA. At the conclusion of his 14th year of retirement Philly Frugal pays back the pension loan and increases his pension almost \$120 a month. At age 61, he commences his pension loan-funded IRA to pay an additional \$150 a month.

What Philly did was well thought out and planned, thus reaping him the rewards of additional money. His intention of taking a Pension Loan was to double his money, then pay off the loan and bring his retirement income to its full value. With the existing money, (interest made from the pension loan) sitting in an IRA, will be withdrawn monthly for the next 15 years.

The Pension Loan program is something to think about when planning retirement. It is a way to possibly make money work for you. If you have any questions, please give me a call.
