

### Parents & Coaches Surveys

Conducted Parents and Coaches Surveys at end of Spring Season – 135 Parents and 35 Coaches responded

- Generally high satisfaction: >80% 4 and 5 out of 5 ratings from Parents and Coaches
- Parents satisfaction correlated with feelings about coach
- Most coaches great, some struggling
- Keep uniform style, fix sizing
- Keep all games on Saturday
- Unbalanced games a concern for Parents and Coaches
- Frustration with late notification of game times flip side to late registration and efforts to balance games
- **Everyone loves Coach Andrew**

Registration has been steady for the last 5-7 years, most coaches from the Spring came back for the fall!

## Rec – Continuing Challenges

Continue to bring in new coaches for the young age groups, especially 1<sup>st</sup> year (U6) and when we split teams into the larger age groups (U7G, U8B)

Continue focus on making Coaching experience as positive as possible to help attract/retain coaches, offer support and addt'l training – without volunteer coaches, no Rec program!




# Referee Report


**Game Trends**
