



Occupational medicine - In accordance with the Occupational Medicine Service Act (Journal of



Laws No. 96 of 13.08.1997)_Obligatory employee examinations. All diagnostic tests required to perform work at a given position, all specialist consultations required for a given position:

- o Initial, periodical and follow-up examinations
- Survey of work positions
- o Participation in occupational health and safety commissions
- Any other provisions of the Act, without exceptions.

<u>24-hour Medicover Hot-Line</u> – 1 96 77 to Medicover Center in Krakow and to Medicover Center in Warsaw – where highly qualified medical personnel provides medical guidelines and decides on the organisation of a medical visit.

<u>Telephone Medical Consultations</u> – a unique system supporting telephone premedical consultations, thanks to which we can determine the best way of providing help fast. When calling **411 95 96, 500 900 500** you will be directly connected to the indicated center (new feature) or the consultant will receive an answer to a question asked and he/she will provide you with information.

24-hour immediate assistance of an ambulance in cases of danger to health or life – the area of action is the radius of 30 km from the central point in every city where Medicover Center is situated (Gdańsk, Gdynia, Katowice, Krakow, Lublin, Łódź, Poznań, Warsaw, Wrocław).

Sanitary transport is related to providing a medical service in the case where there is medical counter-indication to perform the transport with the use of a vehicle other than a medical vehicle, and performance of a medical service at the location of the Authorised Person is impossible; such a service shall be provided on the basis of a Medicover physician's order.

Direct access to physicians - all specialisations, above all ophtalmologist, dermatologist, suregeon,



orthopedist, cardiology, accessible at Medicover Centers without an order from the medical care general physician.

Psychologic and psychiatric consultations – up to five times during one membership year.

<u>Visits of internal medicine specialists and pediatricians at the location of the patient</u> – depending on medical orders. Visits are conducted according to a schedule within the distance of 30 km from the central point in every city, and in the case of Partner Facilities – within the city borders, if such facility provides this type of services.

Visits of a nurse at the location of the patient are related to the performance of a health care



procedure by a nurse, ordered or confirmed by a Medicover physician the performance of which:

due to medical reasons is not possible in Medicover Center, or

is to be performed on a day when Medicover Center is closed, e.g. Sundays and public holidays.

within the scope of a home visit, a nurse shall provide the following services on the basis of an order from Medicover:

- replacing of a dressing
- taking blood samples
- intramuscular or subcutaneous injection

All diagnostic (outpatient) tests ordered by Medicover physicians within the full scope, without limits, e.g.:

Laboratory tests:

- blood chemistry and immunochemical tests (blood count, ESR, Wasserman test, glucose level, electrolyte test, total cholersterol and fractions, triglyceride test, PSA tumor markers, liver tests, etc.)

- hormonal tests (thyroid, gonads, adrenal glands)
- histopathological tests (biopsies, cytology)
- urine analysis (general, glucose, morphotic elements, cultures)
- bacteriological tests

radiological tests (X-ray of the lungs, spine, joints, skull, sinuses, magnetic resonance, computed tomography, mammography)

ultrasonography tests (ultrasound examination of thyroid, abdomen, joints, gynecological ultrasound)

other tests (resting ECG, exercise ECG, computer vision screening, allergic tests)

<u>All other outpatient tests accessible in Poland</u> – the below mentioned procedures performed according to medical indications, under local or infiltration anasthesia (in the area of the procedure), in outpatient treatment room conditions (outpatient clinic), also outside Medicover, performed on the basis of an order issued by a Medicover physician:

removal or biopsy of dermal and subdermal lesions as well as lesions on the surface of mucus membranes, without the necessity of reconstructive procedures

lancing similarly located purulent lesions cryodestruction of skin lesions up to 1 cm in diameter cryotherapy and laser therapy of cervical erosions suturing dermal and subdermal tissue performing surgery on wounds up to 5 cm in length, without the necessity of reconstructive procedures removal of stitches from the skin (regardless of the wound dimensions) paracentesis of joint cavities and area around joints (blockages) paracentesis of maxillary sinuses as well as incision into eardrum to promote drainage (adults)

reconstruction or removal of fingernail or toenail due to ingrowth, injury or disease endoscopic biopsies and polypectomies of the alimentary tract with other terms of the definition simultaneously being met (treatment room of outpatient facility) – intravenous general anesthesia administered at the patient's request setting/removing plaster casts changing dressings that require only local anesthesia thin-needle aspiration biopsy of the breast thin-needle aspiration biopsy of the thyroid gland puncture of scrotal hydrocele control bleeding as well as removal of foreign bodies within the framework of emergency management procedures, possible to perform during a specialized consultation in the

physician's office of a specialist

<u>Dental care</u> – Within the scope of a Dental Care Program its participants can profit from the following services provided by dental care facilities authorised by Medicover (with the exclusion of Medicover Atrium Center situated at Al. Jana Pawła II 27 and Medicover Krakow Center situated at ul. Rakowicka 7):

- Annual checkup,
- 10% discount on conservative and surgical dentistry
- 10% discount on periapical X-ray in Medicover Centers, if such a service is available at a given Medicover Center.

Annual inoculation against the flu - inoculation is free-of-charge in the scope of Medicover medical plan.



<u>Coordination of necessary inoculations for adults and children</u> – covering examination and injections (the cost of the inoculation to be paid for by the patient).

PROFILAKTYKA OSOBISTA

Health checks – once a year, within the scope of the medical plan, each patient can perform a complex health check. The scope of the check is adapted by the leading physician to the individual needs of each patient resulting from sex, age and risk factors. The health check includes all examinations ordered by a Medicover physician enabling him/her to assess the current health status of a patient and to detect any possible abnormalities or diseases early.

Pregnancy care – care during the pregnancy period, full diagnostics and medical care.

Personal Care Manager services (PCM) – a Personal Medical Manager shall be assigned by Medicover to the Employee; the tasks of such a PCM shall include:

- Making appointments and organising consultations in Medicover Centers
- Making appointments and organising consultations in Medicover Medical Facilities
- Making appointments at the location of the patient and, if needed, organising ambulance visits (exclusively at the request of an Authorised Person who refuses to contact Medicover Hot-Line)
- Overseeing the availability of laboratory tests results and notifying the Authorised Person thereof (exclusively at the request of an Authorised Person)
- Ensuring care during the stay at Medicover Centers where the services are provided to the Authorised Person (exclusively at the request of an Authorised Person).

Personal Care Manager services (PCM) are provided on working days from 8 a.m. till 8 p.m. at Medicover Centers.

Patient at a Care Center. The Program guarantees permanent care of the Leading

Physician, directly cooperating with nurses acting as Care Coordinators.

Your Leading Physician: performs planned visits, control visits and urgent visits adapted to your state of health, contacts you via telephone, informs on abnormal results of your examinations and checks the course of treatment, answers your questions through Medicover On-Line service.

Care Coordinator: reminds you about the dates of your examinations, inoculations and control visits, informs you about the normal results of your examinations, issues prescriptions, fills out sick leave certificates, and, if necessary, directs you to perform additional examinations, makes urgent appointments on your behalf, gives you advice in situations not requiring physician's intervention, monitors chronic disease diaries.

Within the scope of telephone medical consultations, when calling **041 195 96, 500 900 500**, you will be connected directly to the care coordinator in a given center, if the hot-line consultant cannot provide you with any information.

Simplified procedures

1. When an order for additional examinations or consultations is issued by a physician outside of Medicover, the order for such examinations can be issued by a Medicover physician without the participation of the patient.

In order to do it, the patient contacts his/her PCM in order to provide the results of consultations together with the orders (sending a scan of the document by e-mail or fax).

The PCM transfers the documentation to the leading physician.

If the doctor sees no counter-indications, he/she fills out an order for the examinations (if not, he/she invites the patient for consultations to a Medicover Center).

The PCM makes an appointment for the ordered examinations for the patient and sends an external order issued by the physician by fax to a given facility.

2. In the case of a change of an internal order to an external order, the PCM coordinates the change of the order without the need to pay another visit.

Medicover On-Line.

With the assistance of Medicover On-Line our clients make over 500 000 appointments, order over 32 000 prescriptions and ask over 10 000 questions to physicians yearly. When logging on to the Medicover On-Line system our patients can individually: make or cancel appointments at a Medicover Center, browse through the schedule of realised and planned visits, acquaint themselves with schedules of work of physicians, and update their personal data. In order to activate access to the Internet service, the patient must individually collect access codes from the reception at ul. Bobrzyńskiego.

<u>Ordering prescriptions</u> – the patient can order a prescription exclusively for a medication which was prescribed earlier by a Medicover physician.

<u>Your Health Questionnaire</u> – drawn up by Medicover specialists; the questions refer to inter alia eating habits, physical activity, sleep patterns and stress levels. Upon filling out of the questionnaire you will receive an individual health report and possible suggestions for changing your lifestyle. www.medicover.pl

<u>Results of examinations</u> – application allowing you to access the results of laboratory tests and imaging examinations performed at Medicover Centers. The result of the test is made available to the patient only after a physician makes an obligatory check of such a result and describes it, also in the case when the result is normal.

Electronic Medical Documentation – when going for a visit to Medicover Center you do not have to have your medical documentation. All Medicover Centers have an electronic medical history system enabling an easy and fast access to full medical documentation of the patient, made available from any physician's office.

SMS – reminding about the planned visits (exclusively at Medicover Centers).
