# 5. SAC CHAIR'S REPORT: Commissioner, SAC Chair, David Wilder

- Commissioner Wilder reported that he was able to participate in the Meet and Greet hosted by CDA Executive Director, Susan DeMarois. He feels that the CDA has a great vision for the senior population.
- Commissioner Wilder states that Assembly Bill 2077 will expand the personal needs allowance. He feels if this would have been in place prior to the pandemic, seniors would have not been so isolated. Staying in contact with family is good for senior citizens mental health.
- Commissioner Wilder reports that he has been working hard with the commission to meet The Brown Act. All action items must be by roll-call vote. The commission should be open and transparent.
- Commissioner Wilder acknowledged how well the SAC orientations went. He expressed thanks to Commissioner Shubnell for organizing the orientation.
- Commissioner Wilder anticipates that the Senior Affairs Commission may continue to meet virtually. The executive committee is meeting in full. This allows the committee to ask questions and lodge complaints.



# 6. DAAS-PG DIRECTOR'S REPORT: Director-Public Guardian, Sharon Nevins

- VISIT FROM CALIFORNIA DEPARTMENT OF AGING (CDA) EXECUTIVE DIRECTOR, SUSAN DEMAROIS: CDA
   Executive Director, Susan DeMarois visited DAAS-PG on July 21st for a brief and impromptu Meet & Greet at the Public
   Guardian building in San Bernardino. Ms. DeMarois is working with Cheryl Brown on activities within the County. Ms. Brown
   and Ms. DeMarois joined Commissioner Fergusson after the Meet and Greet for a televised panel discussion and luncheon.
   Ms. Nevins expressed gratitude to Senior Affairs Commission, Chairperson, David Wilder for his attendance. Ms. Nevins
   added that Ms. DeMarois 'schedule has prevented her from being able to visit all Area Agencies on Aging (AAA) as she
   still intends to do.
- MASTER PLAN FOR AGING EVENT: CA FOR ALL AGES AND ABILITIES DAY OF ACTION: In partnership with the
  IMPACT Stakeholder Committee, the California Department of Aging (CDA) invite you to join the California Master Plan for
  Aging stakeholders in Sacramento on September 20<sup>th</sup> to elevate Aging, Disability, and Equity in statewide cross-sector
  planning to achieve the Governor's vision of a California for ALL. As a member of the IMPACT Stakeholder Committee, Ms.
  Nevins encourages all who are interested, to participate. The speaker line-up includes Assembly Members as well as other
  key dignitaries. Clerk of the Commission, Michelle Torres will distribute registration information.
- NUTRITION INFRUSTRUCTURE GRANT: Ms. Nevins thanked those who participated in the research and preparation of the \$1.5M Nutrition Infrastructure Grant Application. This grant was approved and it will assist existing providers to purchase much needed equipment. The department is waiting to receive the grant so it can be taken to the Board for approval. Ms. Nevins expressed appreciation and gratitude to Interim Assistant Director, Glenda Jackson, Glenna Cook and all the individuals who worked tirelessly to have this completed by the deadline. The department is looking to use the grant money to open a location in Bloomington and expand the center they have. We are also trying to open a new nutrition site in Helendale.
- **SENIOR WEEK:** Assembly Member Eloise Gomez Reyes hosts Senior Week on September 26 30<sup>th</sup>. DAAS has been asked to participate. We will represent aging adults within the community.
- NUTRITION PROVIDER CONTRACTS APPROVED: Ms. Nevins thanked all who were instrumental in getting the Nutrition
  Contracts approved and through the Request for Proposal (RFP) process. The Board of Supervisors (BOS) has approved;
  providers are in place and providing services. The Department is looking as expanding to additional sites this year. The
  need is growing and DAAS-PG wants to be able to meet the expanded and growing need. More to come on developments.
- COVID-19 SURGE: The incidence of confirmed Covid cases has significantly risen over the couple of months with both the Rancho Cucamonga and San Bernardino DAAS-PG offices currently on outbreak status. The Department is taking the necessary precautions to keep staff and visitors safe. If the Commission had been meeting in person, the outbreak would have certainly presented a challenge.
