Dear Neighbor,

Included in this report is the July 9 letter I sent Governor Mike Parson urging him to call a special session of the General Assembly to consider legislative proposals to help reduce our horrendous number of homicides in Kansas City and the frequency of other violent crimes.

This year we are on a pace to far exceed the number of homicides in any given year since our city was founded. Just last week there were two homicides in my legislative district just a two or three minute drive from my residence. **This has to stop!**

The three specific proposals I asked the governor to put on the agenda for a special session are all measures I sponsored or co-sponsored during this year's regular session of the General Assembly. I think all of them would have been likely to pass if the session would not have been abbreviated due to the pandemic. They are:

Establishing a long overdue pretrial witness protection program in Missouri.

Strengthening the penalty for tampering with victims or witnesses.

Making discharging a gun within or into city limits with criminal negligence a state offense.

Turning to another subject, I want to remind everyone that due to a new state law I voted for, all persons 65 or over, anyone whose immune system is compromised, anyone living in a licensed long-term care facility, anyone who has contracted COVID-19, and anyone with a health condition such as diabetes that puts them at higher risk for contracting COVID-19 can vote absentee in the August 4 primary without getting their signatures notarized.

The other health conditions that allow such absentee voting include chronic lung disease or moderate to severe asthma, chronic kidney disease for persons undergoing dialysis, liver disease and serious heart conditions.

All other voters may request mail-in ballots for the August election, but their signatures will have to be notarized.

Persons may request an absentee or mail-in ballot application by calling the Kansas City Election Board at 816-842-4820 or by going to the Board's website www.kceb.org and clicking on Absentee Voting and then clicking on Forms & Applications and printing off an application that can be mailed in.

Applications for absentee and mail-in ballots to be mailed to voters must be received by the Board no later than 5 p.m. Wednesday, July 22. The completed ballots must be received by the Board no later than 7 p.m. August 4. Absentee ballots may be returned by mail or in person, but mail-in ballots must be returned by mail.

Voters may also vote by absentee ballot in person at the Board office in

the basement of Union Station's southeast corner from 8 a.m. to 5 p.m. Monday-Friday through August 3 and from 8 a.m. to noon Saturday, August 1.

FY 2020 ENDS WITH NET STATE REVENUE DOWN 6.6 PERCENT

The 2020 state fiscal year ended June 30 with net state general revenue collections for the year down 6.6 percent compared to FY 2019, going from \$9.57 billion last fiscal year to \$8.93 billion this year. Net collections had been down 7.4 percent through the first 11 months of FY 2020 but improved slightly due to a small uptick in June.

Net general revenue collections for June 2020 increased 1 percent over June 2019, going from \$862.2 million last year to \$871 million this year. Collections for June 2020 marked the first month since February – just before the COVID-19 pandemic hit – that monthly revenue increased compared to the same month in the prior fiscal year.

Because of the sharp downturn in general revenue collections, Gov. Mike Parson unilaterally imposed over \$435 million in budget cuts during the final quarter of FY 2020 in order to keep the state budget in balance. Those cuts primarily came from K-12 schools and higher education. Parson imposed another \$449 million in spending freezes for the 2021 fiscal year, which got underway July 1.

MISSOURI TOPS 25,000 CONFIRMED COVID-19 CASES

Missouri has topped 25,000 confirmed cases of COVID-19 since the pandemic began in March. With a surge of 575 new cases on July 8, there were 25,204 reported cases in the state as of that date, along with 1,046 confirmed deaths from the disease.

As the number of cases continues to increase rapidly after Gov. Mike Parson authorized the state to begin re-opening in early May, several local governments – including those in Columbia, Kansas City, St. Louis City and St. Louis County – have imposed mandatory orders for people to wear masks in public in an effort to limit the spread of the disease. The Springfield City Council is also considering a mask order.

However, Parson has repeatedly stated during his regular press briefings that while he encourages people to wear masks in public, he doesn't favor making it mandatory. Parson routinely goes without a mask at public events.

Dear Governor Parson:

I respectfully request that you call a special session of the Missouri General Assembly to consider specific legislative proposals to help reduce the horrendous homicide rates in Missouri's largest cities and the frequency of other violent crimes in our urban areas.

Another option would be to just add such proposals to the agenda of any special session you may be considering.

I think there is broad support in the General Assembly for taking decisive action to reduce homicides and other violent crimes, and I believe the measures listed below could be passed in a special session without taking an inordinate amount of time. They probably would have passed during this year's regular session if it had not been abbreviated due to the pandemic.

Establishing a long overdue pretrial witness protection program in Missouri.

Strengthening the penalty for tampering with victims or witnesses which is now just a misdemeanor. If the underlying crime is a felony, victim and witness intimidation in such cases also should be a felony.

Making discharging a firearm within or into city limits with criminal negligence a state offense. This legislation known as "Blair's Law" is named after 11-year-old Blair Shanahan Lane who was killed in 2011 by celebratory gunfire.

Mayor Lucas Statement on Operation Legend

FOR IMMEDIATE RELEASE: July 8, 2020

KANSAS CITY, Mo. – Kansas City Mayor Quinton Lucas today released the following statement regarding Operation Legend:

“I learned on Twitter this afternoon that the Department of Justice plans to send federal investigators to Kansas City as support for unsolved homicide and non-fatal shooting investigations. As I understand the Department’s plan, any outside help will not be used for regular policing or patrol activities—and solely to clear unsolved murders and shootings.

“I also understand the United States Attorney in Kansas City has been in contact with the family of LeGend Taliferro who support the investigation effort to help find the murderer of four-year-old LeGend and many other victims tragically killed this year in Kansas City.

“I plan and hope to learn more about this effort over the days ahead. The investigative support effort announced this afternoon can be only one tool out of many, such as mental health treatment and restorative justice, in addressing violent crime.

“As I said in my letter sent last week to Governor Parson that was

cited by the White House this afternoon, '[W]e will continue to pursue a broad set of social services and other tools to address violent crime now and in the future.' As mayor, I remain committed to working on all solutions to making our city safer and finding peace for all those impacted by violent crime."

A Letter from Spire:

To help customers maintain access to safe, reliable natural gas service during the coronavirus pandemic, we worked with the United Way to reimagine how to assist struggling, limited-income residential customers, as well as small business customers, impacted by the pandemic. This effort includes suspending customer disconnects and late fees in mid-March through May.

In June, the [Missouri Public Service Commission](#) approved an order to further decide how utility companies will collect past-due payments after delays due to COVID-19.

As we observe the direction of the Commission and slowly return to normal business operations, Spire will begin disconnecting accounts that are past due on Monday, July 6. We have adjusted our customer communications for disconnections—both written and outbound call messages—to include information on energy assistance available to customers.

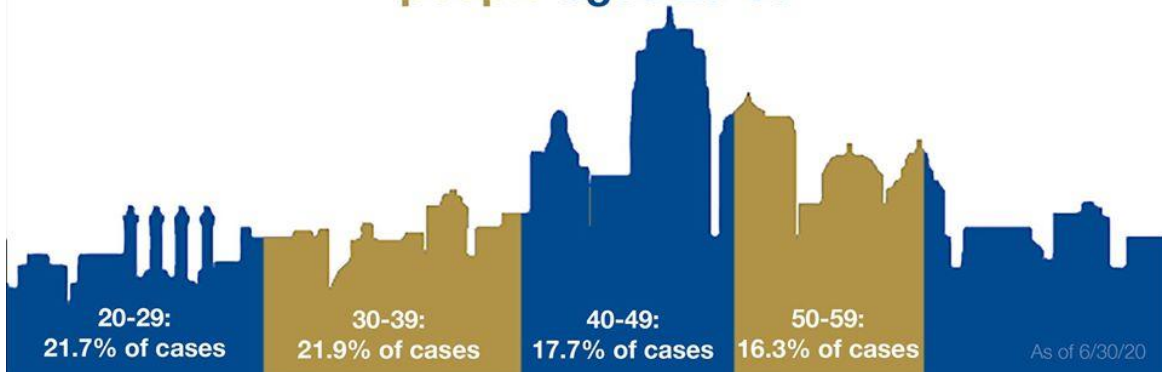

KCMO Health Department announces free COVID-19 testing for restaurant employees

FOR IMMEDIATE RELEASE: July 8, 2020

Restaurant employees in Kansas City are receiving an advanced invitation for COVID-19 testing at no cost during a three-day testing

event organized just for them.

Staff from the Kansas City, Missouri Health Department and the Missouri Department of Health and Senior Services will be at the Homefield Sports Facility, 5300 Bannister Rd., from 7 a.m. until 7 p.m., July 13-15 to administer up to 2,000 COVID-19 tests.

Appointments are required. Restaurant employees who live in Missouri can secure an appointment by [registering online](#) or by calling 877-435-8411. Any extra appointment times will be opened to others outside the restaurant industry.

“Restaurants are social places. The public comes in, and employees have no idea of their history or their exposure to COVID-19. Others work in close quarters with their co-workers. We wanted to offer this testing first to restaurant employees because of their potential exposure,” said Naser Jouhari, Environmental Health Services Division manager. “As restaurants reopen, we also ask staff to follow disease prevention guidelines so employees and patrons stay healthy and so restaurants can remain open.”

Under Kansas City, Missouri, Mayor Quinton Lucas’ most [recent order](#), masks must be worn inside businesses if six-foot distance cannot be maintained.

South KC Mobile Food Pantries

With so many people out of work due to the coronavirus pandemic, a growing number of families in south Kansas City are being forced to rely on community food pantries such as Community Assistance Council's to have enough to eat.

Fortunately, Harvesters (the community food network) brings the semi-truck that serves as its mobile food pantry to four sites in south Kansas City monthly to distribute fresh produce and other healthy food to families in need. The sites are:

Evangel Church, 1414 E. 103rd St., from 7 to 8:30 a.m. the second Saturday of the month. Persons may remain in their vehicles, and food will be brought to them.

Ruskin High School, 7000 E. 111th St., from 4 to 5:30 p.m. the third Thursday of the month. Vehicles should line up on Ruskin Way on the east side of the school, and food will be loaded in the vehicles when they reach the school by staff and student volunteers. This event is sponsored by the school and Community Assistance Council.

Colonial Presbyterian Church, 9500 Wornall Rd., with registration beginning at 8 a.m. and food distribution running from about 8:30 to 10 a.m. on the third Saturday of the month. Families are asked to bring two cardboard boxes for volunteers to put the food in.

Martin City K-8 School, 201 E. 133rd St., from 11 a.m. until food runs out on the third Saturday of the month. This event is sponsored by Three Trails Community church.

UNEMPLOYMENT

How to File?

If you're eligible, you'll need the following:

1. Your Social Security number;
2. Any amount you were paid in the past week, before taxes and deductions;
3. The name and mailing address of each job you worked in the past 18 months;
4. The dates you started and ended work at each of those jobs.

If this is your first time filing for unemployment please watch [this video](#) on unemployment basics. Visit uinteract.labor.mo.gov, create an account and file your claim. If your job loss is related to coronavirus issues, make sure to check a box that says "COVID-19" in your application to waive a requirement to search for a new job amid the crisis.

Missouri provides benefits for up to 20 weeks, which can be extended to 33 weeks under the federal provisions.

The state will pay you up to \$320 per week, and the federal government will provide \$600 on top of whatever you get from the state for each week you're on employment prior to July 31.

Benefits can be paid within 22 days unless there is an issue with your eligibility, which on average can take 4-6 weeks to resolve.

You should continue filing weekly requests for payment even if you have not yet received benefits.

SUBJECT: Reward Increase – 9 Year Old Dominic Young Homicide

KANSAS CITY, MO --- The Kansas City, Missouri Police Department and the Greater KC Crime Stoppers TIPS Hotline continue to seek information in the January 20, 2018 homicide of 9 year old Dominic Young Jr. at 71 Highway and Emanuel Cleaver II Blvd.

Dominic Young Jr. was apparently hit by a stray gunshot while occupying a vehicle driven by his father and died as a result of his injuries. Dominic, his father and brother were en route to Grandview at the time. The vehicle driven by Dominic's father was hit by gunshots from other vehicles apparently engaged in a gunfight according to statements.

KCPD found a possible crime scene near the intersection where the father said the shooting happened. When the father arrived home in Grandview, Dominic was not responsive. Grandview police initially responded to the father's home and found the

boy in critical condition. He was later pronounced dead at a hospital.

A number of community leaders and organizations including State Representative Richard Brown, Mayor Pro Tem Kevin McManus, former City Councilmen Scott Taylor, Scott Wagner, John Sharp; the City of KCMO and Concord Fortress of Hope Church (Pastor Ron Lindsay) have come forward to increase the existing reward in the case up to \$30,000.00. Those leaders are available for comment in regard to the case.
