# 6. General Information

Charges in this schedule have been rounded to 2 decimal places, however charges could be up to 5 decimal places in length.

- <sup>1</sup> Time at Berth Charges are payable to the Port of Townsville Limited and are billed per 24 hours or part thereof that a vessel occupies a wharf. "Occupying a wharf" can be defined as a vessel that is not moving and in a position that limits another ships access to the wharf. Layup Concession may be granted for vessels that are alongside a berth for longer than necessary or intended. Concessions may be granted for a number of reasons, including: Tidal Constraints, Pilotage availability, waiting for internal movement or Port directive. The concession only applies to the "time at berth charge" and is assessed on a case by case basis. Submitting an application does not automatically mean a concession will be granted. For further information please contact the Duty Officer. The Port of Townsville Limited reserves the right to withdraw this concession at any time.
- <sup>2</sup> The definition of "**Part there-of**" means that even if only part of allocated time/tonne was used, the charge will be for the full time/tonne allocation.
- <sup>3</sup> Cargo Charges are payable to the Port of Townsville Limited, and are in respect of all goods discharged or shipped from the port.
- <sup>4</sup> **Transhipment** is the process of off-loading a container from one vessel and loading it onto another vessel. Transhipments are charged at the full rate of cargo charges for imports.
- <sup>5</sup> **TEU** Twenty Foot Equivalent.
- <sup>6</sup> Dry Bulk inclusive of cement, fertilisers, metal concentrates, iron ore, sugar, zinc ferrites, nickel ore, scrap metal, sulphur
- <sup>7</sup> Wet Bulk inclusive of caustic soda, sulphuric acid, molasses, tallow
- Vehicles includes but is not limited to, motor vehicles (eg. sedans, utilities, SUV's), industrial vehicles, forklifts, motor bikes, quadbikes, boats, trailered cargo (eg. jet skis, caravans), trailers, trucks, buses, machinery (eg. cranes, excavators, tractors). Includes static vehicles.
- <sup>9</sup> **Other** break bulk goods shipped in pieces separately without the use of a container. Eg. items shipped in crates, bags, boxes, drums, barrels, on pallets etc.
- <sup>10</sup> **Refined Metals** inclusive of refined copper, nickel, lead ingots, zinc ingots
- Services to Shipping are payable to Port of Townsville Limited and include electricity, water, garbage collection/disposal RORO, security and plant hire charges. These charges are subject to change at any time following advice from utility and service companies. It is the ships responsibility to collect hoses if hired and recoil and return after use.
- <sup>12</sup> Utility charges are subject to change at any time following advice from utility and service companies.
- <sup>13</sup> **Ship Waste charges** are subject to change at any time following advice from service companies.
- Sewage charges are only applicable at Berth 10 where connection to the quay-line sewer manifold is utilised. These charges are subject to change at any time following advice from Council.
- Security Regulated Vessel If a security regulated vessel is required to berth but is not undertaking cargo operations and there has been no arrangement made with another approved Port Operator, then the agent must contact Port of Townsville Limited (POTL) and request in writing POTL undertake this responsibility. For POTL to take responsibility and liability for a security Regulated Vessel at a common user berth there are 2 options:
  - Agent Requests POTL to undertake the **responsibility and liability** and POTL make all arrangements for security using either inhouse (POTL guards) or contracted security that comply with MSIC and other requirements.
  - Agent Requests POTL to take **responsibility and liability for security**, but agent's book and pay for an approved security provider directly and pay POTL a fee to take the responsibility and liability for security
  - A **Port Facility operator** is defined as a person who operates a port facility. If a ship is on a leased berth namely 3, and 11 then the facility operator for that berth is responsible for that ship.
- <sup>16</sup> The party undertaking the booking of **Maritime Security Guards** accepts the financial responsibility of incurred costs.
- <sup>17</sup> Cancellation of booking fee for **Maritime Security Guards** will be incurred (equivalent to 4 hours at the appropriate rate). Fee will be incurred if booking is cancelled within 3 hours of scheduled shift commencement, or if booking is transferred with less than 3 hours notice.
- <sup>18</sup> Hourly rates for **Maritime Security Guards** are inclusive of the Port of Townsville Security Hut hire charge.
  - Maritime Security Guards (MSG's) are mandatory for berths 1,4,8,9 and 10, and associated backing areas where vessels are alongside and when cargo is being handled, pre-received, received or removed from the cargo terminal or where a clean-up procedure is undertaken, and cargo remains within the terminal.
    - Where cargo is stored in a cargo terminal, no access will be permitted to port users or contractors unless a MSG is requested to control access.
  - MSG's will automatically be provided and must be requested to gain access to a berth or cargo terminal area. MSG's will commence duty 30 minutes after scheduled POB time which is the minimum time required to establish security and access control of the berth or cargo terminal. Where a vessel departs, MSG's will remain at the berth for ~30 minutes after last line unless otherwise arranged.
- <sup>20</sup> **Guard Huts** –For use when controlling Landside Restricted Zone (LRZ). Minimum charge 12 hour period. Charged for 12 hour period or part thereof, then hourly rate after. No concession for Layup. Charge relates to one service request per form per guard hut.
- <sup>21</sup> **STS Crane** Minimum charge 1 hour period, then hourly rate or part thereof after.
- <sup>22</sup> Backing land charges listed are cost per individual day of use/booking. Charges apply per calendar day.
- <sup>23</sup> Payable in advance and invoiced in September, December, March and June for the next applicable quarter
