

#### Communion of Saints

7 hen the difficulties of life seem to interfere with our religious beliefs, where can you turn for help or inspiration? The saints in heaven have experienced similar life experiences and found a way to overcome them. The communion of saints gives us the support we need whenever we need it.

The Catechism of the Catholic Church states: The witnesses who have preceded us into the kingdom (Hebrews 12:1), especially those whom the Church recognizes as saints, share in the living tradition of prayer by the example of their lives, the transmission of their writings, and their prayer today. They contemplate

God, praise him and constantly care for those whom they have left on earth. When they entered into the joy of their Master, they were "put in charge of many things" (Matthew 25:21). Their intercession is their most exalted service to God's plan. We can and should ask them to intercede for us and for the whole world. (2683)

The faith of the Church is that the saints are not really dead, but are fully alive in Jesus Christ, who is life itself. Because they are alive, we believe that we can go to them to intercede for us with God. We trust that the saints will accept our requests for help and will present them to Christ for us.

Each saint has a purpose, a way to help those of us still fighting the good fight here on earth. Patron saints are chosen as special protectors or guardians over areas of life. These areas can include occupations, illnesses, causes, or anything important to us. Have you ever asked St. Anthony to help you find a lost object? He has been my go-to saint innumerable times—and he has always helped. Other patrons include St. Gregory the Great for teachers, St. Luke for doctors, and St. Agatha for nurses. Victims of cancer may pray to St. Peregrine. St. Francis of Assisi is the patron saint of animals.

Everyone in Christ, whether living or dead, belongs to the Body of Christ. We need to see the saints as real friends, fellow sisters or brothers with whom we can share our joys and our sorrows, and people to whom we can turn when life gets crazy, as it often does. The saints were real people who often lived very ordinary lives, with a great love for God and their fellow man.

Whether they walked among us sixty or five hundred years ago, the saints are our companions along our journey of faith. We are not alone. Learn to pray to a patron saint—or to a departed loved one who you believe is now in the presence of Christ. Do you recall when websites were first accessible by the average person? It was often referred to as the "Information Highway" or "Information Technology."

Today, this still stands! We can learn much from the internet, from websites in general, as information abounds in many forms. We have the written word as in ar-

ticles; pictures / images; social media, available through countless platforms; videos, itself with countless platforms; as well as business / marketing websites. There is no end to tutorials on any subject you desire and there is no dearth (shortage) of encyclopedic-type information. The biggest challenge is to know whose word to trust or be a bit skeptical of. But there is even a website which is devoted to helping you discern, to know, if what is presented on a website or through any format, is indeed, accurate. And, even then, they give you their own rating of reliability for their sources. One such website is, https://www.snopes.com/.

Near the top is a place for highlighted news, followed by our state contacts; then, local court information, along with their anniversaries and links to the court's personal page. Diocesan courts follow this section and all diocesan court chairs (or those assigned to the task,) are asked to please email me their meeting and/ or event dates and I'll get them published in this section.

Programming, newsletters, membership, national projects and charities, and information on our state court come next. State conventions, workshops, and national and state forms follow. Rounding out the lineup are sections on state court fundraising, special websites (for the Bible, dioceses within our state, and national/state court contacts), national and state logos, and to help further your love of Catholic Daughters, a few games to play!

Of course, you can use the dropdown menu at the very top of the page, to be taken directly to the area you're interested in.


#### Secretary's draft of the minutes

"The secretary's draft of the minutes is often sent to all members in advance of the meeting at which those minutes are to be approved, usually with the meeting notice. When this has been done, it is presumed that the members have had an opportunity to review these draft minutes, and they are not read at the meeting unless a member requests it. Correction and approval, however, is handled in the usual way. A draft of the minutes circulated to members must be clearly marked as such. The secretary's draft of the minutes, whether or not circulated before their approval, does not become the minutes—that is, the official record of the proceedings of the society—unless it is approved, and the minutes may be modified in the correction process. Only the secretary's corrected version of the minutes is official in such a case." RONR (12th ed.) 41:12

**INFORMS** members or clarifies, but expresses no opinion unless vacates the chair

**CAN SUGGEST** a certain motion to resolve a situation **REQUESTS** a member to stand for presenting or discussing a motion

**DOES NOT HAVE RIGHT** to cut off discussion **DENIES ACCEPTANCE** of "I so move"

**HANDLES** motions, amendments, subsidiary motions prefaced by "I Move to or that we..."

**ADJOURNS WITH** "Is there any further business to come before the court? Is so, handle; if not, regent says, "hearing none, meeting is adjourned until..." One rap; three gavel raps, for Prayer and Closing Ode

# Corrections made to minutes have been updated to the following process

"When the minutes are approved, the word Approved, with the secretary's initials (or the signature of the chairman of the approving committee) and the date, should be written below them. If the minutes are approved with corrections, the secretary should prepare a fully corrected version and distribute copies to the members as well as placing it in the minute book. (As noted in 48:4(5) all such corrections should be incorporated in the minutes to which they pertain, and not to the minutes of the meeting making the corrections.)" RONR (12th ed.) 48:14 ◆



# "Live in a manner worthy of the call you have received..."

Dear Catholic Daughters of the Americas and Friends,

Once again, it is that time of year when we need to think of what steps we will take so we are properly prepared for the joyous celebration of Christmas, when the eternal Word of God became incarnate and lived among us. So many things will have to get done, but we cannot forget the most important one—the internal preparation.

Let us ask then: "What will I do in these upcoming days to be ready, so Jesus can be born again in me and through me in our world?" In answering that question the following words can be very inspiring: "Brothers and sisters: You are no longer strangers and sojourners, but you are

fellow citizens with the holy ones and members of the household of God, built upon the foundation of the Apostles and prophets, with Christ Jesus himself as the capstone. Through him the whole structure is held together and grows into a temple sacred in the Lord; in him you also are being built together into a dwelling place of God in the Spirit."
