Skip the Trip! Title and Registration Instructions Private Party Sale with a Colorado Title

- Attached are the additional documents required to complete and process the title and plates for your new purchase.
- <u>We can transfer credits from license plates from another vehicle as long as there is at least</u> one owner in common on both vehicles and the plates are not expired.
- A copy of the current registration or license plate number will need to be submitted in order to do this.
- Indicate "pick up" or "mail" for your delivery type.
- Original Documents are required to process a title!
- You may mail them to the below address or place in our drop box in the lobby at Mesa County Central Services Motor Vehicle

- □ A fee of \$5.00 will be added for postage to mail the plates via regular mail.
- To avoid this fee please mark for pickup and you can pick up the plates at the motor vehicle check in counter at the Central Services Building the day after the payment is processed.

You will need to send in:

1. Cover Sheet. Make sure to select your delivery type, mail or pick-up. If pick-up we will notify you via e-mail or phone when your plates are ready.

2. Colorado title. Before this is sent to us make sure the following are checked and completed:

- The seller(s) is the same person that is on the front of the title. Make sure the seller(s) print and sign their name(s) on the back of the title under the "seller" section as it appears on the front of the title.
- The odometer is filled in and the odometer indicator is checked. This only applies to vehicles 19 years old or **newer**. Any vehicle that is year model 2011 or **older** transferring the odometer is not necessary.
- \circ The dates of sale and purchase price are filled in.
- The buyer(s) has filled in their printed name(s) on the back of the title under buyer" section and signed their name.
- The buyer will also need to print their **physical address** on the back of the title under the address section as well

3. Bill of Sale (optional)

4. **DR 2395 Application for Title and Registration**; highlighted areas are required to be completed. The Identification portion is required to meet the required ID listed on the attached DR 2841. If two or more owners are going on title and Joint Tenancy with Rights of Survivorship is desired page two of the DR 2395 is also required to be completed.

5. **DR 2842 Supplemental Secure and Verifiable Identification.** Only one owner's identification is required. Make certain to have someone witness your ID and signature.

6. Colorado Proof of Insurance. This must be on the vehicle being registered.

7. If you wish to transfer credit from plates we will need a copy of the current registration or license plate number for the plates from which you want to transfer credit. Plates may not be expired.

Payment Options

Once your paperwork is completed we will call you or send you an email with the amount due. You can pay using one of the methods below:

Paying by check

Drop the check, within an envelope addressed to Skip the Trip, in the blue drop box in front of the Central Services Building. Make Payable to MCCR and write the last 8 digits of the VIN in the memo field.

Paying by E-check

Call 970-244-1664 and tell the staff member that you need to make a payment on a Skip the Trip packet and have the last 8 digits of the VIN number with you when you call. You will need to know the Account number and Routing number for your bank.

Be aware there is an additional **\$1.00** charge to pay with an E-check.

Paying by credit/debit card

Call 970-244-1664 and tell the staff member that you need to make a payment on a Skip the Trip packet and have the last 8 digits of the VIN number will you when you call. You will need to have your credit/debit card in hand.

Be aware there is an additional credit card processing fee (approx. \$3 per \$100).

- Please allow up to 5-10 business days for processing of registration, 4-6 weeks for receipt of title.
- Mesa County will not be liable for any plates that may get lost in the mail.
- If your plates do not make it to your address you will need to come into the office with the vehicle information and we will replace your plates for you at an additional cost. Generally less than \$10.00

Joint Tenancy with Rights of Survivorship Acknowledgement of Intent

State Of Colorado

C.R.S. 38-11-101

Any Alteration or Erasure may Void this Document

To create joint tenancy with rights of survivorship, there must be specific language declaring such intent, signed under penalty of perjury in the second degree by all owners. This form is only applicable to multiple owners.

Joint Tenancy with rights of Survivorship is defined as: A form of legal co-ownership of property (also known as survivorship). At the death of one co-owner, the surviving co-owner becomes sole owner of the property. Transfer of ownership requires copy of death certificate and signature of survivor.

Tenancy in Common is defined as: The equal or unequal holding of property by two or more persons. At the death of one co-owner, the deceased share of the property goes to his/her estate and is to be divided according to his/her will or the law in the absence of a will. Transfer of ownership requires documents appointing a personal representative for the decedent.

Secure and Verifiable ID

Secure and Verifiable ID is required to obtain:

- New Titles
- Duplicate Titles (vehicles purchased on or after 07/01/2006)
- New Registrations
- New Temporary Registration Permits
- New Placards

The following types of identification are Secure and Verifiable:

- Any Colorado Driver License, Colorado Driver Permit or Colorado Identification Card, current or expired one year or less. (Valid temporary paper license with invalid Colorado Driver's License, Colorado Driver's Permit, or Colorado Identification Card, expired one year or less is acceptable.)
- Out-of-state issued photo driver's license or photo identification card, photo driver's permit current or expired one year or less.
- U.S. Passport current or expired less than 10 years.
- Valid foreign passport with I-94 or valid processed for I551 stamps. Valid I-94 issued by Canadian government with L1 or R1 status and a valid Canadian drivers license or valid Canadian identification card.
- Valid I551 Resident Alien/Permanent Resident card. No border crosser or USA B1/ B2 Visa/BCC cards.
- Valid I688 Temporary Resident, I688B, and I766 Employment Authorization Card with intact photo.
- Valid US Military ID (active duty, dependent, retired, reserve and National Guard).
- Tribal Identification Card with intact photo. (U.S. or Canadian)
- Certificate of Naturalization with intact photo.
- Certificate of (US) Citizenship with intact photo.
