Convention News

This spring, after two years of our conventions not being in Pierre, we will be "back on the river", this time on the west side of the river, not the east. The Americann at 312 Island Drive in Fort Pierre will be the convention site, and the theme is "Just Have Fun". That, we will do!

Leading off the convention speakers will be Bernie Hunhoff of Yankton. He is the founder of South Dakota



Magazine. Bernie attended country schools. A graduate of Yankton High School and Mount Marty College, he worked in the newspaper business until 1985 when he founded the magazine. He says he has been stuck on gumbo trails in Lyman County, been hissed at by rattlers at Porcupine and forced to eat everything from lutefisk to roast goat. It's all part of the job of publishing South Dakota Magazine. Bernie has served both in the SD House and Senate from District 18. Currently he is in the Senate. He and his wife Myrna have 2 children and 4 grandchildren.

She has worked in several states and overseas. Her experiences with the most impact so far were swimming with whale sharks and cleaning up oiled blue penguins in New Zealand. Through a nationwide search and many tests and interviews, Stephanie was chosen as Wild Kingdom's wild guide in July of 2013 – her childhood dream come true!

Again we welcome to our convention Dennis Eisnach of AARP and Rob Wylie of the SD Retirement System. Usually they bring good news, and we hope it's that way this year, too.

Legislative Report

The five SDRS bills were signed into law by the Governor on 2/17/15./ There was no opposition to the bills in either house and none of the bills negatively impact current retirees and your increase on 7/1/15 will be at 3.1%.

HB 1007 provides several significant changes as follows: updates board adopted actuarial mortality assumptions, interest rates and improvement factor; requires

SDRS board to approve actuary; updates IRS code citations; and removes cement plant employees from the excluded to the included SDRS list

HB 1008 clarifies the methodology for payments of beneficiary of a member whose contributory service ended prior to 7/1/2010. That is the date when contribution rates changed and other statutory changes became effective.

HB 1009 was a clean-up bill addressing old over-payment and under-payment issues.

HB 1010 was a clean-up bill to correct a statutory citation.

HB 1011 provides a new discretionary program for savings, in addition to the regular SDRS. This is an option for new and participating active SDRS members.

Volunteering Improves Your Health

Spring is that time of year when unit community service chairpersons collect the volunteer hours completed by the 2014-2015 membership. Statewide totals will be shared at the state convention in April. Why is volunteerism so important? We could ask Diana Glover, the 2014 Andrus Award Honoree for South Dakota; but the question has a strong foundational answer we need to know.

As I researched the importance and beginnings of volunteerisminthe Retired Teachers Association, I found the words of Dr. Ethel Percy Andrus. "The Challenge [is] to live up to our better selves, to believe well of our fellow men and perhaps by doing so to help **create the good**, to experiment, to explore, to change, and to grow." While we know the story of how she helped retired teachers out of poverty and homelessness, we need to realize how her guiding principle "to serve, not to be served" remains the focus of the National Retired Teachers Association, AARP, AARP-SD, and the South Dakota Retired Teachers Association.

Volunteerism unites our organizations and membership. Traditional volunteers know the value of the regularity of the volunteer position. In fact, the 46,334 hours recorded by South Dakota Retired Teachers in 2013-2014 were equal to 22 full-time job positions.

The Baby Boomers or flexible volunteers have made a difference to how volunteerism is conducted, choosing activities as one-time events. About 78 million Americans were born from 1946 to 1964. Many of the Baby Boomers are ready to volunteer but haven't been asked to help. The flexible volunteers have limited time and wide-ranging interests. They are looking for ways to experience life, share their skills, and follow their passions to enhance their community right now, today. For them, AARP established **Create The Good** as an avenue for volunteer opportunities. If we just gave them a card with **CreateTheGood.com**, they would be excited to find the plethora of ways to volunteer listed on the website, including volunteer vacations to Asia and Africa.

Volunteering, as discussed in the book *Life Reimagined*, is presented as an important aspect to include in one's retired life. Retirees are invited to find a passion to make a genuine difference in their community. So I hear the Baby Boomer say, "What does the world need me to do?"

Before we start a multi-year, multi-million dollar, world-wide project, let's look at the personal "world" of the retiree. Start by sharing your time, 5 minutes or 5 hours. The five-minutes could be a phone call to a caregiver to ask about their day. Five hours provide bigger projects. **CreateTheGood.com** lists projects that could be accomplished in any of our

home towns, such as: organizing a paper shredding event, helping individuals organize their medications for the day, a week, or a month, improving the look to your own street or sidewalk, starting a walking group, joining a garden club, sending books to U.S. troops, or hosting a used book sale or book exchange.

Probably the best location to find great volunteer projects both traditional and flexible is among our membership at every meeting. Our members are steeped in volunteer work. The *Black Hills Pioneer* published on December 11, 2013, an article by Jaci Conrad Pearson about NHRTA Dick and Mona Tinker entitled: "Retirees Do a Lot More Than Just 'Tinker' Around." The article stated in part:

With an admirable and honorable community service mission, Dick and Mona Tinker are on the go so much, family members have a hard time keeping track of them —it was even challenging getting an interview with them.

"Our daughters seem to think we do a lot of volunteering," Mona said. "They say it's hard to get a hold of us because we're always out." That comment was a first-hand testimony to the demanding service schedule the two retirees have kept for more than 20 years.

"They lead by example, are always a coach and a teacher, and are always there for us," Dick's daughter Deb Tinker said. "They give of their time, hands, money, and service. They are dedicated, loyal, caring, committed, and have stamina and boundless energy."

"They taught me to value community service and, along with that, compassion," Mona's daughter Cindy Specht said. "Volunteering is very important and I use that as teaching points with my own child. They've taught me that it's for the rewarding feeling you get. They have been great examples."

Volunteering makes an immeasurable difference in the lives of others. But more importantly it makes a difference in us. Volunteering is reinvigorating to our health. It can decrease the risk of depression, reduce stress, boost self-confidence, and keep you physically and mentally active. Feeling good about what you are doing triggers happiness that improves health. (Brain Benefit for Seniors Who Volunteer - Johns Hopkins University, by Researcher Tim Parsons of JHU, December 24, 2009)

Maximize your engagements and give back to society in a meaningful way. Finding purpose and connecting with others are the core values that generate a healthy life. Choose activities with goals you feel strongly about and follow your passion. Remember, Dr. Ethel Percy Andrus founded NHRTA in 1947 at the age of 62 and AARP in 1958 at the age of 73.



Pre-Convention – "Restored Stained Glass at the Capitol", Tuesday, April 28; 10:15 a.m.

Bob Travis, retired teacher from Pierre, will be our guide for both the pre and post convention tours. There is no fee at the Capitol, and thanks to Bob, we will be his guests at the Cultural Heritage Center. Donations will be welcome, however.

Stained Glass - Beautiful stained glass was installed in our state capitol over 100 years ago. For the 125th anniversary of South Dakota in 2014, it was time for a "clean-up". Crews from Conrad Schmitt Studios in New Berlin, Wisconsin traveled back and forth as the cleaning and releading were done. In June of last year, the reinstallment began, and by November it was completed. Bob will share interesting tales of the \$3 million project which included a special gift from the restoration company.

Cultural Center – The state historical society was first organized as the Old Settlers Association of Dakota Territory in 1862. It occupied 3 "homes" before 1989 when the new center was opened on the hillside north of the capitol building. Five programs are included in its mission and activity 1) archaelogy 2) archives 3) historic preservation 4) museum and 5) research and publishing.

The Gathering meal is served every Monday evening except holidays. We will provide the main course, a vegetable, fruit (optional), bread and dessert. Our groups will prepare the meal, set up, serve, interact with our guests and clean up afterwards. We anticipate serving from 120-150 people.



Dr. Kimberly Kaveny-LaPlante, director of Be Free Ministries, presented an informative program on the issue of human trafficking. Be Free Ministries is a nonprofit organization working in partnership with law enforcement agencies and the District Attorney to identify victims and provide survivor support services, victim/issues advocacy, counseling, life coaching, inner healing, and prayer ministry. Their office is located in Sioux Falls, SD.

Because Be Free Ministries is a nonprofit organization, they rely on donations to provide support services, counseling, coaching, mentoring, and advocacy and prayer ministry for survivors and at risk women or teens. They also work to train and educate the community in order to increase awareness, prevention and contextual response strategies. According to Kaveny-LaPlante, "Our greatest desire is to see survivors become whole, healed, and restored. It is an incredible, life changing gift to offer a woman.....a place where she can come and feel safe, loved, heard, and healed at no cost."

The Madison Area Retired School Personnel invite fifth graders from local school to participate in the AARP Grandparent Essay Contest each year. This year, 144 students from Chester, Colman-Egan, Dell Rapids Public, Howard, Madison Central, Rutland and St. Thomas were involved.

Local winners were: Bella Maxwell, Madison Elementary, first place; Nickolas Litterick, Howard Elementary, second place; and Olivia Flemming, St. Thomas, third place.

In February, Lynn Ryan, retired DSU instructor, spoke about her experiences with Chinese and Japanese cultures and secretive women's friendship language and writing. In particular, she spoke about Nushu as one of the most interesting and least known writing systems. The words nu shu literally mean "Woman's Writing" in Chinese. This writing system was created and used exclusively by women in a remote area of China. Because traditional Chinese culture is malecentered and forbids girls from any kind of formal education, Nashu was developed in secrecy over hundreds of years in the Jiangyong county of Hunan province.

Ryan shared a handout of "The Secrets of Women's Language" and asked the group to suggest words that are generally used by women in their oral or written communications. Some of the contributions included words such as slimming, stylish, precious, accessorize and fashion conscious. She concluded her presentation by demonstrating the impact of word choices and body language, especially in the business world.

As spring approaches, our group will be gathering volunteer hours and preparing to attend the state convention.
