

This document has been processed in accordance with ANSI's requirements for a Provisional American National Standard. The same or similar document will undergo the standards development process set forth in AARST's accredited procedures. This Provisional American National Standard shall be withdrawn on or before the two year anniversary date of its approval as such. While AARST's accredited consensus procedures for public review have not been completed at the date of this publication, the consensus body and supervising consensus bodies have approved provisional publication with consideration for safeguarding lives.

State License Holders

- Most state-licensed testers and mitigators qualify for NRPP
 - Check with NRPP for your state
 - Submit application, fees, & proof of current license
 - Avoids retaking entry courses and exams
 - Analytical providers and labs MAY have additional requirements not all states have same rules as NRPP
- NRPP is able to develop new add-ons faster than State legislative or rule making processes
- NRPP hoping states will recognize new add-ons
