
Executive Summary

ODH-confirmed COVID-19 cases, hospitalizations, and deaths continued to trend upward. According to ODH, 585 (+110) of the 2,199 (+266) confirmed cases are currently hospitalized.

On March 31st, 2020, President Donald J. Trump declared that a major disaster exists in the State of Ohio and ordered Federal assistance to supplement State and local recovery efforts in the areas affected by the Coronavirus Disease 2019 (COVID-19) pandemic beginning on January 20, 2020, and continuing.

Workgroups continue to plan for assessed medical surge, personal protective equipment, quarantine, and congregate care needs. ESF-14 has requested statewide approval for non-congregate sheltering through FEMA.

ESF-8 reports that the third shipment of PPE has arrived at the warehouse and is scheduled to be delivered to the counties on Wednesday, April 1.

State EOC Objectives

- 3. Determine how state agencies will continue delivery of essential services to Ohioans while following COVID-19 public health guidelines.
- 4. Identify supply bottlenecks that threaten community lifelines and tools the state can provide to improve the supply situation.
- 5. Determine what emergency authorities and programs are now available through the National Emergency and Public Health Emergency Declarations

National Emergency Declaration for COVID-19

- On March 13, 2020, a federal emergency disaster was declared for the Public Assistance Program. This declaration is limited to costs incurred by state and local government and in very limited circumstances, non-profit organizations, for Category B, emergency protective measures.
- On March 19, 2020, U.S. Small Business Administration (SBA) has approved Ohio's request to allow small businesses and nonprofits in Ohio to apply for low-interest, long-term loans of up to \$2 million through the SBA's Economic Injury Disaster Loan program.
