**Statement of Work
State of Missouri Participating Addendum
NASPO Master Agreement #99SWC-S26
ST. LOUIS COUNTY (MO)**

This Statement of Work ("SOW") is by and between St. Louis County, Missouri ("County") and Securus Technologies, LLC (f/k/a Securus Technologies, Inc.), ("Contractor") and is made pursuant to the Participating Addendum entered into by the State of Missouri and Contractor relating to NASPO Master Agreement #99SWC-S26 (the "Participating Addendum"). St. Louis County Government is authorized pursuant to Section 107.200 of the St. Louis County Revised Ordinances to enter into this SOW. This SOW is effective as of the last date signed by either party (the "Effective Date").

1. Term. The SOW begins on the Effective Date, but the "Initial Term" will begin 120 days after the Effective Date (to allow for installation of hardware and/or implementation of network connectivity) and will end on the date that is 36 months thereafter. St. Louis County has the option to renew the contract for two (2) additional one (1) year periods at the same terms and conditions. The contractor is obligated to renew the contract at the same terms and conditions for the optional term if the County exercises its option to renew the contract. County will delivery written notice of non-renewal at least 90 days before the end of the then current term. In the event the Statement of Work between Contractor's subsidiary JPay LLC and County pursuant to NASPO Master Agreement #1901 is terminated for any reason, this SOW will also be terminated, unless otherwise agreed. The terms and conditions of this SOW will continue to apply for so long as Contractor continues to provide the Applications to County after the expiration or earlier termination of this SOW.

2. Products and Services. Pursuant to the Participating Addendum, Contractor will provide the products and services described in Exhibit A during the term of the SOW (collectively, the "Applications"). All Applications in this SOW are included and described in greater detail in NASPO Master Agreement #99SWC-S26 ("NASPO Master Agreement"). Any products or services described in the documents referenced in the NASPO Master Agreement or Participating Addendum which are not specifically included in this SOW are not included.

3. Grant of License from County to Contractor. County grants Contractor the exclusive right and license to install, maintain, and derive revenue from the Applications at all correctional facilities under County's authority now and in the future during the term of this SOW. Subject to the remaining terms and conditions of this SOW, Contractor and, as applicable, its subsidiaries, will be the sole and exclusive provider of incarcerated end user communications, whether fixed, mobile or otherwise, including but not limited to voice, video, and data (e.g., phone calls, video calls, messaging, prepaid calling cards, debit calling, and e-mail) and incarcerated end user software applications (e.g., automated grievance filing system, law library, etc.) at all correctional facilities now or in the future under the authority of County and to the exclusion of any other third party providing such services, including without limitation, County's employees, agents, or subcontractors.

4. Ownership of Applications and Grant of License to County. Other than as specifically set forth herein, Contractor does not grant or otherwise convey any license or other ownership right in or to its Applications or any technology or intellectual property rights associated with its Applications. Contractor grants County a personal, limited, non-exclusive, non-transferable license (without the right to sublicense) to access and use the Applications solely as contemplated by the SOW (the "County License").

5. Additional Terms of County License. In connection with the County License, County agrees that (a) it will not resell, assign, or otherwise transfer the Applications or any portions thereof; (b) it will only use the Applications for lawful purposes and will not transmit, retransmit, or store material associated with the Applications in violation of any federal or state laws or regulation; (c) it will not provide access to the Applications to third parties; (d) it will not connect the Applications to any products that Contractor did not furnish or approve in writing; (e) it will not create derivative works based on the Applications; (f) it will not disassemble, reverse engineer, decompile, or otherwise attempt to reveal the code, trade secrets, or know-how underlying the Applications or allow any third party to do so; (g) it will not remove, obscure, or alter any intellectual property right or confidentiality notices or legends appearing in or on any aspect of any Applications; (h) it will be responsible for distributing and assigning licenses to its end users; and (i) it will monitor and ensure that its licensed end users comply with these terms.

6. Ownership and Use of Certain Data Associated With the Applications. County will own recorded communications associated with the Applications (the "County Data"). During this SOW and for a reasonable period of time thereafter,

Contractor will provide County with access to the County Data. County grants Contractor a perpetual, worldwide, non-exclusive, non-transferable right to use the County Data (the "Securus License").

7. Third-Party Software. The deployment of certain features and functionalities within Contractor's Applications which utilize third-party content or services may require a direct agreement between County and the third party as a condition which must be fulfilled prior to deployment.

8. Private Communications. County may designate certain communications (for example, attorney or clergy communications) as "Private" within certain of the Applications. County acknowledge and agree that County have the sole discretion, authority, and responsibility to designate certain communications as Private, and that Contractor has no discretion, authority, or responsibility to make such designations, unless done so at County's instruction.

9. Entire Agreement. This SOW represents the full and entire understanding and agreement between the parties with regard to the subject matter hereof and supersedes all prior agreements (whether written or oral) of the parties relating to the subject matter of this SOW.

Contractor will provide telephone services and Contractor's Secure Call Platform for all County facilities at no cost to County. Contractor will charge the calling rates in the following chart:

*Plus applicable taxes, fees, and the following features described in Footnote 1 of the Inmate Phones tab of Contractor's cost proposal: Account Activator, Postpaid Collect – Direct Bill, and Securus Debit. In the event Securus Debit is deployed, Contractor will invoice County on a weekly basis for all funding amounts transferred from facility trust/commissary accounts to Securus Debit accounts. The invoice will be due and payable upon receipt. These call rates are built using the selected options in this SOW plus the NASPO base rate provided for by the Participating Addendum based on annual minutes of system usage. These call rates may be subject to an annual adjustment in the event County's annual minutes of usage results in a change in the base rate provided for via the NASPO documents incorporated into the Participating Addendum. Outbound voicemail will be charged based on the rates in the above table.

Contractor will provide the equipment needed to support the required number and type of phones and other components in connection with SCP. Additional equipment or applications will be installed only upon mutual agreement by the parties, and may incur additional charges. Contractor will store call recordings for a period of 84 months from the date of recording. County may download and store call recordings during that period. County is solely responsible for preserving any call recordings beyond that storage period by downloading them to a separate storage medium. Contractor will provide an on-site technician to assist the County with the Applications at no additional cost to County.

II. Phones – Standard Investigative Tools

Contractor will provide the Investigative Tools selected by County in the table below:

<u>Investigative Tool</u>	<u>Description</u>
Voice Biometrics (Investigator Pro)	Call Voice Biometrics is a feature that will identify all incarcerated individuals on a phone call using voice biometric technology.
THREADS with SCP	Analytical software integrated into SCP – with automatic upload and analysis of calling records, trust account funding data along with easy import of retrieved contraband cell phone data – plus much more.
ICER	Identifies communications between incarcerated individuals wherever and whenever they happen. Automatic detection and reporting of conversations between individuals within a facility or between facilities when individuals are calling same or different numbers.

The cost of the selected investigative tools was considered and included in setting the rates and other compensation provided for under this SOW.

III. Phones – Corrections Solutions

Contractor will provide the Corrections Solutions selected by County in the table below:

The cost of the selected corrections solutions was considered and included in setting the rates and other compensation provided for under this SOW.

Contractor will provide 8 booking phones, 2 TDD units, 2 Investigator Pro enrollment phones, 62 sets of VPM phones, 3 laptops, 3 other workstations (specific equipment to be reasonably agreed), and a scanner at no cost to County.
