

Dear Governor Brown:

I respectfully submit my application for appointment to the University of Oregon Board of Trustees. The opportunity to serve our State and the U of O in this capacity would be an honor and a privilege. My interest in the position is grounded in my belief in higher education as an economic engine for our state, the important path a college degree paves for graduates, and my personal experience with the University since 1985.

Over the last 35 years I have been an employee, volunteer, student, graduate, and Foundation trustee and officer at the University of Oregon. I was hired to the development staff in the Fall of 1985 to open and run a satellite office in Southern Oregon for the athletic department. After 15 months I was promoted to the Portland office where I worked for two years. Upon leaving the University to work in the investment industry, I enrolled in the University of Oregon's executive MBA program and proudly graduated in 1991.

Over the next twenty years I volunteered as a fundraiser, served on the Pioneer Award Committee for more than a decade, was a guest lecturer on numerous occasions at the business school and remained an active, vocal advocate for the University. My involvement increased significantly in 2007 when I was invited by the Foundation to serve as a trustee. It was a humbling appointment considering my admiration and respect for Foundation trustees from my employment as a young fundraiser 30 years prior. I served as Chair of the Foundation board in 2015 and 2016 to complete my 10 years on the board. The access gained from this role to information, programs, people, challenges and successes provided an in-depth understanding of the University. Interestingly, it was during my term at the Foundation Board that the University of Oregon Board of Trustees was created.

Finally, the University of Oregon is a family affair. My wife, Kasey Brooks Holwerda, completed her undergraduate degree in 1986 and her Juris Doctorate in 1989. She was elected as student body president in 1988 and served on the State Board of Higher Education during her term as ASUO president. We have three grown children, and our youngest, Sina, graduated from the U of O music school last June. We are delighted to have a second-generation Duck in the family.
