CONTAINMENT 2.0¹⁾

Quantifying SARS-CoV-2 transmission suggests **epidemic control with digital contact tracing** (Prof. Fraser Oxford):

- Pre-symptomatic infection is a critical factor (see Figure 1 blue area), people do not know that they are already infecting others
- Time from symptom → labor test → test result → trace contacts → inform contact → isolate potentially infected people takes too long to effectively break infection chains
- In theory, if 60% of population would use an app and 60% do isolate based on the app, the pandemic would be solved (Figure-2)

The red cross app design is based on notification when symptoms are starting, to be even more efficient







