

STP Transit/PNR Element


- Overview of Gateway Cities transit system
- Identification of system issues & deficiencies:
 - Mobility (e.g. limited long-haul/fixed-guideway transit options)
 - Safety (e.g. bike/ped collisions are on the rise)
 - Accessibility (e.g. park-and-ride demand exceeds capacity)
- Recommended transit projects
- Recommended park-and-ride projects
- Transit policy priorities

Eco-Rapid Transit Focus

- Considered STP priority project, alongside other transit, arterial, freeway, goods movement, and technology projects
- Provides one of greatest single contributions to subregional transit ridership and auto trip reduction under STP
- Working with Eco-Rapid Transit & Metro to ensure supplementary projects (e.g. park-and-ride elements) and most recent analysis results are incorporated in Final STP report
- Following recent board motion regarding Eco-Rapid / Gold Line coordination
- STP will include a funding/finance element aimed at forecasting funding needs and available resources to apply for funding

STP TRANSIT PROJECTS

- STP includes major regional transit programs, including:
 - Eco-Rapid Transit
 - Gold Line Eastside Extension
 - Enhancements to Metro Blue, Green Lines
 - Amtrak & Metrolink
 - Long Beach Transit BRT routes
 - OCTA Rapid Bus to Long Beach
- Park-and-Ride Lots
- Also constitute "Mobility Matrix" transit projects to be evaluated in Metro LRTP Update (due 2017)

Transit Policy Priorities

- Invest in service and operational improvements that improve the frequency and reliability of existing services.
- Invest in enhanced personal security features.
- Invest in transit access safety features.
- Invest in providing real-time arrival and departure information to customers.
- Invest in improved transit station and stop amenities to meet the needs of persons with disabilities and senior citizens.
- Invest in context-sensitive amenities at bus stops.
- Provide fare incentives to key transit users through regionally coordinated program.
- Improve coordination between transit agencies.
