## THE STUDENT BODY PRESIDENT

To the Honorable Senate:
This is to advise you that on this date, pursuant to the authority vested in me, by Article I, Section V, Subsection II of the SGA Constitution, I, Chase Blevins, Student Body President of Oklahoma State University, hereby veto Senate Bill S19BL034, which passed the Honorable Senate on April 24, 2019.

The Students of Oklahoma State University have voiced their frustrations with the current election and judicial processes, and this piece of legislation does not address these concerns. The proposed "Election Commission" does not address the issue that arose this past presidential election, of the Election Agency members not being required to have a running knowledge of the SGA Bylaws and Constitution. It is the duty of this body and organization to ensure our processes are as efficient and fair a possible. This can only be achieved when individuals making the decisions have a running knowledge of our Constitution and Bylaws, and fully aware of their job description.

The Trial Court does not add to the efficiency of the process, and does not create a fair process. We cannot have the same three people rehearing a case where their decision is being appealed to the Supreme Court. A better process would be to have the Election Agency verify the votes of the elections, and leave all of the decisions to the SGA Supreme Court. The Supreme Court per our Constitution and Bylaws is the only branch that is able to interpret our bylaws, and hand down rulings based on their interpretation. Therefore, the best practice would be for all violations to be sent to the SGA Supreme Court, and require three (3) Justices signatures to be heard in a formal court hearing.

For the above reasons, I have vetoed S19BL034.
