Are there services covered before you meet your deductible?	Yes. In-network prenatal care and preventive care, certain value drugs. The family deductible can be met by eligible costs incurred by any combination of members enrolled under the same family plan. But, the entire amount of the family deductible must be met before benefits will be provided for any one member.
