# Sustainable Urban Forests Coalition FY 2009 Forest Service Budget Recommendations

#### Invest in Urban Forests for Healthier Cities

### \$50 million for the Urban and Community Forestry Program.

- \$36 million for State Cooperative Assistance. U&CF leverages \$3 for every \$1 in federal assistance and serves 83% of the population. This program helps communities assess, manage and maximize the benefits of trees in urbanized landscapes.
- \$2 million for integrated Technology Transfer and Education to further practices and policies that improve urban forest management and care.
- \$12 million for a Metropolitan Areas Canopy Restoration Initiative to assess, restore, and maintain urban tree canopy in 10 to 15 pilot cities. The initiative will devise science-based tree canopy targets, set strategies to maximize ecological service benefits, and monitor results in cities.

#### \$8 million for urban forest research projects.

The coalition supports the establishment of urban long-term research stations in selected cities to examine urban natural resource issues. In FY 2007, the Forest Service funded roughly \$6.2 million in research on urban forests as part of the overall Research & Development budget. In FY 2009, the coalition recommends \$8 million for urban resources research. Key units:

Northern Station at Syracuse, NY – urban forest effects on air and water quality

Northern Station at Evanston, IL – natural environments for human populations

Northern Station at Burlington, VT – human values and urban forests

Pacific Southwestern Station at Davis, CA – helping cities manage risks/benefits of trees

Pacific Southwestern Station at Riverside, CA – wildland interface and urban cultures

Southern Station at Gainesville, FL – southern fire and reducing wildland interface risks

Southern Station at Athens, GA – technology transfer center

RM Station at Flagstaff, AZ – southwest wildland /urban interface and restoration

#### Key Benefits of Urban Forests

- Climate: Trees cool ambient temperatures in cities, reducing CO<sub>2</sub> emissions. Urban trees also sequester 22.8 million tons of carbon per year a service worth \$3.8 billion annually.
- Energy: Tree windbreaks reduce residential heating costs 10-15%, while shading and evaporative cooling from trees can cut residential cooling costs 20-50%.
- Water: Urban forests promote water quality and reduce stormwater management costs.
- Air: Trees produce oxygen, intercept airborne particulates, and reduce smog.
- **Regulatory Compliance:** Increasing tree cover by 10% in New York City would meet over 1/3 of the city's federal air quality compliance needs for ground level ozone.
- **Risk Management:** Professional urban forest management contains threats in the "urban interface"—such as invasive species, exotic pests, and fire—that pose a risk to forestlands.
- Public Health: Access to trees, green spaces, and parks promotes greater physical activity, reduces stress, and reduces asthma risks.
