Brigance: Expanding CSUCI Teacher Preparation Assessment Abilities

Brief Project Description

Currently, students becoming special education teachers are required to take a course on formal assessment (SPED 545). In this class, we learn how to give, score and report on findings from the Woodcock-Johnson Achievement Assessment (WJIV) which is widely used in Ventura County.

In the last year, it has come to my attention that we have students who are placed in kindergarten and first grade classrooms for whom the WJIV is not appropriate- the children require a more functional assessment in order to gauge their abilities. Additionally, we have a need in the county for practitioners to be able to assess preschool-aged children; the Brigance would be appropriate for this population as well. As the instructor of this course, I do not have the tools to teach our students assessment for this young student population (at CSUCI we have multiple WJIV kits). The Brisance would bridge the gap we currently have regarding age and appropriateness of assessment.

Additionally, special educators are tasked with assessing children regarding transition goals. I currently do not have any materials to teach this type of assessment. I am requesting one Brigance Transition Skills Inventory Kit for this purpose.

In total, I am requesting funds for the purchase of one Brigance IED (Inventory of Early Development) Standardized Kit, one pack of record books for an existing Brigance CIBS (Comprehensive Inventory of Basic Skills) kit and one Brigance TSI (Transition Skills Inventory) kit.

With the purchase of these assessment kits and protocols, I'd like to continue building an assessment center for the education program and demonstrate our understanding of local need while growing our assessment library; these kits will directly benefit our students in becoming trained on an assessment for young children, and their students for years to come. Because the funds will largely be for the kits, their utility is not limited to one semester but will be of service for quite some time.
