

#### **Aims**

1. The aim of this policy is to clearly set out the arrangements for centres awarding Teacher Assessed Grades (TAGs) to private candidates.

## **Roles and responsibilities**

#### Head of centre

The head of centre, (Hafez) Lukman Ahmed, will be responsible for implementing the policy and for determining teacher assessed grades.

#### **Heads of subject**

3. Heads of subject will be responsible for assigning a TAG based on the evidence available for private candidates.

#### **SENCO**

4. The SENCO will be responsible for ensuring any appropriate access arrangements are in place for private candidates.

#### **Examinations Officer**

5. The examinations officer will be responsible for the administration of TAGs and for managing the school's post-results service.

#### List of centres

- 6. The centre's details will be published on the Joint Council for Qualifications (JCQ) <u>list of centres</u> for private candidates. Private candidates can use the list to find an examination centre and filter by the subjects offered.
- 7. The head of centre will ensure that the information provided to JCQ accurately reflects the arrangements available for private candidates.
- 8. Private candidates must register with the school before 26 April 2021 to avoid late entry fees and to allow enough time for assessment. This does not affect existing private candidates' entries: they do not need to re-register.

#### **Candidates**

- 10. The centre will, where possible, accept entries from private candidates. A private candidate is defined by Ofqual as a learner in relation to whom there is no relevant centre. A relevant centre, in relation to a learner, is a centre which has:
  - purchased the general qualification or VTQ on behalf of the learner;
  - materially contributed to the preparation of the learner for the assessment (whether through teaching or instruction provided by teachers employed by it or otherwise);
- 11. It is the responsibility of the centre to satisfy themselves that candidates meet the criteria.
- 12. Examples of private candidates include:



- individuals who are electively home educated;
- individuals who are alternatively educated;
- independent adult learners;
- individuals otherwise not affiliated with a school, college, or similar provider.
- 13. Students who are enrolled in a school or college (state-funded or otherwise) but taking an additional subject that they have studied entirely without support from that school or college, can be included in centres' grant claims for that additional subject only.
- 14. Candidates should be in England and registered with an England-based centre, or otherwise have a reasonable expectation that they would have taken examinations in England if the examinations had gone ahead. There is no candidate age restriction for this grant.

#### Qualifications

- 15. The qualifications eligible for the grant are:
  - GCSEs, AS levels and A levels, in all subjects;
  - all vocational and technical qualifications and other general qualifications that are regulated by Ofqual and are used to progress to further education and higher education on the same basis as GCSE, AS and A level, and would normally have assessments or exams in the summer term;
  - functional skills qualifications which would normally have had an examination between March and June 2021 inclusive and need to be assessed under alternative arrangements.
- 16. Awarding organisations will set out on their websites how each of their qualifications will be awarded under the alternative arrangements announced on 25 February.
- 17. Candidates may enter for multiple subjects, though candidates should only enter for subjects they were already planning to enter this summer.
- 18. International GCSEs and International A levels are not eligible because these are not regulated by Ofqual.

# **Registration for candidates**

- 19. At the point of registration, the head of centre will ensure a meeting takes place between the head of subject and the private candidate to discuss assessment arrangements including:
  - the use of awarding body assessment materials;
  - assessment of any pre-existing evidence;
  - assessment of any new evidence;
  - the provision for any assessment of work to be completed remotely.
- 20. Where the candidate wishes to rely on pre-existing evidence, this must be supplied to the head of subject *by the assessor* along with the completed declaration of authenticity (appendix 1). While it is expected that the candidate will wish to signpost the centre to pre-existing evidence, the actual evidence will not be accepted from the candidate themselves.
- 21. When awarding TAGs, the most reliable and authentic evidence should be considered. Ofqual guidance to teachers is that the more recent evidence is likely to be more accurate and reliable for the purposed of awarding TAGs.
- 22. Where possible, private candidates will be assessed with the same range of evidence that is being used to assess internal candidates. However, where internal candidates are drawing



- upon evidence from existing work, private candidates may be given the same or a similar task to complete independently.
- 23. During the registration meeting, the Private Candidate Registration Form (appendix 1) will be completed and signed.

# Fees for private candidates

- 24. In a normal year, private candidates pay the entry fee for their qualification, and an additional charge for the centre to administer the entry. This arrangement will remain for summer 2021.
- 25. Additional costs will be covered by the government private candidate support grant.
- 26. The following charges will apply for candidates to cover exam fee and administration costs:
  - £250 per subject at A level;
  - £150 per subject at AS level;
  - £150 per subject at GCSE.
- 27. For VTQs and other general qualifications, the fee differs according to the specific qualification.
- 28. There will be no additional fee charged in the event that a private candidate wishes to appeal.
- 29. The centre will be able to provide any private candidate with reasonable adjustments on the grounds of disability in line with the Equality Act 2010 at no additional cost to the candidate.
- 30. Fees must be paid at registration.

#### **Review**

31. This policy relates specifically to the special arrangements for awarding Teacher Assessed Grades to private candidates in 2021. As such, the policy will only be applied for the summer 2021 series.
