9. RESTRICTED IMPORTS

9.1 Goods restricted

The following goods may be imported into Cameroon but are subject of a special visa delivered by the government or subject to special procedures. Consult Douala LO in case of doubt

- 1. Hard soap in non conformance with regulations (Check with LO)
- 2. Cigarettes boxes, packets, cases and tobacco based products for retail shall bear the remark "Message du Ministère de la Santé Publique:" le tabac nuit gravement à la santé du fumeur et celle de son entourage Goudrons 14mg Nicotine: 1.2mg" or "Warning from the Ministry of Public Health: Tobacco seriously damages your health and that of persons around you TAT: 14mg NICOTINE: 1.2 mg" or similar messages accepted by the Ministry of Public Health. In case of clarification, affiliates are advised to consult LO.
- 3. Pharmaceutical products and medicine for veterinary
 - i. The Cameroon regulations require that the direction for use and other indications must appear both
 - ii. in English and French on each packing
- 4. Edible meat
- 5. Sea or bred fish, crustaceans and molluscs
- 6. Alimentary preparations for other animals (see code 2309.90.00 of Cameroon Customs tariff book)
- 7. Medicated soaps
- 8. Prepared explosives, other than propellant powders; pyrotechnic articles, beacon rockets.
- 9. Transmitter-receivers and other receivers.
- 10. Weapons and war ammunition
- 11. Precious substances (gold, platinum, sapphire, etc)
- 12. Radioactive substances (uranium, thorium, deuterium, etc) and equipment containing radioactive elements.
- 13. Salt: maximum iodine 100 ppm or 100mg/kg
- 14. Wheat Flour: Norm as per decree N°27/MINDIC/DPPC dated 1 March 1994; laboratory analysis is compulsory.
- 15. Bovine meat of European origin (importation suspended)
- 16. Pharmaceuticals products and medicine for veterinary purposes
- 17. Order No. 0064 of 12/05/95 and the list of control substances under the Montreal Protocol I)
- 18. 17019910 and 17019920 Sugar (special authorization delivered by the Ministry of Finance)
