Preface

We have a great delight in presenting an account of the HTCC activities during the Financial Year 2008-09.

It is said that Hindus have 366 festivals for the 365 days of the year. This was certainly felt very acutely during the year. There was never a time when preparations were not being made for some celebration or the other.

This report contains a record of the activities we had during the year. The activities are listed under a few different headings and the three chief divisions being Devotional, Educational, and Cultural activities. It will be seen that a good balance was achieved during the year.

Five aaratis were performed each day, most festivals were celebrated on the day itself, and many other worship ceremonies took place.

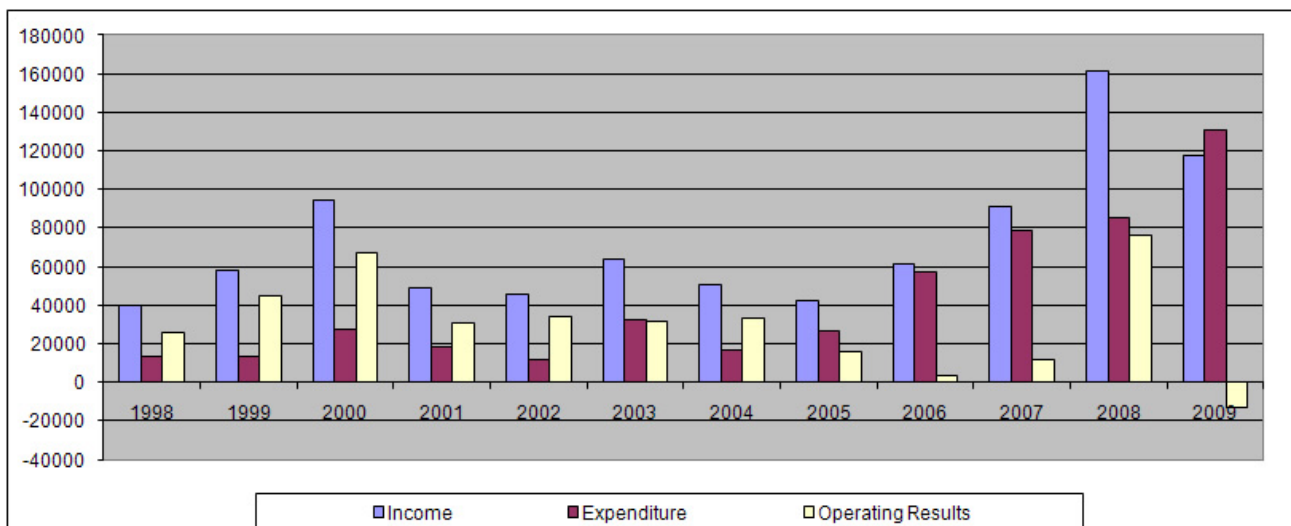
Educational activities include weekly Yoga classes, Hindi courses, weekly Sanskrit classes, meditation classes, and many special lectures and discourses.

In cultural activities we had the second Ramayan Sammelan in Australia, Navarang, Dandia, Holi & Deepavali Melas, Girmitt Day celebrations, food-fairs, and many other programs.

A few years ago HTCC started celebrating every festival on the day of the festival itself and not shifting it to the nearest weekend. This seems to have gone well with the devotees. At many of the festivals on weekdays there has been a presence of up to two hundred devotees.

On the days of almost all religious festivals bhojan-prasad has been prepared by a few devotees persuaded by Punditji. This humble service has been provided during both the Navratris and the week leading upto Janmashtami. This will continue in future too. Devotees are requested to make use of this service and if they so wish they can provide this service in return to other devotees on the days of their choosing.

Devotees have been generous with their donations. It was remiss on the part of the committee not to have special fund-raising campaign and yet due to the generosity of the devotees we again crossed the hundred thousand mark. Here is a snapshot of the financial status of the organisation.



Devotees have been generous in financial donation and yet very miserly in one of the most important community activity - volunteer work. In spite of repeated requests for volunteers to help with maintenance, cleaning, and construction work, few devotees showed up. On most occasions Punditji was the most prominent volunteer cleaning, gardening, and doing all manner of tasks!

Everyone is busy and that's perfectly understandable but what is needed is for people to set aside at least one hour a month to do volunteer work at the Temple. Devotees can work on projects or tasks of their own choosing. One doesn't have to do manual work as a part of volunteer service, your presence, appreciation and bringing a few cups of tea or coffee or drinks for the volunteers working at the Temple is a gesture which will go a long way in encouraging the volunteers who work with dedication. Please show your generosity by a pat on the back for the working volunteers or joining hands with them in devotional service around Temple.

Monthly food-fairs have started to attract larger numbers but most of them are not our members. Imagine the encouragement you will provide to the volunteers by your coming to the food-fair and getting a good, tasty, healthy meal for yourself for five or six dollars. If you are not hungry just come and buy a can of coke or a plate of pakoras. Even a little gesture as this is significant. Please come to the food-fair and encourage our volunteers. This is such a simple task and yet the returns are very high.

We have a unique opportunity to create a culture of appreciation and encouragement. Unrealised by many, the mere presence of positive thinking, appreciative, and encouraging devotees is enough to drive out the unfortunate culture of denigration and intimidation.

Let us hope our members will be generous - not only with their financial contributions but also with volunteer work for the Temple.

We thank the community for providing us with an opportunity to serve. We seek forgiveness for the mistakes committed during the course of service.

Projects

Kitchen renovation

Kitchen renovation is almost completed. Various lockable cupboards have been installed to allow proper and adequate storage of utensils, food grains, spices, disposables, etc. Additional cupboards have been made where exclusive items for Bhog can be stored. New gas cook top is installed and whole stainless steel bench in the middle work area is covered and aluminium strips installed to allow storage of large pots. Due to this installation large pots are not visible from outside the kitchen or from the side facing the fridge. The only outstanding item is the installation of hood, for which an order has been placed and it will be installed within next few months.

Navgrah

Murties of Navgrah have arrived. An area for Navgrah installation is being prepared. Retaining wall is complete. The area has been

filled and levelled and concreted. A drawing for structures to accommodate Navgrah has been prepared. Installation and pran pratishtha will be done within next two to three months.

Shikhar

There is no progress with the shikhar fabricator. Two meetings (on 3/03/09 and 6/04/09) were held of all past presidents and other proponents of shikhar project to discuss a "way forward."

Following actions items were agreed in those meetings.

1. As advised by ACT law society, HTCC to send a demand letter to the shikhar fabricator Mr Paul Grellis at his old as well as new workshop address by registered post. If we get his home address, a copy of letter to be sent to his home address.
2. Paul Grellis home address to be searched. Contact Graham Downie (consumer voice) for him to talk to Paul Grellis
3. A prototype model, approximately 1m high, to be designed and fabricated by Shri Rahul VEDI so that members can see if it is suitable for our needs.
4. The committee to consider the recommendations and call a general body meeting to advise the status of current project and approval of the new proposed Shikhar. Meeting to be called after completion of the prototype model.

Subsequently, on 26 June, a registered letter sent to Paul Grellis' new work shop; old workshop, and his residence giving him the notice as reproduced below:

"Failing to respond to this notice by 24 July 2009, the "Sikhara" project deal with you stands terminated and HTCC will not be liable for any dues. However HTCC would consider to take appropriate legal action against you to recover the \$17935 + bank interest for 7 years."

All the three registered letters posted to Mr Paul Grelis have returned. He did not accept them.

Shantiniketan

A concept plan has been prepared which includes, Hall, Library, Storage room and Change room.

A separate account has been opened and till date \$ 22,076 has been raised.
