Dear friends,

In August 2012, STARS experienced one of the busiest long weekends in our 27-year history. In three days alone our crews responded to 32 emergencies across the Prairies. Nineteen of those missions were inter-hospital transfers, while 13 were direct-to-scene calls, where our pilots landed the helicopter on highways or open fields to ensure patients received advanced critical care as quickly as possible.

For all of us at STARS, each one of those 32 emergency missions is about the privilege of delivering care to an ill or injured patient on the worst day of his or her life. Those 32 people work, play and raise families in our communities. They are our friends, family members and neighbours.

We are proud and grateful for the opportunity to have been there for those patients that weekend. The same can be said for all of the nearly 24,000 patients we've carried since we launched in 1985. You too, can be proud, for we couldn't have done it without you: our partners, supporters and donors.

From our roots in Alberta, we are humbled to continue spreading hope across the Prairies. Both of our bases in Saskatchewan are busy, with each of them now operating 24 hours a day, seven days week as we do in Edmonton, Calgary and Grande Prairie. In Manitoba, we hired and trained more than 50 new team members. Likewise, in Saskatchewan, more than 90 people joined STARS in 2012.

Some other highlights, made possible by your generous support, include:

- Welcoming two AW139 helicopters into our fleet thanks to the roughly 1,300 donors who raised \$26.5 million needed to purchase the aircraft;
- The STARS Edmonton base found a new home, moving from downtown to our new quarters just outside the city;
- We incorporated three BK117 aircraft into our fleet.

Our donors make all of this possible in unique and creative ways. Whether you are baking pies for town raffles, a child shoveling snow in exchange for STARS donations or a company offering long-term financial support, the impact is felt across the Prairies. We continue to be humbled by your support. On behalf of all the patients and their families, allow us to offer our sincere and heartfelt thanks.
