
# The Three Branches of Government

Why is the power of government separated into three branches?



### The Legislative Branch



#### The Legislative Branch

- Congress
- Makes the Laws
- Congress is made up of the House of Representatives and the Senate

### Senate

There are <u>two</u> senators from each <u>state</u> no matter what the <u>size</u> of the state or the <u>population</u>



#### House of Representatives

 The number of representatives a state sends to congress varies according to the <u>population</u> of the state.



#### Powers of the Legislative Branch

- Make <u>laws</u>
- Declare war
- Approve <u>treaties</u>
- Approve presidential <u>appointments</u>
- Impeach
- Override <u>vetoes</u>





#### How a Bill Becomes a Law

- Bill is <u>introduced</u> in either the <u>House</u> or <u>Senate</u>
- It is sent to a <u>committee</u> for study
- If it is not <u>killed</u> by the committee, it is sent to the <u>floor</u> to be <u>acted</u> upon
- After <u>debate</u> the Congressmen in that house may <u>pass</u> the <u>bill</u> in which case it is sent to the other <u>house</u> for <u>approval</u>

#### How a Bill Becomes a Law


- If the <u>two</u> houses pass <u>different</u> versions of the same <u>bill</u>, it goes to a <u>conference</u> committee to work out a <u>compromise</u> on the differences.
- The bill then goes <u>back</u> to the two <u>houses</u> for a <u>vote</u>.
- When both <u>houses</u> pass the exact <u>same</u> bill, it is sent to the <u>President</u> for his signature.
- If he signs it, it becomes a law.

#### How a Bill Becomes a Law

■ The president may choose to <u>veto</u> it.

If he <u>vetoes</u> it, it is sent <u>back</u> to the <u>House</u> in <u>Congress</u> where it started with a list of his/her <u>objections</u>.

It may still become a <u>law</u> if both <u>houses</u> pass it with a <u>2/3rds</u> majority


### Executive Branch



#### The Executive Branch

- The <u>President</u> is the head of the <u>executive</u> branch
- He has <u>advisors</u> who work closely with him called the <u>Cabinet</u>.





#### The President's Cabinet

- The <u>cabinet</u> is a group of presidential <u>advisers</u> that includes the heads of the <u>15</u> top-level <u>executive</u> departments.
- The head of the Department of <u>Justice</u> is called the <u>Attorney General</u>; all other <u>department</u> heads are called <u>secretaries</u>

#### Powers of the Executive Branch


- Enforce <u>laws</u>
- Negotiate <u>Treaties</u>
- Appoint government officials
- Sign or <u>veto</u> laws
- This branch is given the power to <u>enforce</u> the <u>laws.</u>

## The Executive Branch Checks The Legislative Branch

The president <u>checks</u> on the <u>Legislative</u> Branch by <u>signing</u> or <u>vetoing</u> bills <u>Congress</u> has passed.

If he/she vetoes the bill, it is very unlikely it will become a law. A 2/3rds vote of Congress to override a veto is very difficult to get.

### Judicial Branch



#### The Judicial Branch

- The <u>Supreme Court</u> is the head of the Judicial Branch
- There are <u>9</u> justices on the Supreme Court


The Judicial Branch Checks on the other Branches

#### **Judicial Review**

The court has the power to determine whether a law is <u>constitutional</u> or not. If the <u>law is unconstitutional</u> it can not be enforced.

The Supreme Court has the power to determine if a government officials actions are

<u>Constitutional</u> or not



#### Powers of the Judicial Branch

- It is given the power to <u>Interpret</u> the <u>law</u>
- Judicial Review The Judicial Branch checks on the other branches

# Interpreting the Law Marbury V. Madison

- In his last days as president, John Adams appointed many people as judges in federal courts.
- Some of the commissions or appointments were not <u>delivered</u>, including those of some Justices of the Peace in Washington, D.C.
- When Thomas Jefferson, who was a bitter enemy of <u>Adams</u> found them, he <u>threw</u> them away.

## Interpreting the Law Marbury V. Madison

- Some of the men who had been appointed went to the <u>Supreme</u> Court and sued James Madison, who was the Secretary of <u>State</u>, demanding their commissions.
- The Supreme Court ruled that they had no jurisdiction because the Constitution says the case should have started in a lower court.

## Interpreting the Law Marbury V. Madison

- They also ruled that the law that gave them jurisdiction was <u>unconstitutional</u> because it conflicted with the Constitution.
- Significance: By declaring the law unconstitutional, the court established the idea of <u>judicial review</u>, which means that courts have the power to declare laws unconstitutional.

# Interpreting the Law Gideon v. Wainwright

- Gideon v. Wainwright is a case where a man named <u>Gideon</u> was accused of breaking and entering.
- He asked for a state appointed <u>attorney</u> because he could not afford one.
- The state <u>refused</u> to give him one.
- He was found guilty and sent to prison.

#### Gideon v. Wainwright

- While in prison he wrote an <u>appeal</u> to the supreme court saying that according to the sixth amendment it was <u>unconstitutional</u> for him to have been tried without a lawyer.
- The court agreed with Gideon. He was retried with a <u>lawyer</u> and found not guilty.
- Significance: Because of this case, each court is required to provide a lawyer free of charge if the accused cannot afford one.

## Interpreting the Law Miranda v. Arizona

- Miranda was accused of raping a girl in Phoenix,
   Arizona. When the police questioned him, he confessed to the crime.
- He was found guilty and sentenced to prison.
- He appealed his conviction on the grounds that the police should have <u>told</u> him that he did not have to <u>testify</u> against himself. (5<sup>th</sup> amendment)

#### Miranda V. Arizona

- The court agreed with Miranda. They said it was <u>unconstitutional</u> for the police to question him without <u>explaining</u> his right to remain silent.
- Miranda was retried without his <u>confession</u> and found <u>guilty</u>.
- Significance: Because the first case was thrown out, Police now have to read a suspect their rights when they take them into custody

### Juvenile's Rights
