Feature film has done more than any other medium to shape the image of Martin Luther held by the common public in the 20th century. Luther's status a national myth in Germany and Church founder in America required a cinematic concept that was closely linked with theological issues as well as the self-image of the Lutheran Church. 





La Popelinière is thus able to identify what he considers to be the foundation of the doctrine of Machiavelli and opposes a modern concept of the relationship between the Prince and his subjects, far removed from any religious or philosophical issues.
