1. All attendees (Officials, judges, stewards, exhibitors and all workers) are required to follow state, local and facility guidelines in effect at the time of the event.
2. **DUE TO COVID-19 GUIDELINES, THE PUBLIC IS NOT INVITED TO ATTEND THESE EVENTS.**
3. **EXPOSURE TO COVID-19:** If you have recently been in the presence of a person who has either tested positive for Covid-19 or has the symptoms (coughing/sneezing/temperature) please stay home.
4. **IF YOU ARE ILL, FEEL UNWELL, COUGHING, SNEEZING OR RUNNING A TEMPERATURE:** Please stay home. All show committee members, judges, stewards and workers will be required to self-assess and have temperatures taken. ALL attendees should self-assess daily. Report to show committee if you exhibit any signs or symptoms of Covid-19
5. All attendees are expected to adhere to social distancing guidelines and when not possible, are **REQUIRED TO WEAR A FACE COVERING**. Even when social distancing the wearing of a face covering is **STRONGLY RECOMMENDED**. The wearing of a face covering (mask) protects you and everyone around you.
