Dear MSC/Sid Tool Supplier:

Please note that the following encompasses orders for MSC/Sid Tool, also including Class C Solutions Group (CCSG).

Attached is the latest version of MSC's Routing / Logistics Guide. These instructions do NOT change the freight terms under which you ship to MSC. The procedures contained in this Guide <u>must</u> be followed for all shipments from your company, moving to MSC locations, with COLLECT freight terms. This Guide must also be followed for Third Party Bill (To MSC) shipments, shipping to our Customers.

When making prepaid shipments you are not required to follow these routing instructions.

Following these procedures will assist to ensure that your product is received, paid for and available for sale in the most efficient manner.

Here are a few reminders:

- 1) If MSC is responsible for the freight costs on a UPS Small Parcel shipment, you are to ship collect, using the appropriate MSC UPS Account Number.
- 2) For Freight/LTL shipments (Not Small Parcel) you are to follow the attached Routing Guide. Included in the Guide is a matrix for your use in determining the carrier you are to utilize for moving this freight.

Please do not confuse UPS/FedEx Small Parcel with UPS Freight or Fed Ex Freight.

MSC **DOES NOT** UTILIZE FEDEX FREIGHT or XPO LOGISTICS. UPS FREIGHT as a carrier is not to be used for customer shipments unless the terms are "collect" billing our customers. Please refer to the Carrier Selection Guidelines contained herein.

Failure to follow the instructions contained in this guide may result in your company being charged back for full freight costs and administrative expenses. Feel free to contact the MSC LOGISTICS DEPT. at 800-792-5708 or 516-812-2030 should you have any questions.

FREQUENTLY ASKED QUESTIONS - TRIANGLE GUIDE ONLY:

1. How should I label pallets that I am sending to several MSC CFC'S on one LTL shipment?

ANSWER: Each skid should be labeled to the final intended destination with a copy of the specific pallet label provided in the guide.

2. How do I have to document a combined shipment to one location on my shipping paperwork?

ANSWER: The complete shipment detail should be shown as appropriate on the manifest, shown in the guide. The actual BOL should show the shipping details, and also list the manifest as a single extra item to be signed for by the pick-up driver.

3. So what do I show in the body of the Bill-of-Lading?

ANSWER: For example, if you are shipping from Florida and have pallets for Mableton, Jonestown, Elkhart, and Fernley, your BOL should include this type of information (example only):

"7 Pallets (4,525 Lbs) Consigned to MSC Mableton, GA. which include 1 Fernley, 1 Jonestown,
3 Elkhart, and 2 Mableton labeled Pallets." Appropriate freight description and classification must also be included as necessary.

4. The guide calls for me to use UPS (Collect Account Numbers) for small parcel shipments of less than 12 cartons and having a combined weight not exceeding 350 lbs. My order meets those requirements, but due to the nature of my products and past damage history, can I palletize and ship via LTL using the guide?

ANSWER: This Guide should be followed. If prior experience is cause for concern, please call **800-792-5708** for clarification as needed.

5. What UPS Collect Account Number do I use for a shipment to an MSC BRANCH?

ANSWER: The Eight MSC / CCSG Customer Fulfillment Centers (CFC's) each have their own separate UPS Collect Account Numbers as shown in the guide. (Dallas, TX. Jonestown, PA; Elkhart, IN; Hanover Park. IL: Mableton, GA, Fernley, NV, Columbus OH. Shelbyville, KY.) All other Sid Tool, MSC, Enco or other MSC locations around the country are considered branches, and use the corresponding UPS Collect Account Number found within this guide.

6. My shipping department is incapable of following these guidelines for multiple CFC deliveries to a single combined location as indicated in the guide. What happens if I just ship separate LTL shipments to each final location?

ANSWER: If the terms of sale are such that MSC is "Paying the Freight", any violations of the directions provided in the guide are subject to audit and may result in Bill Back Deductions for any shipping and handling costs plus administrative fees that are caused by not following the guide.

7. I have 6 Pallets that only weigh 3,000 Lbs. Do I have to call for an LTL or truckload routing decision?

ANSWER: Yes. All shipments consisting of 5 or more pallets or weighing 5,000 Lbs. or more must be called into 800-792-5708 for a routing decision. Required Information: Origin Zip, Destination Zip, pallet count, pallet sizes (L x W x H), total Weight, and actual NMFC Class, not your "Carrier Negotiated FAK."

8. How can I get extra blank copies of the MSC Supplier Manifest or Pallet Labels?

ANSWER: Please make copies from the guide.

9. How do I know when to use the different attachments when selecting an Itl carrier?

ANSWER: ATTACHMENT 1 is only for LTL Shipments to any of their five CFC's: Jonestown, PA [Harrisburg]; Mableton, GA [Atlanta]; Elkhart, IN; Fernley, NV [Reno] Columbus OH. ATTACHMENT 2 is for all Class C solutions ltl shipments. Attachment 3 is for all other LTL shipments to any other MSC locations or customers in the USA.

MSC INDUSTRIAL TRIANGLE SUPPLIER LOGISTICS GUIDE (Effective 10/23/17)

INTRODUCTION

Please apply these instructions for carrier selection, packaging, and labeling to all of your shipments destined for MSC Industrial Direct facilities and customers.

Appropriate carrier selection reduces costs and increases customer service, while correct packaging, labeling, and palletizing (as required), ensures the efficient receipt of your company's orders.

This Guide does not apply to shipments that are made to MSC Customers which have requested specific carriers and that the freight be shipped collect and billed to the consignee. Please follow specific directions as listed on MSC's purchase order for these shipments.

The Carrier Selection Guidelines contained herein supersede any prior Routing Guide information, and take precedence over any instructions to the contrary on your MSC purchase orders.

If you need any clarification, please contact our MSC LOGISTICS DEPT. and indicate you have an MSC Industrial Direct routing or packaging question.

As this Guide can not cover all possible questions you may have, we welcome questions.

Any deviation from these Guidelines must be approved, in writing, by the MSC Product Manager responsible for your business.

<u>Please do not mark any declared value on the bill of lading when MSC is paying the freight charges.</u>

When our customer requests a collect shipment (Carrier billing our customer for freight) **DO NOT** list MSC as a 3rd party on the bill of lading.

MSC DESTINATION SELECTION:

This Supplier Routing Guide facilitates the consolidation, appropriate labeling, palletizing, and shipment of Orders to the closest MSC Customer Fulfillment Center to your shipping point.

Brief Explanation: MSC has pre-scheduled Truckload transfers moving regularly between their four major CFC's (Customer Fulfillment Centers) located in Jonestown (Harrisburg), PA; Elkhart, IN; Mableton (Atlanta), GA; and Fernley (Reno), NV. This Guide supports the movement of multiple orders destined to these locations, moving as one truckload or LTL Shipment <u>TO THE CLOSEST CFC.</u> Freight for each

separate CFC must be placed on separate pallets, and must be marked for the appropriate intended Final Destination as outlined herein.

Example: A "Triangle Supplier" located in NJ has pallet orders for MSC Jonestown, Mableton, and Fernley. Attachment 1 indicates that the load should consolidate to MSC Jonestown. If LTL, route via Pitt Ohio. If Truckload, this will consolidate to MSC Jonestown, PA. Each pallet must be marked for the Final Intended MSC Destination, but the Bill-of-Lading will indicate to ship physically to Jonestown. The Bill-of-Lading should indicate ex.) 24 Total Skids to MSC Jonestown, with 12 marked for Jonestown, 5 marked for Mableton, and 7 marked for Fernley.

Shipments to Columbus, OH and Class C Solutions destinations Dallas, TX, Chicago, IL, and Shelbyville, KY will be shipped direct per attachment.

CARRIER SELECTION:

Carrier Selection will be determined by the specifics of your shipment: Number of packages or pallets, weight, type of freight (National Motor Freight Classification description), cube, origin, and destination.

All shipments to the same destination should be consolidated to avoid duplication within any three business days.

Breaking down larger shipments into smaller, more frequent LTL or UPS shipments is not authorized.

HOW TO SELECT A CARRIER:

A) SMALL ORDERS (SMALL PARCEL):

Shipments consisting of less than 12 cartons with a total weight not exceeding 350 Lbs., and that are within the UPS limitations outlined below, ship via UPS Collect billing as follows:

All Orders should be shipped directly to the Customer, Branch, or Customer Fulfillment Center.

UPS LIMITATIONS

UPS Shipments are limited to specific size and weight requirements. Shipments exceeding the following requirements should be palletized and shipped via MSC's Routing Instructions for Medium and Large Orders.

- Maximum 350 Lb. total shipment weight.
- ✓ Maximum 150 Lb. weight per package. NOTE: For packages weighing more than 70 Lbs., the Yellow UPS Heavy Package Sticker Must be Applied to the Right of the Address Label for maximum visibility. Enter the package weight in the White Box on the label.
- ✓ Maximum 130 Inches combined length and girth per package.
- ✓ Maximum 108 Inch Package Length.

B) MEDIUM SIZE ORDERS:

For orders that are more than "UPS Qualified" . . . (above), but less than 5 standard Pallets and less than 5,000 Lbs. refer to the LTL Carrier Selection Matrix herein.

SHIPMENT MANIFEST:

An MSC Industrial Direct Supplier Manifest [Attachment 4 (Sample) and Attachment 5 (Blank-Copy and <u>Re-Use</u>)] must be completed for LTL and Truckload Shipments destined for Jonestown, Elkhart, Mableton, or Fernley. It must include:

- Ship Date
- Skid Totals
- Weight Totals
- Skid Counts (Ex. 1 of 4, etc.)
- Weight per Skid
- PO # Associated with Each Skid

The Manifest must be completed for each shipment, signed by the driver to acknowledge receipt of all skids, attached to the Bill of Lading and listed on the Bill of Lading as an item shipped, i.e. 2 pallets containing 100 cartons and 1 MSC Manifest.

This information is critical to move your product without delay through the cross-dock operation.

PALLET LABELS:

In addition to the Manifest, Shipments destined to Jonestown, Elkhart, Mableton, and Fernley must have two opposite sides of each skid labeled with appropriate Pallet Identifier (Attachment 6-Copy and <u>Re-Use</u>). The identifier corresponds with the Order's <u>final destination</u>. The identifier must be visible at all times and can be attached to the inside of the stretch wrap or securely attached to each individual skid.

CARRIER SELECTION:

Select Carrier by using Attachment 1(Triangle Guide for Cross-Dock Carrier Selection) for Shipments to MSC Customer Fulfillment Centers. Mark the Freight Collect.

Select Carrier by using Attachment 2 (LTL Carrier Selection Guide for all State Combinations) for Shipments to any MSC Customers or Branches. Ship Third Party Prepaid.

On each Bill-of-Lading please note as appropriate: Freight Charges are to be Third Party, Prepaid or Freight Collect. Send Freight Bill To:

C) LARGE ORDERS:

Orders of 5 standard pallet spaces or more and or Shipments Weighing 5,000 lbs. or more, YOU MUST CONTACT OUR MSC LOGISTICS DEPT FOR ROUTING INSTRUCTIONS:

Please have the following information available when you call:

- ✓ ORIGIN ZIP
- ✓ DESTINATION ZIP
- ✓ PALLET COUNT
- ✓ **PALLET SIZE(S)** (Length X Width X Height)
- ✓ **TOTAL WEIGHT** of Order
- ✓ NMFC CLASS or WEIGHT PER CU. FT. (Not your negotiated class with a nonapproved carrier)

D) U S POSTAL SERVICE SHIPMENTS

Small Parcel shipments to United States Postal Service Operations CAN NOT BE MADE VIA UPS.

Small Parcel shipments (Less Than 12 Cartons with a total weight not exceeding 350 Lbs. and within the U S Postal Service Small Parcel shipping guidelines) should be made as follows:

Ship via U S Parcel Post through the regular mail system (prepay and add)

OR

Ship via Fed Ex. Small Parcel Bill to Fed ex Account Number 275418323 (Call Fed EX Small Parcel at: 800-463-3339)

Hazardous Small Parcel Packages to the U S Postal System should be routed via Fed Ex Small Parcel Third Party.

LTL Shipments should be made following the LTL Routing Guide contained in Attachment 2.

NON-COMPLIANCE POLICY:

Loss or damage claims derived from a Supplier incorrectly routing freight will result in a direct charge back of all damages. The Supplier will be responsible to file all claims with the Carrier on misrouted shipments, regardless of F.O.B. Terms.

Any accessorial charges (i.e. detention, sort and segregate, inside delivery, after hour's delivery and notification charges, etc.) derived from Supplier misrouting freight will result in a direct charge back, and administrative fees may be added.

Failure to properly describe the freight with correct NMFC Classifications that result in increased Freight charges or Freight Audit Costs may be charged back to the Supplier.

Failure to tender an LTL Shipment with the proper freight terms (Prepaid vs. Collect) that results in the Carrier invoicing MSC an additional Correction Fee, will result in those costs plus possible Administrative Costs being billed back to the Supplier.

Failure to follow the requirements stated in this Guide may result in a charge back for the full freight expense incurred by MSC Industrial Direct plus an Administrative Fee and possible reduction in business volumes.

SHIPPING INSTRUCTIONS:

Multiple Purchase Order (PO) Shipments:

Every attempt should be made to <u>NOT</u> mix product from different purchase orders in the same carton. If you must ship product from multiple PO's in the same carton, the product must be physically separated using internal packaging and have the PO number(s) clearly identified for the product it is covering.

Consolidation of Orders:

If there will be more than one order shipping within three business days to one MSC location, combine the orders for shipping, unless otherwise notified by MSC. <u>The combined shipment must</u> be sent utilizing one Bill-of-Lading, and must include all of the PO numbers being shipped.

Packaging:

It is the Supplier's responsibility to package product in accordance with MSC Standards and Specifications to minimize product damage. You must adhere to the following guidelines when packaging MSC product:

- ✓ Like items must be banded together (i.e. Inner Packs) within the shipping carton.
- Items packaged in a tube must have the ends taped closed or locked through package design.
- Sets must be assembled and separated by material in the shipping carton.
- Packaging must include a description and/or tool size. Tool size must be marked on each individual tool.

Carton or Pallet Identification / Labeling:

See Attachment 7 (Sample UPS Cartons) and Attachment 8 (Sample Pallet Shipments) for details.

The following information must be clearly marked on each carton or pallet:

✓ Supplier name and address

- MSC destination location address, as stated on the PO
- If a pallet consists of more than one PO Number, the PO Numbers must be shown on each carton.
- ✓ When shipping samples or new items, note "SAMPLES" or "NEW ITEMS" as appropriate in ¾" block print on two opposite sides of the carton.
- Carton Quantity must be clearly marked with the total number of cartons in the shipment: Example: The first carton of a three carton order should be marked "1 of 3", etc.
- ✓ When shipping pallets to MSC's Customer Fulfillment Centers (CFC's) (Jonestown, Elkhart, Mableton, or Fernley), Each Pallet must have two MSC identifier labels (See Attachment) properly completed and attached to two opposite sides. Print should be clearly visible from a Fork Lift seat. These "pallet placards" must include:

MSC DESTINATION NUMBER OF SKIDS WITHIN THE ORDER LOT ("1 of 3"), etc. INDIVIDUAL PALLET WEIGHT

 Label informing the Carrier not to break down the skid or the stretch wrap should be clearly visible on at least two opposing sides of the Pallet.

Packing Slips:

All shipments must include two copies of the Packing Slip, and they must be shipped with the product according to the following guidelines:

Packing Slip #1: For shipments moving via Truckload or LTL, the Packing Slip must be placed in a pouch and attached to the outside of the shrink wrap on the Order's lead pallet, with the Lot Designation of Example: ("1 of __"). (See Attachment 8 Sample Pallet Shipment). The first Pallet or first Carton of a multiple CFC Consolidation shipment must contain the Packing Slip for that CFC's freight. Freight for each separate CFC should have a separate Packing Slip, also attached to the first Pallet or Carton.

For shipments moving via UPS, the Packing Slip must be placed in a pouch and attached to the outside of the lead carton of the shipment. Label the lead carton with Lot Designation of Example: ("1 of __"). (See Attachment 7 Sample UPS Carton Label).

Packing Slip #2: For shipments moving via **Truckload or LTL**, place the Packing Slip in a pouch and attach to a carton contained on the lead pallet inside of the stretch wrap of the shipment.

(Lead carton is the one marked ("1 of __"). This will assist MSC in the event that the Outside packing Slip is lost. (See Attachment 8 Sample Pallet Shipment).

The first Pallet or first Carton of a multiple CFC Consolidation shipment must contain the Packing Slip for that CFC's freight. Freight for each separate CFC should have a separate Packing Slip, also attached to the first Pallet or Carton.

Shipments moving via UPS; place inside the last carton or in a pouch attached to the last carton.

Palletizing:

All non-UPS shipments must be palletized using standard (GMA) wood, 40" X 48" pallets, and follow these guidelines:

- ✓ Total Pallet Height not to exceed 44" (Product Specific Exceptions must be approved by MSC.)
- ✓ Stretch wrap to ensure stability during shipping.
- ✓ Use banding on heavy loads to assure stability.
- Mark as indicated above, instructing carrier not to beak stretch wrap or banding.
- ✓ DO NOT DOUBLE STACK Pallets, unless prior shipping experience has shown this will not cause damage. (Product Specific Exceptions must be approved by MSC.)

Bill-of-Lading Preparation:

Shipments moving on the same day from the same origin to the same destination as designated in Attachment 1 must be on the same Bill-of-Lading, and must contain the following:

- ✓ Supplier name
- ✓ Supplier origin address
- ✓ MSC destination address (Select appropriate destination CFC per Attachment 1)
- Piece count including cartons contained on the skids and the manifest as an item. When shipping pallets you must state the total number of cartons contained on the pallets. For Example: "10 Pallets containing 500 Cartons".
- The "MSC Industrial Direct Supplier Manifest" must be listed on the Bill-of-Lading as an item.
- ✓ Item Description

- ✓ MMFC Number and/or Freight Classification for each item
- ✓ MSC PO Number(s)
- ✓ Carrier Instructions NOT to break down or double stack pallets
- ✓ Accurate selection of whether Shipment is to be Prepaid vs. Collect, and the appropriate "Bill-To Address" when required.

Never put declared value on the bill of lading when MSC or Class C is paying the freight charges






