Stolen guns lead to five arrests

Five people were arrested following the burglary of a number of weapons from Rayville home.

Rayville Chief of Police Willie Robinson said a local resident called Rayville Police Department on June 9 and advised that there had been a burglary at his home.

During the course of investigation, officers discovered that several handguns, shotguns and rifles had been stolen during the commission of this crime. Rayville Police Department Investigative Division conducted a quick and efficient investigation into this case in a concentrated effort to recover the stolen weapons and preserve the safety of the community, Robinson said.

"As a result, the case was swiftly concluded, the firearms were recovered, and the suspects were brought to justice," he said.

The Rayville Police Department issued a total of 12 traffic citations this week. That number includes eight for speeding and one each for no seat belt, failure to yield, failure to use a turn signal and no driver's license in possession.

Rayville Police Chief Willie Robinson would like to remind all citizens of Rayville that it's especially important to be respectful of your neighbors when living in a close-quartered housing area.

"Courtesy and respect for the rights of others are some traits of a good citizen," the chief said. "When you live in an area where your neighbor's property is directly joined to yours, this becomes even more crucial."

Chief Robinson stated that some ways in which to demonstrate that courtesy and respect include keeping noise/music at decent levels, being mindful when parking, and not engaging in verbal/physical altercations with your neighbors over personal disputes or differences.

"If you are having problems with a neighbor, don't get into a heated altercation with that person," he said. "It is better to have a mediator, such as your housing manager, than to risk getting into a situation that could possible lead to your arrest, criminal charges, and/or fines."



Some trades are not worth making

can haunt a team for a very long time.

For decades, any Red Sox fan would readily tell you about "The Curse of the Bambino" that haunted their team as a result of trading



As a St. Louis Cardinals fan, I am especially fond of a bad trade made by our rival, the Chicago Cubs, in 1964. That year, the Cubs traded Lou Brock to the Cardinals for pitcher Ernie Broglio. Broglio pitched another ho-hum season or two for the Cubs before leaving the game of baseball for good. Brock went on to star for the Cardinals for the next 15 years and helped them win two World Series titles during his hall of fame career...thanks Cubbies. This is simply one of several curses to haunt the Cubs over the years with no end seemingly in sight.

There are countless other examples over the years that stand out as particularly awful trades for one side of the transaction and no sport is immune to this infliction.

The Dallas Cowboys dealt all-pro running back Herschel Walker near the end of his career to the Minnesota Vikings in 1989 in exchange for numerous draft picks that would fuel the Cowboys dominance in the 90s. The Lakers have won five NBA titles with

Bryant thanks to a 1996 trade with the Charlotte Hornets for aging center Vlade Divac. In 1991, top hockey prospect Eric Lindros was traded to the Philadelphia Flyers in ex-

change for cash and several players that would all go on to help the Colorado Avalanche win two Stanley Cup

Bad trades rarely look bad on the day they are made and sometimes are impossible to grade until time goes by. When Mike Ditka donned a dreadlock wig and fired up a cigar on draft day in 1999, he did so to announce the Saints had agreed to trade every draft pick they had that year for the rights to running back Ricky Williams. He was a "can't-miss" prospect and the type of running back that could change the face of a franchise for years to come. While New Orleans had some good moments and fun times with Ricky, the experiment in hindsight caused more head-scratching moments than jaw-dropping plays for Saints fans.

While trades in the sports world can be difficult to predict but often easy to second guess, a few trades outside the sports arena that have been announced lately warrant our careful consider-

The most discussed example that comes to mind is the trade orchestrated between President Obama and the Taliban. In this one, the President traded five notorious terrorists from custody in Guantánamo in exchange for an American prisoner of war, Sgt. Bowe Bergdahl. Numerous reports have detailed the dangerous nature of these high-level terrorists and the likelihood they will rejoin the fight against America now that they are free. In comparison, mixed reports have surfaced about the intentions of Sgt. Bergdahl, the details of his capture and the level of appreciation he has for his country. Early reports seem to show this as a likely lopsided trade for the Taliban, but hopefully time will prove us wrong. For America's sake, I hope that is the case.

A less discussed example is another recent trade designed and announced by the Obama Administration. In this deal, memorialized by new regulations from the Environmental Protection Agency, the President's captive trading partner is the American economy. In exchange for new regulations on carbon dioxide emissions from power plants mandated from DC, the American economy will spend \$50 billion a year between now and 2030, according to a study by the U.S. Chamber of Commerce.

This is a trade that we do not need to wait long to see who got the better end of the

The U.S. Chamber study went on to state that these carbon regulations would lead to 224,000 fewer American jobs each year, increased electric costs by \$289 billion through 2030, and lower total disposable U.S. income by \$586 billion over that same time period. All the while, other countries will continue to talk a big game on climate while they do little more than watch the U.S. take self-imposed steps to bring our hard fought economic prowess back to the pack.

These trades come on the heels of other one-sided deals by this Administration, such as the time we traded our market-based healthcare industry for a government-driven model and the time we dealt our strong position with Russia in exchange for a weak one.

A lopsided trade can be fun in sports when you are on the better end of the stick. and even if not, it can be overcome with a little time. patience and luck. When it comes to America's economic and national security. the novelty of analyzing and debating risky trades is not nearly as fun.

Our nation's team. made up of the American people, is strong, resilient, and capable of playing at an extremely high level. At a minimum, we just need management to stop making harmful trades that strengthens our competition. Ideally, it is time for the President to make a one-sided deal in our favor, so that the American people can finally be empowered to lead us out of this lingering recession.

The solution is obvious. Next time, the President should simply propose a one-sided deal with his hometown Chicago Cubs. If history is any judge, I know we can pull a fast one on







Leaf galls begin to appear on azaleas, camelias

Leaf galls on azaleas and camellias are relatively common in Louisiana, especially in years with extended periods of cool. wet weather during the spring.

They can occur on leaves, stems, flowers and seed pods.

unsightly sometimes tesque, but they are not particularly serious, except on very susceptible cultivars. Leaf

deformities

These growth

symptoms appear soon after flowering and are quite apparent as the leaves become thickened with a fleshy or leatherlike texture and their shape is distorted that eventually become white and powdery as the fungus develops on the leaf surface and begins to produce spores.

Frequent inspection of the plants and removal of infected leaves when they first appear are often all that is needed to control this disease.

If large numbers of leaves are affected, prune the plants during late spring or early summer to remove the infected leaves and to stimulate new growth.

Also, be sure to rake up and destroy affected leaves that have fallen to the ground under the plants.

Fungicides, such as Captan, systemic fungicides and Daconil give some control of leaf gall when they are applied beginning at bud break and repeated every 10 days as long as environmental conditions are suitable for disease development.

So, we move on and


