She just needed to figure a way out of being broke. Simple math: Either make more money or cut back on spending. She needed to raise money to get out of this financial mess—the question was, how?

## **SMART MONEY LESSON: WHAT “BROKE” REALLY MEANS!**

In Sub-Saharan Africa, less than one percent are born into wealth and under ten percent are born into the middle class. In general, we are not taught in any formal framework how to keep money or grow it—basic personal finance skills are difficult to learn. As a result, even when a young adult starts earning more than they need to survive, they end up living from paycheque to paycheque because they think about their incomes largely in terms of spending and haven't learned how to save or build assets in proportion to what they earn.

Broke means, if you lost your primary source of income today, you wouldn't be able to maintain the lifestyle you have become accustomed to because you have no assets to rely on. Like Zuri, many people have built expensive lives they can't sustain because they continuously spend everything they earn and as such, have a revolving door for their money.



We must dismiss this idea that we will always make more money. We have a finite amount of productive years to work; many people will never be as agile both mentally and physically as they are now. What happens in thirty years when you can no longer work as hard and have no cushion to fall back on? Poverty and dependence on others is inevitable. In order to build wealth, this mentality has to change. Developing a wealthy mind-set requires the understanding of the concept that the way you spend, invest, and manage ten naira is the way you'll spend, invest, and manage ten million.

### **What it Really Means to Be Wealthy**

As a society, we tend to measure financial success based on spending patterns, but our metrics are faulty. For example, Zuri lives in one of the best parts of Lagos, has a decent job and lives a lifestyle that many dream of. Zuri is one of the hundreds of thousands moving up the income-earning scale, able to afford material things that were once out of their parents' reach. To a bystander, she has an enviable life and there's an automatic assumption that she is wealthy. However, building wealth is more about how much you *keep*.

Broke people and rich people approach the same amount of money differently and here's why: broke people think it is about how much you earn but rich people know it's about how much of your income you are able to keep and convert into assets that can provide you with an income in the future. The fundamental difference is that wealthy people understand the relationship between how we earn and how we spend and they know where the balance is.

Active income is the income you get from services rendered, it is usually your income from your job or business. For example, if you work at a bank and you make three hundred thousand a month as your salary, that's your active income. Or, if you run a catering business and you make three hundred thousand in profits every month that's your active income.

Passive income in simple terms is money that you make while you are sleeping. It is the income you get regularly from investments you've already made. Good examples are dividends from a stock portfolio, or rental income from a property you own.

## **What Is Financial Freedom?**

When passive income exceeds your expenses.

Ideally, the goal is to get to a point where the assets you've accumulated can pay you enough of an income to pay for your lifestyle. For example, rental income from a property you own can buy you a car or a holiday to the South of France. Or, the dividend cheques from your stock portfolio can buy you a Chanel bag.

## EXERCISE: NET WORTH

Calculate your net worth. Your net worth is your assets minus your liabilities and it gives you a snapshot of where you stand financially.

- 1. Make a list of everything you own of value (stocks, property, land, fixed deposits, cash, gold).*
- 2. Make a list of everything you owe (mortgage, car loan, general gbese).*
- 3. Subtract your total assets from your total liabilities.*
- 4. Don't be ashamed or afraid of the number. Calculating your net worth now will let you know your starting point.*
- 5. The figure is not as important as the trends in net worth. As long as you make a commitment to keep growing it, you'll be fine.*

## SMART MONEY LESSON

There's a lot of fear surrounding the way African women feel about money and the subsequent consequences of our relationship with money. When it comes to money in relation to our families, our businesses, our friendships, and society, many African women worry about not having enough to survive, not having enough to measure up to the lifestyle of our friends and family, the fear of failing in business, the fear of not being able to afford the lifestyle one has become accustomed to, then losing it all and becoming dependent on others.

Ultimately how we behave with money is deeply rooted in how we think about money and fear can be a very crippling thing; it can stifle you and stop you from taking action to achieve your goals but we must realise that fear is just an emotion. It is worrying about something that has the possibility to occur in the future. Unfortunately, this fear can be paralyzing. So sometimes instead of confronting and facing those money fears, we hide from them and avoid them.

However, confronting our fears is always the right step toward conquering them.

What you deny or ignore, you delay; what you accept and face, you conquer. At the end of the day we are all afraid of something but the difference between successful people and average people is that they acknowledge their fears but don't let fear overcome them or stop them from achieving their goals.



## EXERCISE: CONQUER MONEY FEARS

1. *Make a list of all your money fears.*
2. *Think about why you have this money fear in the first place. It might be rooted in money habits that you already know are bad for your finances. For example, having expenses that are so high they consistently exceed your income each month, so you know it's not sustainable and there's a voice in the back of your head that tells you you're living beyond your means, hence the fear of not being able to maintain your lifestyle.*
3. *Make a plan to counter each fear. The reason we usually allow fear to take over is because we don't have a plan and are uncertain of what will happen in the future. There is nothing that gives you confidence like having a detailed plan to conquer that uncertainty.*

## CHAPTER 3: WHERE IS YOUR MONEY GOING?

It was a Saturday morning, the day Zuri had set aside to begin the process of tackling her financial situation. A track from MI's new album was blasting from her iPod speakers.

*'Tlekun a si,*

*Iṣe owo mi fi alubarika si,*

*Everything we dey face right now go turn story,  
We will all be rich,  
We will all be rich.*

*From cooking with kerosene, to the back of limousine,  
Going where we never been to seeing things we never  
seen.*

*From buying food inside newspaper to the front page of  
magazines,*

*...when they see you tomorrow they won't recognise  
that they've seen you before,*

*...I'm wishing you money; I'm wishing you wealth.*

She danced around her apartment and sang along to the words. *My ginger is on ten!*

It was odd, but the words from the song gave her hope. Hope that even though she didn't have a clear plan to pay off her debts and find financial stability, she would figure it out eventually because she was motivated.

She had decided to deal with this financial situation the same way she would tackle a task at work—logically! As she sorted through the paper bag that acted as a filing cabinet for all her bank statements and service charge bills, she puzzled over where exactly all her money had gone. She earned about six hundred thousand naira a month, which frankly was a lot of money and way above the average Nigerian salary. So, where was it all going? What was she spending it on?

As she rifled through the bag she noticed that most of her bank statements were unopened. It dawned on Zuri: she'd been supremely careless with her money for an incredibly long time. There had been months at a stretch she hadn't even checked her bank account. The statements she *had* looked at, she'd only paid cursory attention to.

She sorted through the statements, arranged them according to dates and used her highlight pens to categorise her spending. Blue for meals, pink for accessories, green for her car, and so on and so forth.

As she pored over her financial life, she came to an even more depressing realisation: she had always been afraid of her bank statements and she hadn't wanted to admit to herself how precarious her life really was. Subconsciously, she'd always known she was spending mindlessly but never wanted to confront her spending habits because it made her uncomfortable.

She told herself that she worked hard and earned good money so she deserved to splurge once in a while, but what was evident from this exercise was that she indulged all the time. Damn! She couldn't believe how much she spent alone on dinner and cocktails with the girls at RSVP and Spice every month!

An exhausted Zuri sat back and stared at the now neat stacks of paper on her dining table. She'd spent hours analysing the statements, trying to make sense of the numbers. It was painful but eye-opening. In fact, she had a new philosophy: if you want to truly know a person, look at their bank statements. Apparently, the picture her bank statements painted was that she was an obese alcoholic with an unhealthy bag addiction, who owned enough *aşo-ebi* to open her own mall. *Who is Ria and why did I pay so much for her aşo-ebi for goodness' sake?*

But that wasn't who she was, was it? Why then, did the money she had spent not reflect her values?

She had decided the best way to make sense of everything was to put all the data she had collected under her six biggest spending categories: rent, utilities, food, transportation, wardrobe, and other, and began to make sense of them in relation to her annual income of about seven point two million.

The two point five million she paid annually for her two-bedroom apartment was easily her biggest expenditure. She had read an article once that described Lagos as one of the most expensive cities in the world and she couldn't agree more. The unspoken success and wealth connotations of living on “The Island” had made Phase I one of the more desirable parts of town. Even though she loved living there she couldn't help but think she was living in an upmarket ghetto. The bad roads, inefficient power supply, and the sometimes filthy water was not exactly high-class living. Luckily, she was only paying a year's rent upfront; most Nigerians had to pay two.

## **SMART MONEY LESSON: TRACK YOUR EXPENSES**

Most people don't know where the money they earn goes. What percentage of your income goes to food? Transportation? Clothes? Just like in any successful business where you track the revenue and costs periodically, it is also important to track the expenses in our personal lives. Nigerian women have to become the CFOs of their financial lives and learn to take control of the income they earn now, instead of waiting for their incomes to increase in the future before they learn to manage money.

Some women have no idea how much their lifestyle costs. She may not spend recklessly, but she subconsciously develops a habit of spending—good or bad. If you don't treat the money you earn with respect, it will leave you with no respect. We have to learn to spend with intention by allocating our resources to reflect the lifestyle we want and are able to sustainably afford. This all starts with having a clear idea of where the money is going in the first place. You have to give

up the excuses and learn to control money instead of letting money control you.

## EXERCISE: TRACK YOUR SPENDING

1. *Write down everything you spent your income on in the last month. This will give you good ideas of how you are spending money and help you identify areas to cut or increase.*
2. *Review your bank statements from the last twelve months.*
3. *Separate your findings into wants and needs. Limit your wants and prioritise your needs.*
4. *Identify three to five things to cut each month that would make a significant impact. Review what you are spending on things like your phone calls and food because these are examples of things that are important but we tend to spend on mindlessly. Assess your spending in these areas and set spending limits.*
5. *Spend on the things you love and cut expenses ruthlessly in the things that don't matter to you.*

## **EXERCISE: UNDERSTAND YOUR DEBT AND DEAL WITH IT**

1. *Acknowledge the total amount of your debt by making a list.*
2. *Set a repayment schedule that includes how much you owe each person or institution.*
3. *Prioritise your debts. Decide which ones are most important. This depends on your particular situation—you could slay the largest debt first to give you more confidence that the rest are manageable, or you could decide it is best to start with the debt charged with the highest interest rate, so the debt does not increase. Otherwise, it's best to pay the one with the most imminent wahala (in Zuri's case her landlord was hounding her and further non-payment could have led to eviction).*
4. *Set deadlines for each loan. There should be an estimate of how long it is going to take you to pay off each debt.*
5. *Decide how you plan to raise the money*

*to pay. For example, deciding to cut your outflow to create room in your budget every month towards paying down your debt, finding another source of income or selling off valuable items you don't necessarily need are all options to consider.*

- 6. Think about the triggers that led you into debt in the first place and try to eliminate them. There's no point getting out of debt only to dive back in.*

## **SMART MONEY LESSON: BUILD AN EMERGENCY FUND**

We live in a very superstitious society. So, even when we hear the terrible stories of people losing their jobs, or women losing the bread winners of their households suddenly, then forced into relative pennilessness because they can no longer afford their rent and have to beg friends and family for money to pay the children's school fees, we think 'God forbid not me'. A smart woman doesn't wait for financial surprises; she systematically saves toward her emergency fund because she knows that this is the foundation of her financial journey. The cushion that acts as a financial safety net, so before you splurge make sure you have at least six to nine months of living expenses saved up for emergencies. An emergency fund is not there to make you money but to act as a financial cushion that protects your long term investments from

short term unexpected expenses.

## **EXERCISE: BUILD AN EMERGENCY FUND**

- 1 Calculate how much you would need to survive if you lost your job or income from your business. What do your living expenses add up to each month? Multiply that by six or nine months. Factor in things like rent and utilities.*
- 2 Strictly define emergencies. Your car breaking down or having to pay an unexpected hospital bill qualify as emergencies. A phone upgrade, an impromptu trip to Dubai or those YSL pumps on sale do not.*
- 3 Shore up your emergency fund with windfalls like cash gifts, bonuses or extra work done. i.e. when you get money you were not expecting, commit to using a percentage (at least 20%) of it to top up your emergency fund.*
- 4 Don't put it in a risky asset class, i.e. stocks. It is not there to make you money.*
- 5 The most important elements of an*

*emergency fund are liquidity and safety, not return, so do not take risks to earn more or sacrifice liquidity.*

- 6 Look for high interest savings accounts or money market accounts that preserve your capital and give you a reasonable return.*

## **SMART MONEY LESSON: DEVELOP A SUSTAINABLE BUDGET**

One of the biggest issues people complain about when it comes to their money is not knowing how to save or budget. People associate the word “budget” with scarcity or a reduction in station of life. Therefore, “budget” is a word they come to resent. The reality is, a budget is something that tells you how to allocate your resources and it should reflect what you value. So if I looked at your bank statement, would it reflect that you are spending on the things you love or would it be a reflection of the fact that you don't spend intentionally and allow your money to be pulled in different directions?

The reason most people live paycheque to paycheque is because they don't have a full understanding of what their income can support. Money in the bank is equal to spending. It doesn't matter whether you earn ten thousand or ten million naira a month, your resources are limited and consumption tends to rise with income, so it's important to have a spending plan that takes that into

consideration.

So here is the trick for guilt-free spending: the smart money budget! I know the idea of a budget makes most people nervous, but it shouldn't, especially if it's easy and reflects the things you love. The smart money budget is a way of allocating your resources.

First, divide your income into three parts:

- Long-term financial goals
- Short-term financial goals
- Living expenses

**Long-term financial goals (LFG):** At a minimum of twenty percent of your income, it represents a proportion set aside towards improving your net worth, i.e. buying assets that will provide you with an income. Good examples are towards purchases like land, property or a stock portfolio.

**Short-term financial goals (SFG):** The proportion of your income set aside for treats — a Chanel bag, an iPhone, or a luxury holiday; whatever tickles your fancy.

**Living expenses:** Your monthly contribution to your rent, health insurance, cable/satellite television, petrol, service charge etc.

Here are two examples of how differing incomes might look distributing a salary.

**Lara:**

Monthly income= ₦3,000,000

LFG (20%) = ₦600,000

SFG (10%) = ₦300,000

Living expenses (70%) = ₦2,100,000

**Zuri**

Monthly income= ₦600, 000

LFG (20%) = ₦120,000

SFG (10%) = ₦60,000

Living expenses (70%) = ₦420,000



## EXERCISE: ORGANISE YOUR MONEY

### Create buckets for different goals

1. *An account for emergencies because you never know when your car is going to break down or when you have to send money to the village.*
2. *A 'turn up' account, because we work hard so we can play hard. Otherwise you'll be setting yourself up for overspending, which will jeopardise your financial freedom in the long run. (This could be for shopping, traveling, anything that makes you happy). Planning for it means you spend mindfully and within a budget, instead of impulsively.*
3. *An account for rent because it's easy to procrastinate and wait three or four months before the 'gbese' is due and then start panicking and borrowing. It's always better to have an account dedicated to this that you put aside systematically each month (this works*

*for school fees as well).*

4. *An investment account because there's no point in working hard, year after year, earning three million naira a year, spending it all and then your net worth is one hundred and fifty thousand. It's best to systematically put aside a proportion of your salary toward building assets that will earn you an income.*
5. *An account for bills because Nigeria is expensive— this covers food, domestic staff's salaries, transport costs etc.*

Leads Africa on Instagram because of their focus on women and business. People are doing things on social media that are really changing how people connect.

“I just had a conversation with a girl and she said '*Dey dere... Instagram is life*', and the people who don't get that are just like the people in the nineties who said that the internet was the big bad wolf and would destroy us. I had to laugh at that one, but maybe she has a point, you know. Social media is the new way we interact. Not just with our friends but it's how we showcase our products, acquire customers and grow our businesses.”

“I hear you! But before you interrupted me, I was about to tell Zuri that I met Nimi Akinkugbe. She's basically a personal finance rock star! She used to be the head of wealth management at Stanbic IBTC for ages, then left to join Barclays Wealth, now she's the CEO of Bestman Games, the company that brought Monopoly to Nigeria. She is so well-spoken and so proper. I'm obsessed! Anyway, she suggested we go to the Money Makeover breakout session that's about to start,” Lara said.

To get started, I'd like us all to introduce ourselves, say what we do for a living, share what we are deeply passionate about and share the main reason we chose to attend this breakout session.”

“So we all want to be rich, right? Let's talk a little bit about the things we believe are stopping us from attaining wealth. Impulsive spending? Not enough money? Too many bills? She may even be contributing a significant amount to the household, to rent and school fees. They are great things to save towards but they also aren't assets, so once that money is paid, it's gone. We don't put as much weight on building assets that will provide us with an income in the future and protect our financial future because 'it is a man's job.'”

It was a great session and Zuri loved that Omosede had taken the time to lay out a thorough 'game plan' that allowed for focus and direction without being too complicated. ## **SMART MONEY LESSON: YOUR NETWORK IS YOUR NET WORTH**

Having an extensive network allows you to maximise your potential. There are no level playing fields, but it can be argued that in Nigeria the field is a little more uneven. A person's ability to attract wealth is tightly linked to how well they are able to grow and leverage his or her network to take advantage of opportunities.

The operative word here is “leverage”. Lots of people from wealthy backgrounds have parents who lunch with some of the country's most powerful men and women, but they are unable to leverage those connections—combined with their talent—and translate it to money. On the other hand, plenty of folks who came from less privileged backgrounds have been able to parlay their way into certain circles by virtue of the value they add.

Mentorship is an awesome way to build your network and accelerate your personal growth, but instead of having the 'Aunty, *epp*

me' approach, it's better to try to build organic relationships. You want a mentor who is invested in your growth and genuinely wants you to succeed. This is more likely when you have built a relationship and they become genuine friends as opposed to a transactional relationship that feels obligatory.

Okay, I know conventional wisdom at networking events is usually '*sell ya self, sell ya market*', but take a minute to think about the fact that a thousand other women are doing just that. So, *what* makes you different? I can't tell you how many conversations I overheard that started with, 'My name is XYZ, I'm into Brazilian hair' or 'I'm into fashion. The concept of my business is *blah, blah, blah*'. Let me tell you a secret. They'll smile, they'll nod, they'll even take your business card but girl, no one cares about your CV or business concept for that matter! You know why? It sounds rehearsed, and limits chances for genuine conversation.

Instead of talking about yourself, ask questions about the other person, find common points of interest and then work interesting tidbits about yourself into the conversation.

Elevator pitches are important, but people are more likely to connect with you if you can sell them on your 'why' as opposed to what you do. For example, instead of saying, 'My name is Anire and I make smoothies—we have apple, strawberry and pineapple flavours', try saying, 'I used to be so depressed about my weight but last year I lost fifteen kilos with a smoothie-inclusive diet and decided to start a business that will help other women like me lose a ton of weight'. You are probably going to be more memorable this way.

The business or job opportunities you'll have access to will come from your ability to harness your network and learn how to convert that network into opportunities because the more people you are able to reach and influence, the more likely you are to attract new business, gain access to partnerships or raise funding for your business.

## **SMART MONEY LESSON: THE CONVERSATION ABOUT FAMILY FINANCES MUST BE HAD**

In Africa, discussions of money and assets in a family in the context of what happens when the breadwinner dies are almost taboo, and as a result this leads to disputes within families when the inevitable happens. We need to have more conversations about estate planning and wills. In simple terms, how assets will be divided in case of death and who the beneficiaries are. Women need to start asking tough questions about life insurance, debt, deeds, brokerage accounts, trusts and in general where financial records are kept, who is on the next-of-kin form et cetera. In the event where the woman has no formal occupation and no income of her own, she is protected. It is better to be prepared beforehand than to wait for tragedy to occur before these discussions are had.

In addition, when couples are coming together money matters should be a well-considered part pre-marital counselling. A

discussion about the expectations of each person's responsibility is critical. We all come from different backgrounds and carry our own money biases and habits, and we often assume a synergy with our significant. For example, Sade and Femi get married and live together for the first time. Sade comes from a home where her mother was a housewife and her father the provider, so even though she works for a living her notion is 'my money is my money, and Femi's money is our money'. If Femi comes from a family where both parents contributed equally to the household and believes strongly that Sade should contribute to the household expenses, without a proper discussion, this can cause significant problems.

There is also the issue of understanding each other's money personalities; establishing who is the saver and who is the spender early on and to protect both parties. It is probably best to keep personal finances separate but have a joint account for household expenses with pre-agreed amounts that each person contributes.

like, *why bother?* When my five hundred thousand sits in the account for ninety days and all I have to show for it is a measly thirty thousand naira—what's the point?”

Omosede nodded knowingly as she jotted some notes down on a legal pad. “Don't worry, I know the kind you mean. The thing is, you have to have a more patient attitude to investing. The typical Nigerian is looking for that next big deal to make a killing. They want to 'hit', so if someone is talking to the about investment opportunities with a four percent return they say, 'what's the point? It's too small', but the point of that kind of investment is compounding interest—basically making interest on interest already earned. The key is to start early and stay consistent.”

“That makes more sense. The interest earned is added to the original amount and earns interest of its own, and so on and so forth, right?” Zuri said contemplatively.

“Right. Obviously, there are other asset classes—better known as investments—that may have a higher return but with more risk. So I take it you've never invested in stocks before?” Omosede said with a wry smile.

“I've heard too many horror stories. In fact, my friend's father lost a lot of money in the Nigerian stock market in 2008 so I've always been too scared. The idea of stocks or bonds just sounds convoluted.”

“They are really not as complex as you think, but I'll

“I know people typically measure financial success by how much they earn—the income they get in salary

However, your net worth is the true measure of how wealthy you are, because building wealth is ultimately not about how much you earn but how much of your income you are able to convert to assets that can provide you with an income in the future. Are you with me so far?” Omosede asked.

“Yes, I think so. So you mean how much of my income I can convert to assets like property and stocks. That kind of thing?” Zuri replied.

“Yes. Exactly,” Omosede said

Zuri showed her frustration, with a situation that felt very unfair. “But property is so expensive. And stocks are so risky! For example, the flat I live in costs about seventy million and it would probably take me forever and a day to buy! This is the problem I've always had with all this investing stuff. “Girl, slow your roll,” Omosede smiled. “This is the part I find amusing. People will go from zero to a hundred in a flash. Lekki Phase I? You didn't even say Ikorodu! Let's just take baby steps and start with areas your income can support.”

Zuri laughed too. “Right. Where should I start?”

“You work in real estate so you are aware of growth areas, like along the Lekki-Epe expressway. They are much more affordable and have immense growth potential. There are a few real estate companies we work with who offer payment plans for much cheaper real estate opportunities. Even though it's pretty far from the main city in terms of distance, that area is going to blow up in the next five to ten years.”

Chichi has been looking for ways to make money, outside of her salary, so she goes ahead and also invests the money she had been saving in XYZ stock.

“Most people tend to make the mistake of saying, *Mr Lagbaja made this investment and made a killing, so I'll make it too*. This 'me too' approach to making an investment decision is what often leads to a lot of people losing money, because they didn't take the time to really look at how they were investing. Amaka and Chichi may earn the same monthly salary but their circumstances are different.

“Amaka is twenty-five, lives with her parents, and has little or no obligations. Her expenses for the month mostly comprise of fuel for her car and credit for her phone.

“By choosing to buy stocks, she is buying equity or a fraction of ownership of the company. It's a relatively high-risk investment, but historically it gives better

returns in the long run than other types of investments or asset class. The longer her money is invested, the higher the average rate of return. Since she has zero to no obligations and age is on her side, she can afford to take the risk of investing a huge portion of her earnings in the stock market in the long run. Clear so far?”

“Yes, it is.”

Omosede continued, “Chichi, on the other hand, is thirty-two and married with two children under the age of seven. Her husband's income is inconsistent; therefore, she has a great deal of financial responsibility. She is partly responsible for paying rent and school fees. Chichi had been saving that money towards those payments, but was looking for “faster” ways to grow her money. This was a bad move because if the price of XYZ stock goes down, so will the value of her investment. Since she needed the money in the short-term, this was not a good investment to make for her situation.”

Zuri realised what Omosede was trying to teach her. “I think I see where you are going with this. So basically what I invest in depends on why I'm investing and where I need to be with money and cash flow.”

“Exactly. So let's talk a bit about what your investment goals are. Why do you want to invest?”

Zuri knew exactly what she wanted. The last few

months had been a wakeup call. “I want financial security. I want the money I make to translate to something bigger in the future. And, I want to make enough money to maintain my lifestyle.”

“You have to get a little bit more specific,” Omosede said.

“Well, I'd like to own property and start building a stock portfolio, but I would also like to go on holiday. And I need a new car,” Zuri rushed out in one breath.

Omosede smiled. “Here's the thing. You have to make choices, prioritise, and start slowly. Your resources are limited and you still have rent to pay. You'll eventually be able to do them all, but not all at once. For example, you probably can't afford to save and invest towards a car and a holiday at the same time on a salary of six hundred thousand, but we can start working towards those goals.”

“Baby steps. Got it. So, how do I develop an investment strategy? It sounds complex.”

“It really doesn't have to be. It's basically a fancy way of saying this is *how* you'll approach achieving your goals. It doesn't have to be complicated; you just set benchmarks. It could be as simple as saying to yourself, *I want to own property in the next five to ten years. I have found land that costs one million. So I will put twenty percent of my income in a money market fund*

*towards reaching that goal. When I've bought the land, I'll start investing that twenty percent in a mix of stocks and treasury bills until I have two million to put towards developing the property.”*

Zuri was now officially an Omosede fan. “Can I just say I'm obsessed with you? You make this stuff so easy to understand.”

She smiled at the compliment. “I try,” Omosede said. “The thing is, ideally what we want long term is for you to build a diversified portfolio and decide your asset allocation.”

## **SMART MONEY LESSON: A FEW THINGS TO CONSIDER BEFORE YOU POP YOUR INVESTING CHERRY**

The world of investing might seem daunting, but like learning a new skill, it takes time and patience to understand. Here are my thoughts on how to start investing in Nigeria.

### **Know Your Asset Classes/Types of Investments**

**Stocks:** I can't count the number of times I've heard 'I don't do stocks'. Granted, the level of risk involved is not for everyone but the stock market can be your friend, especially if you are young. The Nigerian stock market lists stocks of some of the best companies this country has to offer and the criteria that has to be met for companies to be listed mean that they have been thoroughly vetted, so they have corporate governance and audited accounts. If you can take the risk of investing in your friend's fish farm, you can take the risk of investing some of your long-term savings in the stock market.

The saying 'No one ever got rich from a savings account' holds true now more than ever, because the value of cash decreases over time due to inflation, currently about 15% in Nigeria. It is important to understand that even though stocks are volatile in the short run, they've historically risen in value in the long term.

I am passionate about the growth prospects of the Nigerian stock market. I believe it is a solid platform to build long-term wealth. In the words of Warren Buffet when it comes to investing in stocks, “Be fearful when others are greedy and greedy only when others are fearful.” Since people are wary of the Nigerian stock market, it is a good time to research and invest in good companies that are undervalued.

**I do not believe in borrowing money to buy stock, nor do I believe that the stock market is a money doubling scheme,** which was the motivation for many people's investments in 2007, when the market was at its peak. That is an easy way to get burnt, but I believe in systematically using money you can afford to forget about to build long-term wealth. i.e. money you would have used to

go shopping or buy credit for the month, not your money for rent or school fees.

The cardinal rule when you invest is, *don't invest in anything you don't understand*. You should always do some research, ask some questions. Here are a few tips to get started:

- *Subscribe to proshare ([www.proshareng.com](http://www.proshareng.com)).*
- *Pick a few stocks from different sectors to research.*
- *What do you like about the companies as businesses? What are the fundamentals behind them?*
- *What are the growth prospects of the company in the current economic climate? Do they have any durable competitive advantage?*
- *Do some research on the companies past performance, historic price, dividend yield, and liquidity of the stocks?*
- *Speak to an investment adviser or stockbroker about your findings.*

**Real estate:** An investment in real estate in Nigeria is mostly always a good idea. It's a great long-term investment with medium risk, decent cash flows and a reasonable expectation of an increase in value,



especially in growth areas. Real estate investments include residential rental property, raw land, or commercial (business) real estate.

An investment in real estate does have some distinct risks. It is possible for property values to go down as well as up, so you could lose some of your investment principal (the initial amount of money invested). Most of all, real estate is not a "liquid" investment—it may be hard to sell the property when you want to, leaving your money tied up when you need it.

That said, real estate is a great asset to have and most people know this, but are deterred from entering the market either because they think it's too expensive or are waiting to 'hit' so they can build their own house to live in. However, it's better to find something that's in your price range and just START!

**Mutual funds:** A mutual fund is an investment vehicle that is made up of a pool of funds collected from many investors for the purpose of investing in securities such as stocks, bonds, money market instruments and similar assets. Mutual funds are operated by money/fund managers, who invest the

fund's capital and attempt to produce capital gains and income for the fund's investors.

The advantage of this is that an investor no longer has to worry about the day-to-day administrative issues that come with making investment decisions as this is passed on to a professional fund manager. It gives small investors access to a professionally managed diversified portfolio. Mutual funds in Nigeria are mostly open-ended and affordable, which mean that you can start with as little as ten thousand naira and liquidate at market value when you want to.

**Money market instruments (i.e. Treasury bills):** Money market instruments are basically short-term securities like treasury bills (money you lend to the government) or commercial paper (money lent to institutions). Treasury bills are more common and arguably more secure.

You cannot bid directly for treasury bills; you have to go through a broker, your bank or a finance house. Nigerian treasury bills are usually sold bi-weekly, and upcoming primary auctions are usually reported in the financial section of national newspapers. The CBN also publishes a quarterly treasury bills auction calendar on their website. The

interest rate is not fixed but fluctuates based on demand (volume of bids) and supply (amount offered by the central bank).

Alternatively, you can look into investing in a money market fund. This is a specific type of mutual fund that invests in money market securities. It preserves your capital, pays you a return that's comparable to prevailing money market rates in Nigeria

### **Establish Your Investment Goals**

The crucial question is, why are you investing? This may be a more difficult question to answer than many people realise, because they haven't fully articulated what they want their money to do for them. Are you putting money aside toward rent? A car? Retirement? Building assets? The reason you are investing will determine what kind of investments you make.

For example, if you were investing towards your rent next year, the worst thing you can do is say, "Let me invest my savings each month in the stock market." Stocks can be very volatile and your capital might be lower in value when you need it the most. A money market product or treasury bills

might be a better option. However, if you were working a nine-to-five job and were saving towards a business you plan to start in five to ten years, then the stock market could be an option.

There are no right or wrong answers. Your investment goals should reflect your financial obligations, what you value most, and what you want the money you make to be able to do for your life in general.

### **Develop an Investment Strategy**

It is important to write down your investment strategy to clearly articulate your thoughts. Once your strategy is written, you should ensure it matches your long-term investment goals. Writing down your strategy gives you a plan/guide to refer back to in times of chaos and help you avoid making emotional decisions. It also gives you something to review and change if your investment goals change or you start earning more money.

It doesn't have to be complicated. Even if you think what you have to start with is too little, begin with a savings account and start building it up. You can give yourself

benchmarks

Here is an example.

### **Ivie**

Goal: Buy land

20% of salary deposited in savings account until ₦200,000 is saved

Take ₦200,000 and split: ₦100,000 for fixed deposits, ₦100,000 for stock portfolio. Repeat until fixed deposits reach target amount.

When fixed deposits = ₦1 – 1.5 million range, buy land in Awoyaya.

If possible, sit down with an investment advisor and discuss those goals and financial obligations you've mapped out so that they can match your goals with the investment products or asset classes best suited to your lifestyle.

If your goal is to build a house in five to ten years and your financial obligations include paying children's school fees and rent, you will want an investment advisor to match your goals with products and asset classes that will help you attain them.

### **Determine Your Risk Profile**

When people ask me about investing, one of the most recurrent themes is the need for high returns. “My money is in my savings account and it's giving me little interest. What can I invest in that will keep my money safe but grow it very fast?” It doesn't work that way. You can't have both low risk and high returns. Simply, a lower risk investment has lower potential for profit. A higher risk investment has a higher potential for profit but also a potential for a greater loss.

You've heard that saying, 'No risk, no reward'? There is a strong correlation between risk and return. The investments that offer the highest return in the long run also come alongside a healthy measure of risk. For example, if you have one hundred thousand naira and you put it in a savings account, treasury bills or buy XYZ stock. Chances are in ten years your XYZ stock (through capital appreciation and dividend yield) will be worth more than savings or treasury bills. However, because stocks are volatile in nature your XYZ stocks could also be worth less.

**A conservative investor's** primary objective is to preserve the capital and receive regular

income. They have a low tolerance for risk and hence a major chunk of their investment would be allocated to debt or money market mutual funds.

A **moderately aggressive investor** is the one who is willing to take controlled risk for moderate returns. Such investors are generally recommended a mix of balanced portfolios.

**Aggressive investors** consider risk as an opportunity and leverage their experience and knowledge to take intelligent financial decisions. The major share of their investment, therefore, goes to growth and equity schemes.

### **Pick an Investment Firm**

Now, you are ready to invest! Doing your own preliminary research on what investment options are available to you in Nigeria is great but the reality is no matter how skilled you are in your business or line of work, you may not have the skill or patience required to pick the best investments for your situation. It's important to speak to a professional to guide you. Commercial banks offer some great savings

products but an investment firm gives you a wider range of investment options that include stocks, bonds, real estate and other investment opportunities.

At this point, you should have a clearer idea of what your investment goals are, your financial obligations, how much you have in your budget to invest and a fair idea of your risk profile. With all of this, I think you are armed with enough information to begin a conversation with an investment professional.

Knowing what you want to achieve is key so that nobody can '*wele*' you into investing in products or assets that are not in line with your goals. Even though they are professionals, don't let them dismiss your concerns or questions. Whether you are investing one hundred naira or one hundred million, *na* your money! You have every right to ask questions, and you should. Remember the cardinal rule: do not invest in things you don't understand.

## **MOMENT OF TRUTH**

Some investment firms will try to sell



you on a product that might not be right for your particular financial situation based on their own self-interest (if for example they have a mandate to sell the rights issue for a particular stock or they are getting commission from selling a particular product). This is why it is extremely important to be clear on your own investment goals and why you are investing in the first place, so they can appropriately match your goals to the products they have available. Make sure you choose a firm with a track record and an investment advisor you can honestly talk to about your financial situation.

Knowing what you want to achieve is key so that nobody can '*wele*' you into investing in products or assets that are not in line with your goals. Even though they are professionals, don't let them dismiss your concerns or questions. Whether you are investing one hundred naira or one hundred million, *na* your money! You have every right to ask questions, and you should. Remember the cardinal rule: do not invest in things you don't understand.

# **QUESTIONS YOU SHOULD ASK YOUR INVESTMENT ADVISOR**

## **INVESTMENT STRATEGY**

What is their asset allocation strategy? what will they be investing your money in, stocks? Bonds? Real estate? How diversified is the investment/fund/product? What is the asset allocation mix/ratio (i.e. the product invests in stocks, bonds, real estate and treasury bills proportions for example, 10:20:40:30)?

## **RISK**

Talk to them about how much risk you are willing to take on. With some investments there is a possibility of losing a portion of your principal. Although the returns on these types of investments attract better returns, ask yourself if your lifestyle would change if the value of your principal investment went down. This would determine how much risk appetite you have.

## **PROFITABILITY**

What are your expected returns on the investment? Are the returns guaranteed or is there a possibility of a reduction if the

market conditions change?

## **LIQUIDITY**

How much access do you have to the money invested? So if you decided to liquidate the investment prematurely, will there be any penalties? If so, how much?

## **TENOR**

How long is your money locked in for? You don't want to invest money you may need soon in a long-term instrument.

Even if they do, don't give up just find a way to reframe the problem, make your argument stronger and re-present it. Once Mr Tunde says yes, you can find a reasonable way to tie in your own compensation. If it's tied to performance it will be a relatively easy sell.”

## **SMART MONEY LESSON: MAXIMISE YOUR EARNING POTENTIAL BY FOCUSING ON FINDING YOUR PURPOSE**

Nine out of ten times when people ask how they can make more money my answer is find your purpose. Yes, it sounds trite, but this is a basic truth.

Your purpose is your calling; the thing that drives you to be successful because it is what you were created to do. It sits at the centre of three aspects of your life:

**Skill-set.** The things that you are good at, either because it's what you've studied or something you've spent hours honing.

**Passion.** People often confuse this with the things they like doing. It is that idea that burns deep inside you, so much so that you can't stop thinking about it until you execute. I like to say it makes you feel like you are pregnant with ideas.'

**Earning potential.** Your idea has to solve a

problem that people will be willing to pay for.

People are complex, so it's possible to be called to several things, or for your purpose to evolve. An article written by Fred Swaniker of the African Leadership Group explains purpose best: to determine if something is your purpose, it must answer three questions. “Is it big enough (Which speaks to impact)? Are you in a unique position to make it happen (What skills or resources do you have or have access to execute the idea)? And are you passionate enough about it (does it pass the sleepless night test)?” He explains that if the answer is yes to all three, then it is probably your calling.

When it comes to earning money it's important for people to understand purpose because, they often pursue an idea and then can't follow through on because they haven't thought through those three questions.

You can earn money from a side business, side deals, investing, and passive income but ultimately the mechanism with which you primarily and actively earn an income plays a huge role in determining how wealthy you

become. The more money you can generate from the mechanism you choose, will determine how much you have to invest in a side business, stocks etc.

So how do you earn more? The most popular answer these days is become an entrepreneur, start your own business. I have seen lots of articles and memes on Instagram and Twitter that say, 'If you don't follow your dreams, you'll end up working for someone who did', which is fair enough, if a bit of an over-generalisation.

In order to maximise your earning power and have the ability to invest, you need to pursue a career you are passionate about and create multiple streams of income. This does not necessarily mean you have to become an entrepreneur. The reality is, not everyone is cut out to be their own boss and you need to learn this early on. Being a boss is not about working for yourself and avoiding the discipline of a nine-to-five.

There are two ways to be stuck (and you don't want to be stuck in your thirties or forties):

- 1) Stuck in a 9-5 job you hate, and
- 2) Stuck in an entrepreneurial role you

cannot handle.

## **Are We Glamorising Entrepreneurship?**

Just ten to fifteen years ago in Africa, becoming financially successful and making your parents proud generally meant that you had to become a doctor, lawyer, engineer, accountant and maybe even an investment banker. Pursuing a university degree then deciding to become an entrepreneur would have caused mayhem in most Nigerian homes. You were expected to choose a profession, work hard at it, then scale the career ladder to success. However, with the scarcity of 'good' jobs and unemployment on the rise, starting a business has become the new normal for many graduates. In fact, entrepreneurship has become one of the most sustainable ways to solve Africa's unemployment problem. However, are we glamorising it to the detriment of our long-term success?

Three things we should probably reconsider:

- 1. Selling the idea that entrepreneurship is the ONLY guaranteed way to success*

I can't count the number of times I've heard, 'If you don't follow your dreams, you'll end

up working for someone who did' or 'No one ever got rich working a nine-to-five'. These are overgeneralisations that have consequences because the fact is, not everyone is cut out to be an entrepreneur. Plus, if we all become our own bosses who is going to work for whom? Who will be the employees?

It is wonderful that non-traditional avenues to earn money have opened up in the form of entrepreneurship, but why do we always have to have two extremes? Mark Zuckerberg is the founder of Facebook, but Sheryl Sandberg Facebook's COO and author of 'Lean In' (which has helped millions of women around the world in the work place) is not just an employee. Just because she isn't the founder of Facebook it doesn't make her less important because she focuses on being a value-driven individual. To paraphrase Dustin Moskovitz, if you joined Facebook as employee number one thousand, you would still have made roughly twenty million dollars.

Shouldn't the focus be on encouraging people to be entrepreneurial in their thinking whether they work in a corporation or run their own business? People who are

entrepreneurial in their thinking are value-driven. They adopt critical thinking and embrace innovation and continuous improvement. They are the ones you see solving problems every day and are getting paid to do so regardless of whether they are the founders of the company or not.

*2. Are we choosing entrepreneurship for the right reasons?*

With entrepreneurship growing in global popularity, everyone wants to be a boss. Many graduates don't even bother joining the rat race anymore; they come out of university saying, 'I don't want to work for anyone. I want to be my own boss'. A good proportion of those already on the corporate ladder can't wait to jump off and start a business so that they too can escape.

The thing is, becoming an entrepreneur isn't about avoiding the discipline of a nine-to-five job or jumping into the next “it” industry because other people seem to be making money. Becoming an entrepreneur is about finding a problem that you are uniquely placed to solve and that people will pay you for. You shouldn't be thinking about a “me too”, copy and paste approach because

the idea of working for yourself sounds appealing. The thought process should be, *what skills or resources do I have to execute that idea? Am I passionate enough about it to pursue it and follow through?*

### *3. The myth that good ideas are the key to business success*

We live in a world where the future of success is touted as becoming an entrepreneur, so the focus of most graduates is to be the next Elon Musk or Sara Blakely and create the next Tesla or Spanx. The thought around this is powerful, but it is not the full story. Ideas are a dime a dozen; execution and the ability to solve a series of problems is the actual key to success.

Becoming an entrepreneur means you are responsible for an enterprise and beyond the idea—a successful enterprise has to have structure, a business model and a value proposition. Instead of over-glamorising either end of the spectrum, let's focus on encouraging people to be value-driven. solve problems where they are and focus on finding career paths that suit their skill-set and temperament so they can thrive.
