## **DEPUTY DIRECTORS' REPORTS**

## CURATORIAL, EXHIBITIONS, & COLLECTIONS MANAGEMENT

In the fall of 2012, The Walters continued its commitment to the presentation of thought-provoking exhibition projects with Revealing the African Presence in Renaissance Europe.

This ambitious international loan exhibition introduced visitors to the diverse roles played by Africans throughout European society during the Renaissance, paying particular attention to the character of individuals as revealed through their portraits. The exhibition received high critical praise on an international scale, and the accompanying publication—sold out after three printings—has become an important reference text. After closing at the Walters, the exhibition travelled to the Princeton University Art Museum, where it was seen by more than 20,000 people.

In March, we opened *New Eyes on America*: *The Genius of Richard Caton Woodville*, an unprecedented celebration of the complete oeuvre of the Baltimore-born genre painter Richard Caton Woodville (1825–1855). The installation included all of the known works painted by Woodville, and resulted in the discovery of one additional portrait, previously unknown to scholars. Through generous support from the Wyeth Foundation, our conservators, in collaboration with the Scientific

Research and Analysis Laboratory at the Winterthur Museum, were able to conduct a thorough technical examination of Woodville's paintings, the results of which were featured both in the installation proper and in the accompanying catalogue. Following its presentation in Baltimore, the exhibition continued its tour to the Mint Museum of Art in Charlotte, North Carolina.

As the fiscal year was coming to a close, the Walters hosted for the first time The Janet & Walter Sondheim Artscape Prize 2013 Finalists Exhibition. Presented jointly by the Walters and the Baltimore Office of Promotion & The Arts, this exhibition featured the work of six finalists competing for the Janet & Walter Sondheim Artscape Prize, the region's most prestigious competition for contemporary artists.

In addition to these large-scale projects, objects from the Walters collection were also enjoyed in several "Focus Shows" and temporary installations. Of particular note is Threshold to the Sacred: The Ark Door of Cairo's Ben Ezra Synagogue, which told the story and presented a technical study of a rare carved wooden door panel owned jointly by the Walters and Yeshiva University Museum in New York.

A highlight of this year's art acquisitions was the purchase of the large-scale landscape painting *River Scene* (1868)

by Robert Seldon Duncanson, one of the premier landscape artists of the nineteenth century. This important addition to the Walters collection was made possible with funds generously provided by the Eddie C. and C. Sylvia Brown Challenge Grant, and matching funds, for the acquisition of African American Art.

#### **AUDIENCE ENGAGEMENT**

Audience Engagement addresses the ways in which we engage a wide variety of audiences in the art, programs, events and activities of the Walters Art Museum. The Division of Audience Engagement thinks holistically about managing the total visitor experience, from the development of innovative programming to understanding the visitor: from when and how to communicate with the visitor, to the moment a visitor makes a decision to attend, to the experience during the event, to the days, months and years after the event.

Nearly half of all visitors to the Walters participated in a variety of education programs at the museum in FY 2013. The 41,538 teachers and students who participated in all school programs include a 7 percent increase in studio experiences and a 20 percent increase in the school outreach experience compared with FY 2012. Funded by the Maryland Humanities Council, African Presence: Student Response (September 15, 2012–February 3, 2013) was a small exhibition of artwork created by Maryland middle school students in response to the special exhibition Revealing the African Presence in Renaissance

Europe. The exhibition was viewed by 953 K–12 students and 9,000 general visitors.

Since going free in 2006, the Walters has sustained our attendance by families who participate in a wide range of familyfocused programs including Drop-In Art Activities in the Family Art Center, which enjoyed an increase of 7 percent over last year, to Family Festivals, which saw a 49 percent increase in attendance over last year. In FY 2013, 43,645 people participated in family programs and activities, a significant increase over last year. The Walters has distinguished itself in the development of quality early childhood learning programs, a major focus of education efforts throughout the nation, and was cited in publications by the U.S. Institute for Museums and Library Services and the Maryland State Department of Education. The Walters' offerings of sensory mornings for children in the autism spectrum and their parents continue to achieve recognition and appreciation from parents and caregivers. Community Outreach successfully worked with a number of organizations and served nearly 5,000 people.

The Division of Marketing and Communication launched a three-year project, Off the Wall, aimed at getting more people in the community to enjoy and interact with art in the Walters collection. The project began with the reproduction of twenty-five classic paintings from the collection, and these were installed in buildings, streets, and outdoor spaces throughout Baltimore City and Baltimore County. The project has met with great success and has been the focus of social media and pictures posted on Flickr.

Beginning October 4, 2012, with generous support from Constellation Energy, the

Walters opened its doors every Thursday evening from 5 to 9 p.m., offering nighttime access to the permanent collection, free entry to special exhibitions, shopping at the Museum Store, and food and beverages at Café Q. Known as Constellation Thursday Nights, the extended hours were designed to improve museum access and diversify the Walters' audience, with a special focus on young professionals, many of whom live and work in the Mount Vernon neighborhood.

In 2013, as in past years, the Walters was awarded prizes by the American Alliance of Museums in several categories in this year's Museum Publications Design Competition.

The Walters Art Museum would not be able to accomplish its mission to bring art and people together without incredible staff and the commitment of dedicated volunteers including those in Visitor Services, who contributed 6,669 hours of volunteer hours (a monetary value of \$153,720), and Walters docents, who contributed 17,755 volunteer hours (a monetary value of \$409,075), touring students and adults through the collections and special exhibitions.

#### DEVELOPMENT

This year saw important development activity on numerous fronts. The museum celebrated Gary Vikan's long and distinguished tenure as Director at our annual gala on October 13, 2012. At 550 for dinner and 220 for the pARTy, attendance broke all records, and a total of \$405,000 was raised for the museum's educational and community programs. Board President Douglas Hamilton announced

that evening that the Andrew W. Mellon Foundation would consider a \$1.5 million challenge grant to endow scholarly exhibition activity in Gary's honor. By March of 2013, Gary's many friends and admirers (see p. 56) had stepped forward generously, matching the Mellon gift dollar for dollar The \$3 million fund provides a lasting reminder of the many important exhibitions organized under Gary's leadership and ensures support for such scholarly endeavors into the future.

Individual giving, from membership to the Annual Giving Circles, grew to \$2,191,057. We are truly grateful to the 4,478 people who show their support of the museum's mission and program through these sustaining contributions. The hard work of the William T. Walters Association, chaired by Adam Borden, was essential to that success. Their persuasion, hospitality, and enthusiasm for the collections, people, and programs that make up the museum ensure this success.

The Development Committee, chaired by Trustee Christine Espenshade, undertook several key initiatives. Members of a corporate task force chaired by Michael Glick embarked on a research project, meeting with corporate representatives from donor and nondonor companies to discern interests, identify contacts, and spread the word about the museum's education initiatives in particular. The Government Relations Committee, chaired by Meg Ferguson, worked with staff to advocate with the museum's many friends in the legislature for a \$2.5 million capital appropriation in Governor Martin O'Malley's budget to address pressing issues in the physical plant and the visitor experience. Bond funds recommended by Mayor Stephanie Rawlings-Blake and enthusiastically

approved by Baltimore City voters will be an important source of support as well. The Walters Enthusiasts, chaired by Colleen Pleasant Kline, is a growing group of young advocates, who focus on building the group of young friends and supporters of the museum. Their programs, ranging from casual meet-ups during Thursday evening hours, to a special gathering with the Young Members of the Centre Club, to work on the Gala pARTy, add fun and excitement to our schedule.

The Walters Women's Committee. chaired by Anne Nelson Apgar, held two ambitious and successful fundraisers: the Jewelry Fair (November 2-4, 2012) and Art Blooms (April 5-7, 2013). Both events swell museum attendance and raise significant funds. This year, Women's Committee sponsorship went to the exhibition New Eyes on America: The Genius of Richard Caton Woodville and provided \$30,000 in funding for school buses to bring children to the Walters from Title 1 schools. The activities of members of the Women's Committee go far beyond those two events and include arranging the beautiful floral display in the Centre Street lobby, decorating the entire museum for the holidays, and participating on numerous committees.

Our two major special exhibitions, African Presence and New Eyes on America, were supported generously through grants, sponsorships and gifts from individuals. This year's roll-out of consistent Thursday evening hours is made possible through the generosity of Constellation Energy.

## ADMINISTRATION & OPERATIONS

Over the last fiscal year, the division has largely focused on three key areas: finance, human resources, and capital improvements.

The museum ended the 2013 fiscal year (July 1, 2012–June 30, 2013) with a small budget surplus, and staff presented to the Board of Trustees a balanced budget for FY 2014. At the end of FY 2013, the endowment reached nearly \$100 million.

In an attempt to align staff performance with strategic goals, we launched a new performance management program in fall 2012 that included the development of Results-Oriented Job Descriptions and individual performance goals known as "SMART" goals (Specific, Measurable, Achievable, Relevant, and Timely). As part of an industry and best-practices approach, we implemented a Paid Time Off (PTO) program in June 2013. Under this program, all leave benefits (personal, sick, and vacation) are bundled for the employee to use as the need or desire arises, and we adjusted the rate at which leave is accrued, now providing that information on the biweekly paychecks. As a result of the PTO program, we have reduced paperwork and improved accounting discrepancies; we expect to have long-term cost benefits. In FY 2013, we completed a six-month evaluation of our capital program, which led to the launch of three capital projects currently in progress: a campus-wide fire detection upgrade; improvements to address fire code issues and the relocation of frame storage to our 100 West Centre Street property; and the design phase for the installation of a firesuppression system in Hackerman House. Technology sits within the adminstrative function of the museum and its chief technology officer. The Walters Art Museum hosted Art Bytes, Baltimore's first art museum hackathon on July 27-29, 2012. The multi-day event brought the technology and creative communities together to build programs and applications to address specific challenges faced by museums. Participants divided into seven teams and developed smart phone- and tablet-based prototypes. Using a wide range of technologies, including three-dimensional scanning and printing, augmented reality, and geo-locating navigational tools, the prototypes sought to provide deeper context for the artwork by building links to additional curatorial, conservation and historical information from sources both within and outside of the museum.

#### **SPECIAL EXHIBITIONS**

#### **Public Property**

June 17-August 19, 2012

This participatory exhibition was created collectively by the public. From December 2011 through March 2012, a series of public choices were made, from deciding the exhibition title and theme to selecting artworks. First, we asked the public to browse the collection and tell us which artworks they would collect and tag them with key words. We found some popular themes from among the choices. We held a vote to determine which would become this exhibition's theme, and "Creatures" was selected. Using an online voting tool, the public selected the works of art to include in the exhibition, including the twentythree paintings that were displayed. While on view, visitors continued to contribute to, and change, the exhibition.

## Revealing the African Presence in Renaissance Europe

October 14, 2012 – January 21, 2013

This unprecedented international loan exhibition explored the world of Renaissance art in Europe to bring to life the hidden African presence in its midst. During the first half of the 1500s, Africa became a focus of European attention as it had not been since the time of the Roman Empire. The first half of the exhibition of seventy-three works

explored the historical circumstances as well as the conventions of exoticism that constituted the prism of "Africa" through which the people were inevitably perceived. In the second half, attention shifted to individuals, focusing on portraits. These often very sensitive images emphasize the role of art in bringing people from the past to life.

# New Eyes on America: The Genius of Richard Caton Woodville March 10-June 2, 2013

Painter of iconic works of American genre, Richard Caton Woodville (1825–1855)

led a life of paradox. Born and raised in Baltimore, he produced most of his paintings in Düsseldorf, Germany, Paris, and London, where he died at the age of 30. Although he left behind fewer than twenty paintings, his images were widely known in the period because of their reproduction as premium prints distributed by the American Art-Union. Woodville's humorous characterizations of contemporary life, realistic depictions of period interiors, and use of narrative detail, give viewers many points of access to his beautifully crafted works of art. In this first exhibition devoted to Woodville since 1967, the Walters' rich holdings and several key loans were assembled to explore the formation, historical and social context, and reception of this engaging painter.

New Eyes on America: The Genius of Richard Caton Woodville was generously sponsored by the Women's Committee of the Walters Art Museum and Wilmington Trust, with grant funds from the U.S. Institute of Museum and Library Services, the Wyeth Foundation for American Art, the Bernard Family, Charlesmead Foundation, Frederick and Mary Louise Preis, and other generous individuals.

# The Janet and Walter Sondheim Artscape Prize 2013 Finalists June 29-August 11, 2013

Presented by the Walters and the Baltimore Office of Promotion and The Arts, this exhibition showed the work of the six finalists for the 2013 Janet and Walter Sondheim Artscape Prize. Artists competed for top honors. The \$25,000 prize in the Greater Baltimore area's most prestigious arts competition assists in furthering the career of a visual artist or visual artist collaborators

living and working in this region. Held in conjunction with Artscape, America's largest free arts festival, the finalists and semifinalists exhibitions were presented in partnership with the Walters and the Maryland Institute College of Art. The competition winner, Gabriela Bulisova, was announced at an awards ceremony at the Walters on July 13, 2013.

The exhibition and opening event at the Walters Art Museum were generously supported by Cynthia Alderdice, the Talkin Fund of the Columbia Foundation; Time Group Investments; Rachel and Joseph Rabinowitz; The Zamoiski, Barber, Segal Family Foundation; and the Greif Family Fund.

#### **FOCUS EXHIBITIONS**

## Hashiguchi Goyo's Beautiful Women May 18-August 12, 2012

Through a handful of images, Hashiguchi Goyo, the last of Japan's ukiyo-e printmakers, captured the spirit and the dynamic visual character of the pre-World War I era. Between 1918 and his death in 1920, Goyo oversaw the production of just thirteen prints. Of these, eight were images of beautiful women. To this small group of images, his brother and nephew added a few posthumous works based on completed designs. The twelve prints and two drawings in this exhibition constitute first editions of all of Goyo's prints of beautiful women and reveal the elegant design sense of this important twentieth-century Japanese artist.

#### Paradise Imagined: The Garden in the Islamic and Christian World June 30–September 23, 2012

Gardens have long functioned as spaces of invention and mythmaking. This exhibition of twenty-seven artworks

focused on the transmission and assimilation of garden imagery between the Islamic world and western Europe. Drawing on imagery found in illustrated manuscripts from the Walters' collection, this show explored gardens as an expression of love, power, philosophy, poetry, and art evoked through word and image on the illuminated page.

#### The Two Planets: Araya Rasdjarmrearnsook

August 11-November 18, 2012

In The Two Planets (Dow Song Duang), a work of contemporary video art by Araya Rasdjarmrearnsook, the inhabitants of small villages in Thailand discuss several classic European paintings. The work explores how people perceive and understand works of art based on their experiences, backgrounds, and cultures. This project was made possible by Tyler Rollins Fine Art, New York.

## **African Presence: Student Response** September 15, 2012–February 3, 2013

The Walters worked with five schools from Baltimore City, Baltimore County, and Anne Arundel County to create a focus show related to the special exhibition Revealing the African Presence in Renaissance Europe (on view October 14, 2012–January 21, 2013). An educator visited each school to discuss the themes of the exhibition. The students created their own artworks, including a mural, triptych, book, paintings, and drawings, in response to paintings in the exhibition.

This project was made possible by a grant from the Maryland Humanities Council, through support from the National Endowment for the Humanities.

## Diadem and Dagger: Jewish Silversmiths of Yemen

October 27, 2012-January 21, 2013

This focus show highlighted 28 objects of Yemeni-Jewish silverwork, which are a joint gift to the Walters and the Israel Museum, Jerusalem, by Mr. Derek Content and Mr. Benjamin Zucker in honor of Mrs. Amanda Content and Mrs. Barbara Zucker from the Zucker Family Trust collection. The rare pieces, dating to the seventeenth through nineteenth centuries, are inscribed in Hebrew and Arabic and reference the Muslim ruler and Jewish craftsman. From the inception of Islam in the 7th century, Jewish and Muslim communities co-existed in Yemen, although few Jews live there today. Yemeni-Jewish craftsmen produced beautiful silver pieces characterized by elaborate granulation and filigree decoration for Muslim and Jew alike. Through the lens of superb Jewish craftsmanship, this exhibition explored the significant role of the Jew as silversmith in the Arab world.

The Walters wishes to extend its deepest appreciation to Mr. Derek Content and Mr. Benjamin Zucker for the joint gift of most of the works on display here to the Walters and to the Israel Museum, Jerusalem, in honor of Mrs. Amanda Content and Mrs. Barbara. # Threshold to the Sacred: The Ark Door of Cairo's Ben Ezra Synagogue March 2-May 26, 2013

This exhibition focused on a work of exceptional historical importance jointly owned by the Walters and the Yeshiva University Museum: an intricately decorated and inscribed wooden door panel from a Torah ark, a special cupboard that holds the sacred Jewish scripture. The panel is believed to have come from the famous Ben Ezra Synagogue of Old Cairo (Fustat), Egypt the site of the great nineteenth-century discovery of the Cairo Geniza, a treasure trove of documents on medieval Jewish life around the Mediterranean. This exhibition presented Geniza documents, photographs of the Ben Ezra Synagogue, and works of Jewish and Muslim artisans, together with conservation-science research, to relate the fascinating "object biography" of the WAM-Yeshiva ark door.

Threshold to the Sacred: The Ark Door of Cairo's Ben Ezra Synagogue was organized by the Walters in collaboration with Yeshiva University Museum, New York, where it is on view from October 27, 2013 to Feburary 23, 2014. # The Frist Center for the Visual Arts, Nashville, Tennessee March 3–June 23, 2013

Organized by the Walters, this exhibition presented 124 pre-Columbian works from the collection of ancient Mesoamerican, Central American, and Andean South American art (spanning 1200 BCE to 1530 CE) assembled by John G. Bourne beginning in 1940. Displayed geographically and culturally, the exhibition featured artworks as illustrations of their societies' most fundamental principles: the feminine origins of royal power in ancient Mexico, the shamanic foundation of Central American chiefs, and the cosmic principles embodied by gold and silver in Peru. Other artworks, from elaborate musical instruments to portrayals of dancers, explored the importance of performance to politics and religion throughout the ancient Americas.






The most comprehensive work on Woodville to date, New Eyes on America reproduces all of the artist's known works. Five essays explore Woodville's artistic genius, his Baltimore upbringing, his education at the Dūsseldorf Academy, his place in the international art world, and his technique, which was acclaimed for its attention to detail and color. The themes that Woodville represents, including the generational divide that informed so many pressing issues of the time, offer a unique perspective on both America and Europe during the decades preceding the Civil War and capture a period of rapid social, political, and technological transformation. The catalogue accompanied an exhibition that opened at the Walters in March 2013 and traveled to The Mint Museum, Charlotte, North Carolina.


Revealing the African Presence in Renaissance Europe explores the roles of Africans and their descendants in Renaissance Europe as revealed in compelling paintings, drawings, sculpture, and printed books of the period. The essays, supplemented by an illustrated checklist of the exhibition, consider the lives of African slaves and people of African descent in Renaissance Europe; European perceptions of blackness as reflected in the visual arts: Leo Africanus's account of culture, religion and politics in northern Africa; the contributions to Renaissance society by free (or freed) men and women of African descent; and visual representations of African ambassadors and rulers. Accompanying an exhibition that opened at the Walters in October 2012 and traveled to the Princeton University Art Museum, the publication (generously supported by the Robert H. and Clarice Smith Publication Fund) exhausted three printings. ### NAMED ENDOWMENT FUNDS

The following named funds are part of the Walters' permanent endowment and were established with gifts of \$250,000 or more.

### **Alexander Brown Griswold Fund**

Alexander Brown Griswold, an eminent scholar of Thai art, greatly enriched the Walters' collection of Asian art with the gift of his large and important collection of Thai and other Asian sculpture. In addition, he established this endowment fund, with income unrestricted.

# The Andrew W. Mellon Curatorial Chair for Medieval Art

This fund was established in 2007 with gifts from generous individuals given to meet a challenge from the Andrew W. Mellon Foundation.

# The David Hirschhorn Community Outreach Coordinator Fund

The David and Barbara B. Hirschhorn Foundation established the museum's first endowed education position in 2007, the David Hirschhorn Community Outreach Coordinator, to honor the memory of the former Walters' Trustee David Hirschhorn and promote the Walters' programs for learning and cultural development.

# Exhibition Endowment Fund in honor of Gary Vikan

Gary Vikan served as the Walters Art Museum's Director from 1994 to 2013. The achievements of his tenure will be honored in perpetuity with this fund, given by his many friends and admirers and matching a leadership grant from the Andrew W. Mellon Foundation, it supports "scholarly activities, research, and publications related to special exhibitions."

### The Jacob and Hilda Blaustein Endowment Fund and the Louis and Henrietta Blaustein Endowment Fund

In 1989, the trustees of the Jacob and Hilda Blaustein Foundation and of the Louis and Henrietta Blaustein Foundation established these funds at the Walters to provide support for essential programmatic activities, such as permanent and temporary exhibitions, publications, education programs, and visiting specialists.

# James A. Murnaghan Curatorial Chair in Renaissance and Baroque Art

James A. Murnaghan, the distinguished Irish jurist and art collector, was the uncle of the Hon. Francis D. Murnaghan, Jr., Chairman Emeritus of the Walters' Board of Trustees. The income from this fund supports the position of Curator of Renaissance and Baroque art.

### The Jay M. Wilson Endowment Fund

Jay M. Wilson was President of the Walters' Board of Trustees from 1979 to 1985, Chairman from 1985 to 1988, and President again from 1991 to 1994. Established in 2000 by his family, this fund is designated for endowment, with income unrestricted.

### The Laura F. Delano Fund

Miss Delano, niece of Henry Walters, served as a trustee of the Walters for 28 years and took particular interest in the collections of jewelry and portrait miniatures. Upon her death in 1972, she left a significant bequest to the museum's endowment, with income unrestricted.

### The Loretta Lee Ver Valen Fund

This fund was established in 2001 with a bequest from the estate of Loretta Lee Ver Valen. It was given to honor the memory of Mrs. Ver Valen's mother. The income from this fund is to be used to support the acquisition of works of art.

### The Perlman Memorial Fund

Philip B. Perlman was one of the original members of the Walters' Board of Trustees, which he established in 1932 following Henry Walters' bequest to the City of Baltimore in 1931. He became President of the Board of Trustees in 1955 and remained in that position until his death in 1960. His bequest, and a generous donation by an anonymous donor, funded the Perlman Memorial Fund, with income unrestricted.

# The Robert and Nancy Hall Assistant Curatorship

Museum patrons Robert and Nancy Hall established this endowed mid-level curatorial position in response to a challenge from the Andrew W. Mellon Foundation.

# The Ruth T. Rauch Early Childhood Program Endowment Fund

This fund was established in 2012 with gifts from Lynn and Phil Rauch and the Rauch Foundation in memory of Mr. Rauch's mother, Ruth T. Rauch. Income from this endowed fund will support early childhood programs providing a foundation for success in school and a framework for learning through art.

### Mr. and Mrs. Thomas Quincy Scott Curatorial Chair for Asian Art

This fund was established in 1997 in response to a challenge from the Andrew W. Mellon Foundation, with income restricted to support of the position of Curator of Asian Art.

### W. Alton Jones Acquisition Fund

In 1983, the W. Alton Jones Foundation made a major gift to the Walters to establish an acquisition endowment. The income from this fund is to be used to support the acquisition of works of art.
