## TRANSPORTING HORSES IN THE EU

From 1 January 2021 Transporter Authorisations and Vehicle Approval Certificates issued in the UK will not be recognised by the EU. You may not be able to apply for these from an EU member state before 1 January 2021.

From 1 January 2021 Driver and Attendant Certificates of Competence issued in the UK will not be recognised by the EU. You may apply for this from an EU member state before 1 January 2021.

Horses will only be able to enter the EU via a Border Control Post in the EU designated for the specific consignment.

Transporters should contact EU BCPs to check notice periods.

## DRIVING LICENCES AND INTERNATIONAL DRIVING PERMITS (IDP) IN THE EU

It will not be sufficient just to carry your UK driving licence. Drivers will also need an international driving permit (IDP) to drive in some EU and European Economic Area (EEA) countries. You do not need an IDP to drive in Ireland .

## GET THE RIGHT OPERATOR LICENCE FOR THE EU

You need a goods vehicle operator's licence if your business uses goods vehicles above a certain weight. Check the licences and other permits you need.

## DRIVER CPC FOR LORRY DRIVERS FOR THE EU

UK Drivers need a Driver Certificate of Professional Competence (CPC) qualification to drive a lorry professionally in the UK and other EU and EEA countries.

You do not need a Driver CPC if you're driving a vehicle under 3.5 tonnes, or are only carrying your own goods.

## UK VEHICLES AND TRAILERS IN THE EU

You must register commercial trailers over 750kg and all trailers over 3,500kg before you can drive through some countries in Europe.

Search **GOV.UK** for “Register your trailer to take it abroad”.

Check your vehicle insurance documents and a Green Card.
