Reflections on FY17 (July 1, 2016 – June 30, 2017)

#### A note from Jill McKinstry UWRA PRESIDENT 2017-2018

On behalf of UWRA's Board of Directors, I am proud to share UWRA highlights from the past fiscal year. It was a year of extraordinary growth, engagement and generosity.

#### Growth

The **number of retirees last year was almost double** what it was ten years ago. Membership in UWRA continues to appeal to new retirees: in the past five years, **UWRA's membership has grown by a third**.

#### **Programming Highlights**

The number and quality of UWRA-offered **member programs** keeps growing, with enthusiastic participation in the fall meeting with Prof. Pepper Schwartz, the winter Learn & Lunch featuring three outstanding scholars, the spring Scholarship Brunch honoring six student recipients, and day trips to tour the UW Press and the Union Bay Natural Area. We kept members **informed** through sessions on proposed Medicare legislation and on geriatric medicine. We **partnered** with the Meany Center for the Performing Arts, UW Dance, and the Seattle Piano


Institute in order to make their programs available to UWRA members.

#### **Engagement**


UWRA engaged with the broader University community through programs that helped current employees and retirees with the decisions and planning that surround retirement. We reached out to all retirees through the annual reception honoring the year's retirees, the retiree resource fair, and a new periodic e-newsletter. And we expanded many opportunities for service through UW Encore.

UWRA's board continued to **advocate on behalf of retirees** through ongoing discussions regarding retirees'
privileges, such as email. Retirees from UW Bothell and
UW Tacoma were recruited to the 2017-18 UWRA board to
help extend outreach. Retirees serve on the board of UW
Impact and on councils of the Faculty Senate, including
Benefits & Retirement, Faculty Affairs, Research, Teaching
and Learning, Tri-Campus Policy, University Facilities and
Services, and University Libraries as well as the ad hoc
Committee on Retirement.


#### Generosity

Retirees' financial support of the University has been remarkable during the year since the beginning of the Faculty-Staff-Retiree campaign. UWRA members give to UWRA's scholarship and fellowship program with **extraordinary faithfulness and generosity**.

In 2016-2017, UWRA members made gifts to the four designated scholarship and fellowship funds totaling almost \$27,000, with the added impact of a 50% match on over \$20,000 in contributions to the fellowship endowment. These gifts to endowments and current- use funds allowed UWRA to award **four \$4,000 scholarships** and to work with the Graduate School to award **two one-quarter graduate fellowships**, which include stipend, health insurance and tuition waivers.

Retirees are also generous with their time: over half the respondents to UWRA's survey of retirees reported participating in community volunteer activities, and about **26% volunteer somewhere at the UW**.

- Sarah Fishleder (Department of Health Services PhD Program) works to make a meaningful impact on healthcare delivery for older adults. Her goal is to conduct primary research in translational gerontology at the National Institute for Aging.
- Combining a love for working with older adults and a passion for eradicating inequality, **Kezia Howard** (Masters of Social Work) is pursuing coursework and certification that will enable her to work with family trauma and end-of-life care in a health care setting.
- Lauren Langley (Doctorate of Audiology, Department of Speech and Hearing Sciences) seeks to serve the 25% of adults over age 65 with a disabling hearing loss, particularly through understanding and addressing the barriers to help-seeking in this population.

- Yong K. Choi (Biomedical Informatics and Medical Education) is exploring how Internet of Things-based smart sensor technologies can help older adults who are aging-in-place manage their health and wellness.

#### Your Generosity at Work

Thank you for giving to the UW's Faculty-Staff-Retiree Campaign for Students (FSR), and a special thanks for being donors to the UWRA Fellowship Fund.

The Graduate School selected UWRA's Endowed Graduate Fellowship in Aging (UWRAFE) to be eligible for the FSR match, and UWRA members gave generously to support it. In 2016 you gave \$20,000 to UWRAFE, and as of mid-December 2017 you have given almost \$12,000 more. After the original UW matching funds were exhausted, the Graduate School identified an additional \$25,000 in matching support for gifts received through the end of December, so all 2017 gifts to UWRAFE were credited with the match.

The UWRA Board of Directors and UWRA's Scholarships and Fellowships Committee members are grateful for all of your support for the UWRA Fellowship. This fund provides financial support, combined with Graduate School tuition waivers, to meritorious graduate students in aging-related fields. These students will expand and transform our understanding of aging. (See last year's recipients on previous page.)

It is UWRA's goal to build the endowment so that we can keep this fellowship an annual award even as the costs of graduate education rise. It's an ambitious goal, but we're on our way, thanks to your generosity.


## Faculty Staff Retiree Campaign for Students

From October 2016 to October 2017, **\$10 million** in match-eligible donations were received by the UW's Faculty Staff Retiree Campaign for Students. UW's matching support of \$1 for every \$2 donated, up to the available total of \$5 million, was added to this total.

Retirees in particular were a critical component of the FSR's success – **46%** of the matching funds were used to match gifts from UW retirees.

In addition to remarkable match-supported philanthropy, UW faculty, staff and retirees have donated widely to other funds as part of the UW campaign. From July 1, 2010 through June 30, 2017, and with the campaign not yet over, retirees have donated **\$58.5 million**. UW retirees have participated in the campaign at rates double that of current staff and faculty.

#### **UW Systems Change May Require Action from You**

The UW has updated its online payroll and personnel system, which is now called Workday. Recent retirees are advised to double-check that their personal information was transferred to Workday correctly. Also, if you are expecting W-2 or other tax documents from the UW, please confirm your contact information and specify whether you need to receive your documents electronically or on paper.

To access Workday, you will need to set up two-factor authentication (TFA). This means that when you log in with your UW NetID and password, you will also need confirm your identity by responding to a notification text or phone call.

## UW Encore: Active Caring for Your Community is Actually Self-Care

Looking to make a New Year's resolution that might be both a rewarding use of your time and a boon to your well-being? Numerous studies have emphasized the health benefits of volunteer work. A 2012 review compiled by the Corporation for National and Community Service shows a research-based association between volunteering and mental and physical health benefits.

UWRA's recent survey of UW retirees revealed that many retirees appear to be taking good care of themselves. Of the 600+ survey respondents, more than half are volunteering in their communities and 26% are volunteering at a UW campus. In 2017, UW retirees returned to campus to take part in programs such as the Husky Leadership Initiative's Spring Celebration of Service and Leadership, Huskies@Work student career exploration with the UW Alumni Association, and the Dream Project's Admissions Workshop Weekend.

In July, 2018, UW retirees will have new way to be involved: the UW will host the Special Olympics USA Games. More than 1,700 UW volunteers will be needed for a wide variety of support roles – from bocce ball to dorm concierge services and everything inbetween. Stay tuned for more information in the coming months.
