IL-ACDA Summer Board meeting Tuesday July 7 2009 ISU Performing Arts Center

President Brett Goad called the meeting to order at 4:10P.M.

Brett asked members present to introduce themselves and their Board position. Congratulations were conveyed to President-Elect Beth Best. Acknowledgements of past service were made to John Jost and Eric Johnson.

The minutes of the 2009 Winter IL-ACDA Board Meeting were perused, discussed, and approved as presented. A motion to approve the minutes was made by Elizabeth Zobel, second by Joy Schertz; motion carried.

The IL-ACDA Financial Report July 1, 2008 – June 30, 2009 was presented. Treasurer Tim Fredstrom anticipates after the Retreat there will be \$4500.00 remaining in the treasury, essentially breaking even. Tim recommends an operating capital upwards toward \$8000. Ensuing discussion concerned the high cost of the *Podium's* art work and postage. It was announced Tim's quarterly reports were approved by and impressed the National Office. There will be an audit of the treasurer's books after the Retreat. To make budget at the Retreat, 120 participants are needed. After discussion a motion to accept the treasurer's report was made by Beth Best, second by Janet McCumber; motion carried.

ILACDA Summer Retreat 2009 Open Membership Meeting Friday July 10 ISU Alumni Center

President Brett Goad called the meeting to order at 2:15 P.M.

The format of the meeting followed topics given on the evaluation form.

- Bob Boyd and Karyl Carlson will talk to Musical Resources to secure enough music for the Directors Chorus, and work out appropriate number pieces per session for the time allotment
- Leslie stated the pre-registrants should get music; we take responsibility for 120 in the Director's Chorus
- For the Chestnuts it was suggested each presenter bring copies of the song from his/her school each has chosen for the participants use during the session, and the vendors could have copies available [not sure if on site or to order later]
