#### SEPTEMBER PLANNING COMMISSION AGENDA ITEMS

#### Lesnett Subdivision - Garden Grove Drive

The referenced Subdivision Plan is located along Garden Grove Drive and Old Plank Road in the R-1 (Single Family Residential) Zoned District. The plan proposes to consolidate two lots. Planning Commission recommended granting final approval of the Lesnett Subdivision contingent upon compliance with Gateway Engineers' letter dated August 19, 2020, C-25667.

#### Litman Road – Change of Zoning

The referenced change of zoning would amend Butler Township's Codified Ordinance, Chapter 300 (Zoning), and previous amendments thereto by rezoning the parcels as identified below from Residential Zoning to a Zoning designation of C-1 General Commercial:

Butler County Parcel ID 051-38-7A-0000. A vacant parcel on Litman Road consisting of (23.02 Acres), and Butler County Parcel ID 051-38-6-0000. 98 Old Plank Road consisting of (11.09 Acres), and

Butler Township's Codified Ordinance, Chapter 300 (Zoning), and previous amendments thereto by rezoning the parcel as identified below from R-2 Multifamily Residential Zoning to a zoning designation of R-1 Single-Family Residential:

Butler County Parcel ID 051-38-18-0000. 94 Old Plank Road consisting of (3.859 Acres)
