Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Professional handlers are not permitted to exhibit in this class. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards or otherwise advertised or represented themselves as handling for pay. Dog may not be exhibited by current assistants and household members of a professional handler.*

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth, etc. are permitted to receive awards in the 4-6 Month Puppy Classes.

The Certificate of Merit (CM) title is an introductory title to AKC conformation events. Entrants in each breed shall compete for Best of Breed and Best of Opposite Sex to Best of Breed. Winners of the Best of Breed will be awarded points toward the CM title based on the number of dogs defeated in their breed or variety. Winners of Best of Opposite Sex to Best of Breed will be awarded points toward the CM title based on the number of dogs defeated in their sex.

The Certificate of Merit requires 15 points awarded in accordance with the following points structure

If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquisition, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
