

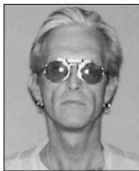

On August 12, 1972, 25-year old, **Vickie Lynn Harrell** was last observed getting into her dark blue 1965 Plymouth Valiant 4-door at the K-Mart parking lot on the east side of Bloomington, Indiana. On August 13, 1972, Vickie's roommate reported her missing to Bloomington Police. On August 14, 1972, Vickie's body was discovered in Owen county on an access road to McCormick's Creek State Park, approximately 2.5 miles east of Spencer, Indiana. Vickie's body was nude and there was evidence that she had been strangled. A knife or sharp instrument had been used to carve two alpha characters on her chest, post-mortem.

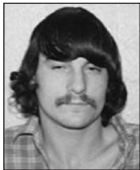

As they traveled underneath the Manhattan road underpass, two large rocks (exceeding 15 lbs. each) broke through their windshield, one of which killed Ms. Gipson, who was the driver. The two rocks were obviously thrown from the overpass where at least two subjects were observed. This was not an isolated incident, as similar incidents had occurred from the Manhattan overpass and other nearby overpasses during prior months, without killing anyone until Marsa Gipson.
