2 Safety Instructions

2.1 Information on EMC

2.3 Intended Use

The interfaces are used to connect computer systems to CAN and LIN networks. The USB-to-CAN^{v2} Embedded is intended for installation in computer systems with closed housing. The USB-to-CAN^{v2} Compact, Professional and Automotive are intended for the connection to a computer via the USB interface.

Product versions that are not galvanically isolated are only allowed to operate inside buildings in CAN networks of maximally 30 m length (order number 1.01.0281.11001).

3 Scope of Delivery

Included in the scope of delivery:

- USB-to-CAN^{v2} interface
- only version professional and automotive: 2 x RJ45 to D-Sub 9 adapter cable
- Installation Guide VCI Driver
- User Manual USB-to-CAN^{V2}

The following equipment can be ordered separately:

- CAN bus termination
- RJ45 to D-Sub 9 adapter cable

4 Product Description

The USB-to-CAN^{v2} is an active USB interface which enables the user to monitor and control up to two CAN high-speed channels, one CAN low-speed channel, and a LIN channel, depending on the variant.

4.1 USB-to-CAN^{V2} Compact and Embedded

- 1 x CAN high-speed channel according to ISO 11898-2: 2016
- optional galvanic CAN bus isolation
- fieldbus connection:
 - compact: D-Sub 9 or RJ45
 - embedded: D-Sub 9

4.2 USB-to-CAN^{v2} Professional

- USB 2.0 Hi-Speed (480 MBit/s)
- 2 x CAN high-speed channels according to ISO 11898-2: 2016
- galvanic CAN bus isolation (both CAN channels are on the same potential)
- fieldbus connection: 2 x RJ45
- 2 x RJ45 to D-Sub 9 adapter cable

4.3 USB-to-CAN^{v2} Automotive

- USB 2.0 Hi-Speed (480 MBit/s)
- 2 x CAN high-speed channels according to ISO 11898-2: 2016, CAN 1 can be switched between high- and low-speed (ISO 11898-3) via software
- 1 x LIN interface V1.3 and V2.0/2.1, Master/Slave mode and LIN frame format switchable via software
- galvanic fieldbus isolation (all fieldbus channels are on the same potential)
- fieldbus connection: 2 x RJ45
- 2 x RJ45 to D-Sub 9 adapter cable

5 Installation

5.1 Installing the Software

For the operation of the interface a driver is needed.

Windows

The VCI driver is constantly improved and expanded! Check if a newer version is available on <u>www.ixxat.com/driver-windows</u>.

- Download the latest VCI driver from www.ixxat.com/driver-windows.
- Install the VCI driver (see Installation Guide VCI Driver).

5.2 Installing the Hardware

5.2.1 Connecting USB

Connection disturbance possible if extension cable or longer cable is used!

HMS recommends connecting the interface directly with the included cable or via an active USB hub to the computer according to the USB specification.

Insufficient power supply!
Connect the interface directly to the computer or to self-powered hubs to ensure sufficient power supply.

The shield of the USB cable is connected to ground using a 100 nF capacitor. The shield of the CAN connector is connected to CAN ground via a 1 M Ω resistor and a 10 nF capacitor. USB_shield is connected to CAN_shield via a 4.7 nF capacitor. The shields of the CAN connectors of the variants *professional* and *automotive* are connected directly together.

For non galvanic decoupled interfaces, fieldbus ground and computer ground are at the same potential.

USB-to-CAN^{v2} Compact/Professional/Automotive

Connector:

- USB cable with plug type A
- Assignment corresponds to USB 2.0 standard.
- Make sure that the VCI driver is installed.
- Plug the USB connector in the USB port of computer.
 - \rightarrow Windows automatically finds and installs the hardware.
 - \rightarrow USB LED is green.

USB interface supports hot plug!

It is possible to plug or unplug the device during operation.

5.2.2 Connecting the USB-to-CAN^{v2} Embedded



Connector:

- USB cable with 5 pin female connector
- Assignment corresponds to PC standard for internal USB devices.

1	Red: +5 V/voltage +/VCC
2	White: D-/data-/USB-
3	Green: D+/data+/USB+
4	Black: GND/voltage-/ground
5	Black: S-GND/over current/shielding

- Make sure that the driver is installed.
- Turn off the computer.
- Pull the power cord.
- Open the computer case according to instructions of the computer manufacturer.
- Mount the bracket with the embedded board in the suitable slot.
- Plug the small plug of the USB cable in the USB connector of the embedded board.
- ▶ Plug the USB connector in the suitable slot on the computer main board.
- Close the computer case.
 - \rightarrow Hardware installation is complete.

5.2.3 Connecting the CAN Fieldbus

The assignment of the fieldbus connectors (D-Sub 9 and RJ45) is in accordance to CiA 303-1.

The shield of the CAN connector is connected to CAN ground via a 1 M Ω resistor and a 10 nF capacitor. USB_shield is connected to CAN_shield via a 4.7 nF capacitor. The shields of the CAN connectors of the variants *professional* and *automotive* are connected directly together.

For non galvanic decoupled interfaces, fieldbus ground and computer ground are at the same potential.

ig(ig) For best noise immunity connect the shields of the CAN cables directly to the device ground.

- ▶ If necessary install a bus termination (see CAN Bus Termination, p. 14).
- Observe pin allocation.
- Connect the CAN fieldbus connector to the CAN fieldbus.
- Start the CAN bus monitor on the computer.
- In the CAN bus monitor adjust USB-to-CAN^{v2} properties according to the fieldbus characteristics.
- Start the CAN bus monitor communication.
 - ightarrow Received CAN messages are shown in the receive window of the CAN bus monitor.
 - \rightarrow CAN LED is green flashing with each CAN message.

5.2.4 Connecting the LIN Fieldbus

 \mathbf{i} LIN functionality is exclusively available on the USB-to-CAN^{v2} automotive.

Power consumption is limited by a 1 k Ω resistor.

The LIN interface can receive and transmit LIN frames according to LIN specification V1.3 and V2.0/2.1. The LIN interface can be configured as LIN master.

A 1 k Ω pull-up resistor is automatically activated in LIN Master mode and automatically deactivated in LIN Slave mode. External pull-up resistors are not necessary.

To use the LIN interface connect a voltage of 12 V DC (voltage range 8 to 18 V DC) to pin VBAT_{LIN} (see *Pin Allocation of USB-to-CAN^{V2} Automotive, p. 10*).

To ensure successful transmission of LIN messages:

- Connect external voltage before LIN messages are transmitted.
- Make sure, that the external voltage is not switched off and on during operating in LIN mode.

6 Operation

The implemented LEDs vary dependent on the variant of the USB-to-CAN^{v2}.

Reflects the status of the USB communication.

There is no bus termination resistor for the CAN bus integrated in the interface. HMS Industrial Networks offers a bus termination resistor as a feed through connector.
