# The prerequisites for the IATF 16949 1<sup>st</sup>/2<sup>nd</sup> party initial examination at the moment are:

- 3-day training "IATF 16949 1st/2nd Party Auditor Qualification" (ID 211)
- auditor qualification as internal auditor for ISO 9001:2015
- auditing experience: at least three full internal system audits to ISO 9001 over the last three years.
- at least 2 years professional full-time job experience in the automotive industry.

### **NEW and ADDITIONAL Requirement:**

- Proof of knowledge in Automotive Core Tools
- The NEW VDA training "Automotive Core Tools for System and Process Auditors" (ID 417)
  and the existing VDA qualification "Automotive Core Tools Professional" (ID 415 and 416
  and possibly 450) are recognized.
- Alternatively, evidence of a minimum two-day training about Automotive Core Tools by another training provider as well as the passing of an Automotive Core Tools online quiz is required.
- If the quiz is not passed, the "Automotive Core Tools for System and Process Auditors" training (ID 417) must be completed.

## The prerequisites for the VDA 6.3 examination at the moment are:

- 3-day auditor qualification based on ISO 19011
- 5 year professional full-time job experience in the automotive industry, of which at least
   2 years in the quality management
- 4-day training "VDA 6.3 Qualification for Process Auditor! (edition 2016, ID 315)

### **NEW and ADDITIONAL Requirement:**

- Evidence of knowledge in Automotive Core Tools
- The NEW VDA training "Automotive Core Tools for System and Process Auditors" (ID 417) and the existing VDA qualification "Automotive Core Tools Professional" (ID 415, 416 and possibly 450) are recognized. Alternatively, evidence of a minimum two-day training about Automotive Core Tools by another training provider as well as the passing of an Automotive Core Tools online quiz is required. If the quiz is not passed, the "Automotive Core Tools for System and Process Auditors" training (ID 417) must be completed.



## New requirements for the extension of VDA 6.3

- Validity: The changes are valid from 1st January 2020.
- These new conditions also apply to certificates, which the validity ends until 31st December 2019
- but the extension is applied after 1st January 2020.
- Period of Extension: The extension can be applied for no later than three months after the
- expiration date of the certificate, otherwise an additional examination ID 353 must be taken.
- The request for Extension may be submitted up to four (4) weeks before the expiry
- date of the certificate.

### New requirements for the extension of VDA 6.3:

- Proof of five (5) process audits with at least ten (10) audit days
- Auditors, who do not meet these requirements will have the opportunity to attend a
- one-day VDA 6.3 Workshop ID 341
- (Please note: ID 341 VDA 6.3 Competence Training for Certified Process Auditors)
   will be adapted from 1st quarter 2020 to ID341 Workshop for Certified Process Auditors)

- 2. OR Module I or Module II (ID 415, ID 416)
