


What Is The Total Confined Offender Population For Your Agency?



- 20 (50%) states answered this survey.
- 6 (32%) states reported having between 1,000 and 10,000 offenders in confinement.
- 6 (32%) states reported having between 10,000 and 30,000 offenders in confinement.
- 7 (36%) states reported having over 30,000 offenders in confinement.
- TX reported having over 124,000 confined offenders.

19 other states answered this question.


What Is The Total Number of Medical Staff In Your Agency's Facilities?



- 7 (36%) states reported they had between 1 and 500 total medical staff in their agency's facilities.
- 6 (32%) states reported they had between 500 and 1,000 total medical staff.
- 6 (32%) states reported they had over 1,000 medical staff.

19 other states answered this question.


What Percentage Of Your Facilities Are ACA Accredited?



- 9 (45%) states reported having 0% of their facilities ACAaccredited.
- 1 (5%) state, MT, reported having 25% ACA accreditation with it's own correctional standards.
- 10 (50%) states reported having 90-100% of their facilities ACAaccredited.

What Is The Total Number of ACA-Accredited Adult Correctional Institutions Per State?

The ACA reports that . . .

- 20 (40%) states have 0 ACA-accredited the adult correctional institutions.
- 25 (50%) states have 1-25 ACA-accredited adult correctional institutions.
- 2 (4%) states, VA and OH, have 26-50 ACAaccredited adult correctional institutions.
- 3 (6%) states have over 50 ACAaccredited correctional institutions.
