## THE ROMAN AQUEDUCTS

An aqueduct is a pipe, conduit, canal or trough used to convey water from one place to another. At one time approximately 350 million gallons of water poured into Rome each day from as many as fourteen great aqueducts in order to serve their needs for thermae, public fountains and for domestic use.

One of the first of these aqueducts was the Aqua Appia which brought water from springs seven miles east of Rome and was completed about 312 B.C. The reservoir for the Aqua Appia was located near the Tiber and consequently only supplied a part of the city.

Forty years later in 272 B.C. they completed the second aqueduct by drawing from the Anio River on high ground near Tivoli about 20 miles from Rome.

The Aqua Marcia was third and came from springs in the upper valley of the Anio a distance of 38 miles but in order to avoid some low lands and to maintain the proper pitch, a circuitous route increased its length to 61 miles. The last seven miles entering Rome were supported on arches. It was completed in 144 B.C. and was built at a cost of approximately 8 million dollars.

The fourth was named the Aqua Tepula only 13 miles long, the last half of which was supported on the arches of the Marcia.

The Aqua Virgo served the Baths of Agrippa, so named because of the young maiden that pointed out the location of the originating springs. Water from these springs is still being brought to Rome in a newer aqueduct which is called the Trevi ... need I say more.

Next came the Aqua Claudia, built by Caligula and Claudius, it was completed about 50 A.D ... It brought water from the Subiaco, a distance of 45 miles and in some places was carried on stone arches over 100 feet high.

One of the longest seems to have been the Anio Novus completed about 50 A.D. and ran about 62 miles. The first 49 miles were subterranean.

Some of the others had names like Aqua Felice, Aqua Paolo and Aqua Alexandrina.

Most importantly they all started in the surrounding hills and were brought into Rome on a gradual pitch, sometimes going miles off course in order to avoid steep grades too soon. The portion on the ground ran in concrete channels or pipes and above ground on beautiful stone arches. Some of these conduits supplied a stream of water entering the city 40 feet deep and two feet wide running at about five to six miles per hour in a continuous current. They coped with this by making sharp

changes in direction about every mile and also by providing reservoirs at strategic locations. Settling tanks had to be provided to remove much of the chalky matter with which the water was loaded

A study of Roman antiquities made about 100 years ago stated that if all of the water from all of the aqueducts could be brought together at one point, it would create a stream 25 feet wide and 6 feet deep constantly running at a speed four or five times faster than most rivers. These aqueducts also furnished the water required to sustain the beautiful villas and the farms that covered the countryside during imperial times. Most of the water furnished to the inhabitants was free. There were about 600 open reservoirs in the city for use by anyone. The only requirement was that you bring your own "secchia." (MWRA Please Note).

Today, about 2,000 years later, one cannot speed through the Campania in an air-conditioned train, bus or car and view the standing remains of these majestic structures without some passing thought to the vision, daring and wisdom of those Roman engineers.

## EARLY DELIVERABLES ARE GEARED TO TAXPAYERS

This piece is from the Wall Street Journal's popular "Notable & Quotable" feature it was published in May and was authored by Joseph Rago. Realizing it will never be published in the mainstream media, I determined my readership be advised of its content.

I titled the piece.

White House payoffs to big labor are by now routine, though rarely are they this transparent: This week, Health and Human Services Secretary Kathleen Sebelius rolled out a new program that, scrubbed down amounts to a slush fund for union health plans.

When Democrats realized that ObamaCare's approval numbers were sagging, they loaded the bill up with "early deliverables" - programs that would go into effect immediately, rather than the five or more years of delay used to hide the bill's true costs. One of those early deliverables was \$5 billion in subsidies to early retirees aged 55 to 64 who incur annual health costs over \$15,000.

Ms. Sebelius did her best to dress this reinsurance program up in public-interest blanket, but many of the 3.3 million eligible retirees are ex-union workers who extracted generous benefits from some of America's most hard pressed industries. Businesses that doled out these unaffordable promises will be delighted with the federal handout, taxpayers less so. And also eligible are retired state and local public employees, as well as certain health-care trusts like one recently set up by the United Auto Workers, which has an estimated 30 cents in cash for every dollar of expected claims.

The subsidies will be distributed at Ms. Sebelius's discretion - no prizes for guessing which groups will be "certified." Indeed, an explicit stipulation of GM's health care agreement with the UAW was that GM would join the union in lobbying for a nationalized health care system to eventually transfer its obligation to taxpayers.

The Sebelius giveaway will supposedly expire in 2014, but Democrats can be counted on to keep coming up with plans to put taxpayers on the hook for all the unaffordable promises made to unionized workers by their public and private employers. That political imperative has all along been the driving force behind initiatives like ObamaCare.



## DEFICITS AND TAXES ON THE DRAWING BOARD

Democrats ok spending \$2 for each \$1 in long term taxes. As European governments take out their meat cleavers to spending and raise taxes across the board, Washington has adopted the path of austerity. Congress is ready to pick up the tab for a lot of the stimulus needed to get the economy moving again provided it can pay over 10 years. The lower the cost of a jobless society and tax credit extended and paying \$23 billion provisions in Medicare-physician costs passed as a "doc-fix" amendment. The bills have a \$112 billion short term cost, and could be partially paid for with \$60 billion in long term tax increases on investment funds, oil companies and multinational corporations. The Senate approved \$47 billion in deficit spending tied to Afghanistan and Iraq. The Democrats in Congress have only passed tax increases with a \$90 billion fee on banks. The Democrats may end up packaging the bank tax with extension of the middle-class tax cuts passed by President Bush that set to expire at year end. An extra \$47 billion in aid would close about 1/3 of the budget deficit faced by states at year end, said Nicholas Johnson state fiscal director

of Business & Policy Priorities. Senate negotiators are reported looking at a tax hike on investment fund managers. The increase could raise the tax on fund managers to 38.5% from 15%.

The major Indexes fell Friday as a down grade in Spain's debt took center stage. The NASDAQ fell .9% and the S&P and Dow Jones fell 1.2% each as the NYSE fell 1.5% on the eve of the holiday weekend. The markets general health leaves a lot to be desired. Three of the four major Indexes are stuck under their 200 day moving averages. It wasn't that long ago that the Indexes were far above that line. A turnaround is necessary if we have patience. In four of the last 10 years a sustained rally historically started in August of those years, so patience is necessary as with the market in correction, stocks buys are risky. Stocks such as Comstar, Boston Beer, Overstock.com, Impax Labs, FS Networks, had posted gains in the 15% range.

Consumer spending defied forecasts for a .3% gain. Incomes climbed and real disposable income rose by 1.5%, the most in a year. The savings rate rose to 3.6%, and the University of Michigan Consumers Index rose vs. .5% from April.

Apple rose 1% on Friday before Memorial Day. It sold 1 million of its Ipad in Australia, Canada, Italy, Spain and Switzerland. Apple sold 1 million of the devices in the U.S. in just 28 days. The Chicago Business Index fell 4.3 points in May. The jobs gauge dropped to 40.2% a sign that employers may be growing anxious amid European debt crisis and a slow down in China. The order backlog fell sharply with IBM's U.S. manufacturing index weak. Retailers did well! Shoe retailer DSW's EPS quadrupled to .67%, topping views by .18¢, driven by a 16.2% same store sales gain. Auto parts retailer, Auto Zone, topped views helped by new store openings. Cosco Wholesale, Rose 21. Dress Barn and JoAnne stores and American Eagle Outfitters all beat views. The week was weak on rivals that weighed on the market.

Many rebounding stocks carry a heavy burden with overhead supply. The stock has traded higher and people who bought there are waiting to break even, and sell when the stock recovers, to their entry point. There are many stocks new in this position and it takes time to recover when they sell, the recovery stops. There is a lot of supply areas that are more than two years old, but you need to be concerned about recent over supply areas. Quality stock such as Apple were able to fight through over supply. One should buy stocks reaching new highs as they are not burdened by overhead supply.

Barbara has been actively collecting pennies and other donations for this program over the past four years. Like a river that finds its source in miniscule streams increasing in mass as it this year.



other all over Italy and Europe. The Guelphs Party felt the Pope should have spiritual and wordly power. The Ghibellines felt the Holy Roman emperor should have worldly power and the Pope

Besides meeting her when he was nine, he did meet her again when he was 17 and as they passed each other she spoke one word to him: "Salute" (which can mean "hi" or "good health to you.") That evening he dreamed about her and all her beauty and splendor and

Boniface VIII put him under house arrest for 3 months and as he was returning to Florence, a friend in Siena warned him not to return to his beloved Florence for he and his sons would be tried and executed because the Black Guelphs Party (with the help of Pope Boniface and French troops) had taken over Florence and were killing, exiling, taking the wealth and property of the White Guelphs. And thus begins Dante's exile away

Italy had some small citystates (Florence, Genova, Venice, Verona, Naples, Sicily, and more. Rather than unite, they would wage war on each other and many times because they belonged to the Guelphs or the Ghibellines Party. Pisa favored the Ghibellines at one time so Florence waged war on Pisa because Florence favored the Guelphs and so on. The last major battle between these two parties took place in Benevenuto (near Napoli) in 1265 (the Guelphs won over the Ghibellines), and as a result Florence became totally Guelphs Party.

his endless love for her. Since he had fought in the

Florentine cavalry and had fought valiantly in the Battle of Campaldino (in 1289), he entered politics in 1295. He was elected City Councillor and took part in taking wealth and property from the Ghibellines party that lost in many battles in Tuscany, etc. As it often happens, when they were not fighting enemies, they began to fight among each other. The Guelphs divided into two factions: the White Guelphs and the Black Guelphs. Dante remained with the White Guelphs and became very important and became a troubleshooter all over Italy for Florence (something like Henry Kissinger was during the good Nixon era).

The White Guelphs and the Black Guelphs were not races of black or white people but were two political parties like Republicans and Democrats. Because of the bad Black Guelph political leaders (like Corso) and the nasty way Dante was treated by them, Dante will refer to Florence's neighborhoods, politicians, places and individuals in over 30 occasions in Dante's epic poem "Dante's Inferno." Florence continued to flourish under the Black Guelphs party but for Dante and his White Guelphs party members, it meant only exile and hardship.







...... Old Sturbridge Village will celebrate an old-fashioned military "Muster Day" on Saturday, June 12, with a special appearance by the 1812 Marines from Boston's U.S.S. Constitution, who will march, drill, and demonstrate field maneuvers alongside the Sturbridge militia. Active military personnel get a 50-percent admission discount, and members of their party get 25 percent off admission.

Fifers and drummers will play martial music, and children can "join the militia," learn to march and drill, and make a militia hat to wear and take home. Visitors can enjoy early 19th-century "base ball," French & English (tug of war), and crafts demonstrations, and head to the farm to meet the baby oxen, lambs, and piglets and help the farmers with late spring work. In early New England, the militia was somewhat similar to today's volunteer firefighters, and its ranks were filled by farmers, craftsmen, and other male citizens in town. At least once a year, these folks were "called to muster," and spent a day in training. "The 1830s were peaceful years in New England," notes OSV curator Tom Kelleher, adding that muster days also offered festive recreation, including a way to skirt the temperance laws banning the sale of alcohol in the 1830s. Those thirsting for liquor could pay a few cents to enter a tent to see a "striped pig," and also get a "free" shot of rum. Muster Day visitors to Old Sturbridge Village can see a real pig, striped just for the occasion,

and get a free glass of lemonade as a stand-in for the rum.

#### SJC-10513 SUPREME JUDICIAL COURT OF MASSACHUSETTS January 5, 2010, Argued • April 8, 2010, Decided

Cumming Properties, LLC (Cummings), owns an office park in Beverly (complex). Dr. Beverly (Shafer) leases a suite for her medical office at the complex. Shafer and Cummings entered into a commercial lease for the medical office premises on July 1, 2006. Per the terms of the lease, the leased premises consist of approximately 3,996 square feet, plus a 15.4% share of the common areas. Shafer's liability insurer is Norfolk & Dedham Mutual Fire Insurance Company (Norfolk). Cummings's liability insurer is OneBeacon Insurance Group (OneBeacon).

On July 19, 2007, Ellen Morrison (Morrison), Shafer's patient, arrived at the complex for an appointment with Shafer. She parked her vehicle in the parking lot located on the east side of the complex, near the main entrance. The entrance to Shafer's office, where there is also a parking lot, is located on the west side of the complex. After getting out of her automobile and approaching the complex, Morrison alleges that she tripped and fellon a newlyconstructed cement curb. Morrison brought a personal injury law suit in the Peabody Division of the District Court Department on

February 15, 2008, alleging negligence on the part of Cummings and Shafer. The lawsuit remains pending.

Cummings demanded that Dr. Shafer's insurance company (Norfolk) defend the suit. Norfolk refused to claim Cummings insurance Company (OneBeacon) is responsible for defending the suit.

There is a Massachusetts statute which states as follows:

Any provision of a lease or other rental agreement relating to real property whereby a lessee or tenant enters into a covenant, agreement or contact, by the use of any words whatsoever, the effect of which is to indemnify the lessor or landlord or hold the lessor or landlord harmless, or preclude or exonerate the lessor or landlord from any or all liability to the lessee or tenant, or to any other person, for any injury, loss, damage or liability arising from any omission, fault, negligence or other misconduct of the lessor or landlord on or about the leased or rented premises or on or about any elevators, stairways, hallways or other appurtenance used in connection therewith, shall be deemed to be against public policy and void.'

The trial judge decided that the lease providing that the landlord could escape liability was void because it violated the statute above.

The case was appealed to the Supreme Judicial Court.

The Supreme Court decided that the statute providing that the landlord could escape liability was void. But it also said that an agreement between a tenant and a landlord providing that the tenant is required to include the landlord in the policy as being and additional insured is valid.

The court said:

In this case, the insurance provision of the lease required that Dr. Shafer purchase liability insurance protecting both herself and Cummings in the event of injury and that Cummings be added as an additional insured on her policy. This distinguishes it from those cases in which there is an indemnification provision in a contract, and the indemnitor is required to procure insurance to insure his indemnification obligation.

So a landlord can require you to include his name as an additional insured in your policy but he cannot escape liability by including him as the insured he is covered. So if you are a landlord have a tenant include you in the policy.

People are so obsessed with hygiene these days that kids are growing up in increasingly sterile environments, says a report from the University of Montreal. This means they are less exposed to pollen, dust and cat dander — so don't build up a natural resistance to bacteria.

Does spanking kids turn them into bullies? Next time you swat your toddler on the butt for misbehaving, be warned — it could come back to haunt you. A slap may make a kid do as they're told in the short term, but it can have a negative impact as they grow older, reports Tulane University. Researchers found spanked 3-year-olds were twice as likely to get into fights and be aggressive by the time they reached 5.

And Glenn Miller's 1940 band included the likes of Billy May, Hal McIntyre, Tex Beneke, and Ray Anthony; each of which later had successful bands of their own. ## ALMOND-FLAVORED BUTTER COOKIES

3 eggs 1/2 cup sugar 2 sticks softened butter (1/2 pound) 3 cups flour 1 1/2 cups flour — separate 2 teaspoons baking powder Cookie cutters of choice \*1 teaspoon almond flavoring (optional)

#### ICING:

1/3 cup melted butter

1 box Confectioners sugar

"Jimmies" (sweet toppings) or nonpareils

\*1/2 teaspoon almond flavoring (optional)

In a bowl add cream sugar and softened butter. Add beaten eggs and mix thoroughly. Measure out three cups flour and place in a separate bowl. Add baking powder to flour and stir. Gradually add this to the sugar, butter and egg batter. This will become soft dough. Spray two cookie sheets with vegetable or butter spray and set aside.


Spread some flour on a pastry board. Spoon a portion of pastry dough onto floured pastry board. Sprinkle some flour over dough. With your hand or rolling pin spread dough out to about 1/4 inch thickness. Before cutting each cookie, dip cookie cutter into flour. Then place cut out cookie onto greased baking sheet. Continue until all dough has been used. Bake in preheated  $350^{\circ}$ F oven. Baking time is about ten minutes. Bottoms will brown slightly. Remove from oven and place baked cookies on a tray to cool. Makes about four dozen.

**ICING:** Melt butter in top pot of a double boiler. Add almond flavoring. Gradually add confectioner's sugar to mixture until you have soft icing. Using a pastry brush, spread icing on one cookie at a time. Immediately sprinkle your choice of "Jimmies" or nonpareils over the icing. Set cookie aside on a tray. Continue icing in this manner.

 $\ensuremath{^*\text{Use}}$  you own favorite flavoring in the cookie dough and icing.

NOTE: This is an easy recipe to prepare for a holiday or birthday party. The colorful cookies are a favorite of my children and grandchildren. They store well in a canister.



It was time for a new car. Dad had been driving a 1938 Plymouth two door sedan since the car was a year old. It was now 1949, and the car had seen better days. There was no rear bumper and the trunk wouldn't close. The inside smelled like a cigar ashtray and was just as drab. The only options, after market add-ons were a heater and a radio. The engine was on its way out and Dad, one afternoon, was standing across the street looking at a new 1949 Chevy that a neighbor had bought. It was a two door deluxe fast back with white walls, full wheel covers and a coat of the shiniest black you ever saw. Looking inside, the seat covers were patterned and the steering wheel was a marblized off white color. I looked up at my father's face and could instantly tell that he had fallen love.

Tony, the neighbor said that he had just picked up the car at Reese Chevrolet, a long gone dealership that existed in the Day Square area of East Boston. Dad asked if Tony could accompany him on a trip to the dealership and he agreed. I jumped into the back seat of the old Plymouth, Tony took the co-pilot's seat and Dad climbed in behind the wheel. We were off on a five minute journey that would take us to Day Square and the car dealership.

As we walked inside, the salesman who had handled Tony's transaction, spotted him and approached us. He was introduced to Dad with the added information that we were neighbors and that Dad was looking for a car. There were several that were in the show room, a convertible, a couple of four door sedans and 2 two door modelsone a fast back and the other a squared top coupe. As Dad and the salesman conversed, Dad remembered a problem he might have purchasing a car and explained it to the salesman. Dad played bass violin and his instrument was quite large. If the instrument couldn't fit into the car, then the vehicle would be useless to my father. Now, Dad liked the fast back that our neighbor, Tony, had bought, but wasn't too sure about the room inside. He examined the one on display and it was almost identical to the one Tony had purchased. Plush interior, black in color, white walls, full hub caps, and a marbleized off-white

look on Dad's face, the salesman told him that he could give him a deal on the new car, and part of the deal depended on the car my father was trading in.

You then had to lift the instrument so the back could rest on the top of the vertical part of the seat, while making sure that the bridge didn't hit the courtesy light on the ceiling. The peg or tail stock had to be facing the rear window and the scroll atop the neck pointing toward the dash or front wind shield. 



To the Pope's warm welcoming address, Giuseppe Tornatore, the director of the celebrated "Cinema Paradiso" observed: "the Pope's address was a sweet touch to culture at a time when we get only slaps on the face"!

A call to international events came an Iranian writer, Kader Abdolah, who attended the meeting wearing a green scarf in homage to the Iranian people who are looking for freedom hoping that their voice will be heard even inside the hall of the temporal power (of the Popes). 
