## Special Olympics Torch Run

Last Friday, June 10th, this area's leg of the Law Enforcement Torch Run for Special Olympics of Maine took place from Calais to Machias. Taking part in the first several miles were many US Customs and Border Protection Officers.

The Law Enforcement Torch Run began in 1985. Each year, approximately 600 members of Maine law enforcement run approximately 800 miles across different areas of the state. This all begins the Tuesday prior to the Special Olympics Summer State Games and concludes at the Friday evening opening ceremonies, as the torch is carried into the stadium.

Special Olympics of Maine provides year-round sports training and competition in 17 Olympic-type sports, plus 3 Unified Sports opportunities, for over 4,000 children and adults with intellectual disabilities throughout Maine. It relies 100% on charitable gifts to fulfill its mission of enhancing the lives of its athletes.

Runners raise funds for the Special Olympics Maine in various ways, and to date, have raised well over one million dollars, according to its fundraising website page. Locally, runners sought pledges for the run, which is dedicated in memory of Chief Deputy Shawn Donahue, who passed away unexpectedly two years ago.

# Fewer Personal Vehicles into Calais for Q1 2016 vs. Q1 2015

According to the United States Department of Transportation and its Bureau of Transportation Statistics, first quarter 2016 saw a decrease in personal vehicles crossing into Calais from Canada compared to the same months in 2015.

Reports show 139,478 personal vehicles, which transported 199,866 people, crossed through the border into Calais from Canada during the first quarter of this year. These numbers are a decrease from what was recorded during the same time frame just one year ago.

In 2015 during January through March, 167,873 personal vehicles entered through Calais' three ports of entry from Canada. These transported 241,267 people into Calais.

Also decreasing in 2016 from 2015 during the months of January through March were the number of buses crossing

into Calais from Canada. In 2016 during the first quarter, only 15 buses crossed, bringing with them 385 people. In 2015 in the same time frame, twice as many buses had come through and carried with them 872 people.

Loaded and empty truck containers totaled 7,593 and

3,387, respectively, in first quarter 2015. These numbers increased for 2016 to 10,003 and 3,492, respectively, for the first quarter.

These figures have been compiled from reports from Ferry Point, Milltown, and International Avenue border crossings.

# WES Students Become Scientists for a Day

The fifth and sixth grades at Woodland Elementary School traveled to Portland last Friday, June 10th, for a fun, yet educational, experience. The students had the opportunity to visit the Gulf of Maine Research Institute (GMRI).

The institute focuses on stewarding the ecosystem, cultivating science literacy, supporting sustainable seafood, and strengthening coastal communities. While at the facility, the kids participated in GMRI's LabVenture! experience.

Working in small teams, the Woodland Elementary School students explored and answered questions related to the gulf. Some of those questions included: How are cod and lobster connected? Are we farming lobsters? How can we make fisheries more sustain-

able? What impacts will climate change have on the Gulf of Maine ecosystem?

LabVenture! connected students to science in ways that allowed each to understand and become aware of the science that surrounds their everyday lives. Students had the opportunity to conduct their hands-on research with use of microscopes and various measuring tools. They demonstrated skills of critical thinking, problem-solving, and reasoning, while

getting a first-hand, up-close look at live lobsters and other sea life.

The LabVenture! program is the first part of GMRI's continuum of 5th through 8th grade education programs designed to cultivate a scientific literacy and active Maine students to become lifelong STEM (science, technology, engineering, and mathematics) learners.

**Cool Weather Gardening**

When IS it going to get warm? If you have your garden planted as I do, and keep looking at the weather with concern for all those plants, take heart! There are ways to help protect your investment until summer temperatures finally decides to get here.

Row covers are an inexpensive way to keep your plants a few degrees warmer than the outside air. This breathable fabric comes in a roll that you can cut to fit your bed. It's very lightweight and meant to keep out bugs. An extra benefit is that on cooler days (and nights) by pulling the row cover over your plants, the heat stays in around the plants all evening. Just remove the covers if the sun decides to shine, and you will see your warmth loving plants thrive.

Also, consider this extended cool season a reason to grow more cool weather crops like broccoli, cauliflower, peas and root vegetables. In our house, one can never have enough broccoli. Usually by now, these plants have suffered the heat and gone to seed. This year, the harvest is still going strong with cooler temps helping.

Don't forget the cool loving herbs! Mint and cilantro come to mind. You can never have too much of either flavor, and once the heat gets here, these herbs will go to flower, and their flavor is reduced.

All in all, although we want to see warmer temperatures, we can still enjoy our gardens despite the stubborn season change.

## Princeton Fire Station Open House

On Saturday, June 11, on what was as perfect a day as Maine gives, the Town of Princeton Fire Department celebrated its new fire station.

Well over 100 people attended the open house from 11:00 a.m. to 1:00 p.m. First on the program to welcome everyone was Scott Carle, Chair of the Princeton Board of Selectmen. He introduced Pastor of the Sunrise Christian Church Ernest Carle, who led a prayer and gave a special blessing for the new fire station. Youngster Courtney Leighton sang the national anthem. Then select board member John Leighton gave thanks to one of the early planners, Jim Davies, who five years ago said, "We need a new fire station," as well as all those in this very small town who helped along the way. Also he praised the ability of Princeton to build a new fire station without raising taxes due to the diligence, planning and thrift of the town's earlier officials.

Select board member Doreen Wallace gave a history of the naming the station the Rolfe House Station. Originally the Rolfe family's home was here and it was one of the oldest in Princeton. Unfortunately it had deteriorated beyond repair and after much thought, it was the best choice to locate the fire station. The Rolfes were one of Princeton's earliest families.

In attendance was Maine Representative Beth P. Turner who has always been supportive of area events, and who congratulated Princeton and its citizens on a job well done. Also attending was Representative Joyce Maker who is running for the office of State Senator. She mentioned that her husband was a fire fighter and thus, had an understanding of the importance of local fire departments.

A special presentation was made by three young children and Penni Theriault from Princeton day care Lots of Tots. The fire department has a very long history of doing fire safety programs for the children of the community and they wanted to do something special. They kept a fire boot by the door which the

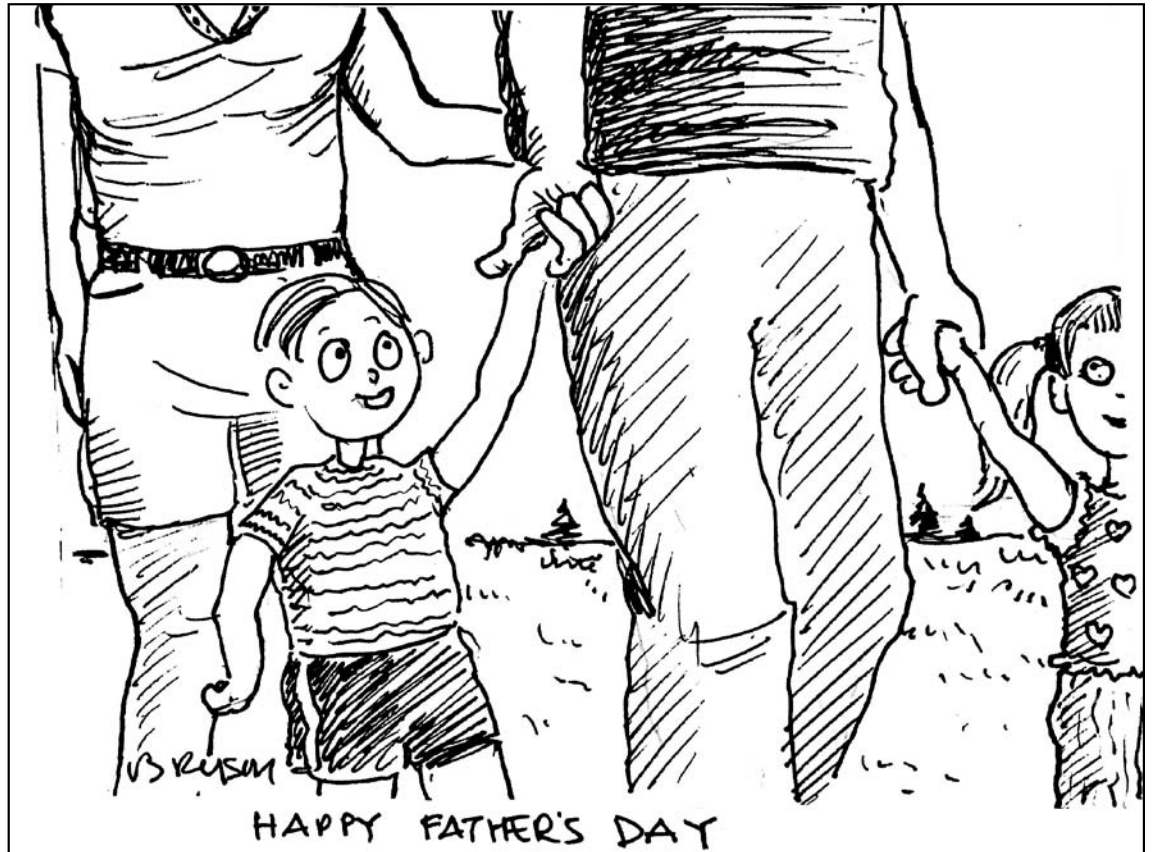


children filled with their donated change. A large painting of a fire truck and activities was given to Fire Chief Tony Ramsdell and his volunteer fire fighters.

He gave credit to all his volunteer fire fighters as well as communities with fire departments and how they all work together to provide mutual aid to surrounding towns. He introduced Assistant Fire Chief Moses Cilley, who called up the town's fire fighters to join him which resulted in a hearty round of applause for all.

Then it was time to enjoy the grilled hot dogs, full table of specialty salads and another table of delicious desserts provided by the generosity of the volunteers who are always willing to donate to a good cause. Tours of the station were given, the guest book was signed by many, and a drawing was done for a replica toy fire engine. Young Evan Monk won the truck and was a surprised and happy boy.

Our town may be small, but our dedication and enthusiasm is large and 100 years from now we hope that the fire station is still in place and that Princeton is as special to its residents as it is today.

## Downeast Salmon Federation Acquires New Site

Downeast Salmon Federation has acquired a historic mill site and home on Whiting Corner. Plans are underway to renovate this historically significant home and improve the heritage fishery. Fish passage restoration in the Orange River could rejuvenate river herring

populations (alewife and blueback) and other sea-run fish such as shad, Atlantic salmon, eels, lamprey, and brook trout. A healthy fish migration would revitalize the ecosystem and provide a source of income for local fishermen.

The next step for the

Downeast Salmon Federation is to hire a group of engineers to complete a feasibility study on the dam. The feasibility study is necessary to explore any and all costs related to providing adequate fish passage. As DSF is still seeking funding for this purpose, the process

could take multiple years to complete. DSF intends to have ongoing meetings with community members and groups to explore all feasible options for fish passage and to ensure that local heritage and values are a part of the decision making process. No decisions about the

dam will be made without full consideration and input from the community.

Nestled next to the St. Croix River, the 315-acre conservation area known as Devil's Head has been receiving a bit of grooming over the past spring. Volunteers and members of the Friends of Devil's Head group have been removing truckloads of branches, dead trees, and trash from the sides of the access road leading to the trail and the beach. As the effort continues, more and more community members are lending a hand to rehabilitate the scenic, woody park.

With the more obvious tree debris removed from the sides of the road and the low-hanging branches clipped back, the trip down to the start of the trail is a bit more enjoyable. Earlier in the year, the students of

Washington County Community College's Heavy Equipment program smoothed the road itself out significantly, removing its ruts and holes.

Once arrived at the riverbank, guests are invited to enjoy a picnic in the open area by the shore. Members of the Passamaquoddy Bay Symphony Orchestra have been clearing the picnic area, while Lyons Towing moved the windfalls at the lower parking lot to enlarge it for ease of access. A bench will soon be installed in the picnic area for visitors to take a moment and enjoy a sense of picturesque timelessness.

Visitors that haven't yet been to Devil's Head will soon be more accommodated. Plans are in the works to create a brochure indicating the ecosystems

and points of interest in Devil's Head. Indicator signs for the trail and a speed limit sign have been built by Brian Duffy and his class at St. Croix Regional Technical Center, with more planned once the school semester resumes.

The Friends of Devil's Hand is in the process of applying to become a 501(c)(3) corporation, which will enable it to apply for grants and hold fundraisers for future efforts. In the meantime, efforts will continue to improve the condition of the site and the trail.

## Machias, Eastport Students Participate in "Project Sticker Shock"

One Voice student groups at Rose M. Gaffney Elementary School in Machias and Shead High School in Eastport recently participated in "Project Sticker Shock," a youth led initiative to change adult attitudes about selling and providing alcohol to minors. On May 27th and 8th grade Gaffney students affixed fluorescent orange and black stickers on containers of alcohol, especially beer, at Machias Foster's On the Run. Shead students completed a similar activity at R&M IGA in Eastport on June 9th. The highly-visible stickers are a strong reminder for consumers: "Providing Alcohol to Minors is Illegal! Fines are up to \$2,000 and/or up to one year in jail!"

Alcohol has been identified by the Maine Office of Substance Abuse as the number one drug of choice among Maine youth, and according to local youth, one of the easiest substances to obtain. "Project Sticker Shock" is sponsored by the Maine Office of Substance Abuse and hopes to cause adults to think twice before making it any easier for youth to access alcohol. One Voice youth groups, local beverage retailers, and the state police want to remind adults that providing alcohol to minors or allowing them to drink in a place under your control is against the law, and it carries the same penalties under the law as furnishing, even if you don't supply the alcohol.

"Sticker Shock' is a way for students like us to tell people in the community that providing alcohol to minors is not okay," said one Rose M. Gaffney student. "Adults and older teens need to be role models for the younger generation and everybody needs to be a part of the solution."

Healthy Acadia and participating students would like to thank Machias Foster's On the Run and R&M IGA in Eastport for their desire to sell alcohol responsibly and support the group in their efforts to inform the community about underage drinking. "A strong community message is sent when local businesses take responsibility for speaking out against underage drinking," said Jenny Robish, Community Outreach Coordinator for Healthy Acadia. "Stores like these are working together with youth to create safer, healthier communities by combating the problem of underage drinking."

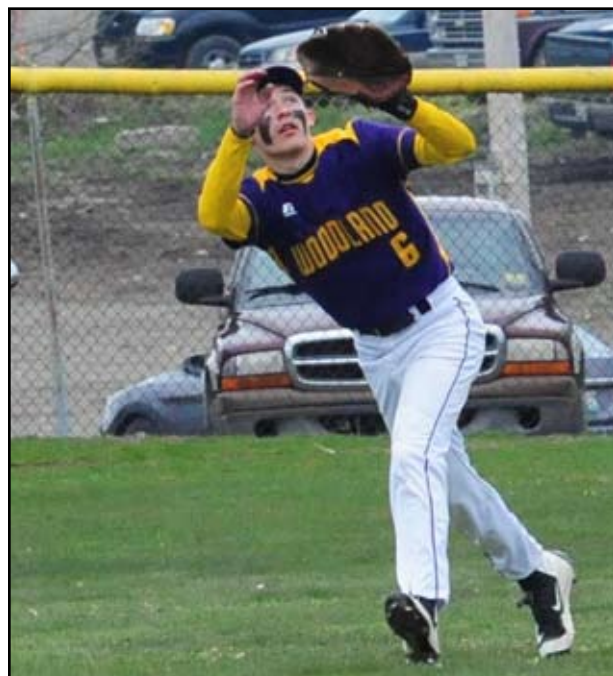

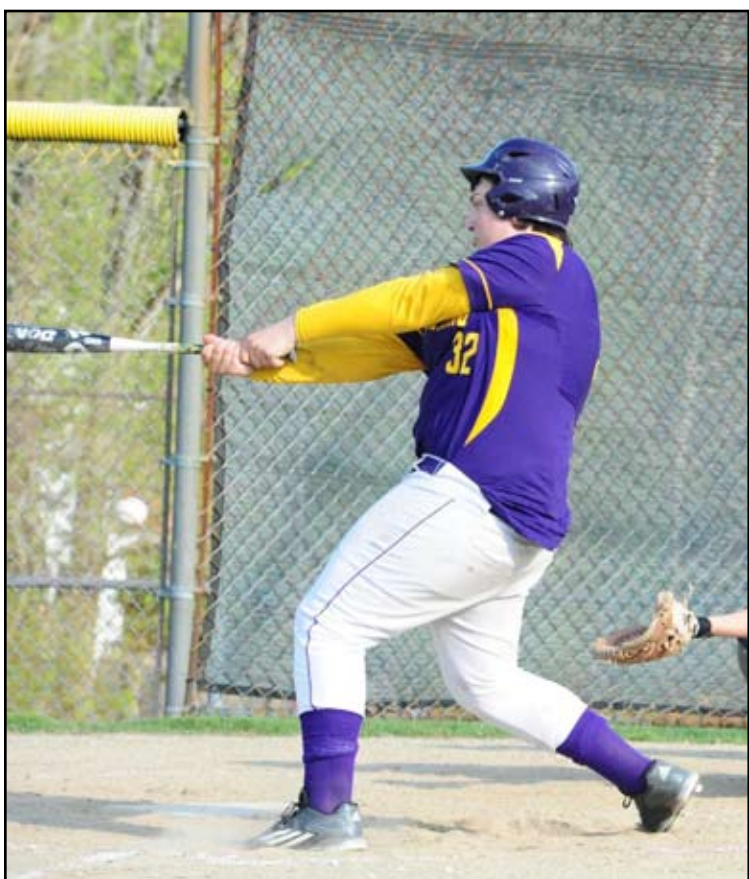

# A Story and a Recipe

The list of the vessels built in Robbinston in the 1800s made me realize that the whole St. Croix River must have been a bustle of activity. Builders and merchants in Calais, St. Stephen and St. Andrews were also putting out great vessels so it would seem that the every little inlet along the St. Croix shores would have a stocks and docks.

In addition to the economic developments enhanced by the shipbuilding industry, the town was very active with its mills, construction, lumbering and social activities. Hayden writes in his diaries, "There were raisings, bees, corn husking, quilting parties and square dances. The church was an important center," (A Catholic Church was built on the land that is now Tom Brennan's back yard.) "and the one room school house was in session for a while in the winter if a teacher of sufficient courage could be found." Hayden taught several terms at the school and in 1832-1833 Hannibal Hamilton of United states Vice-Presidential fame for Abraham Lincoln's first term was the teacher at the Robbinston Ridge until the chimney collapsed and brought a quick end to the term. (Hayden Diaries)

For all practical purposes the shipbuilding trade was on a downhill slide. In May of 1857

the Calais Advertiser published, "All those heretofore engaged in the business (shipbuilding) in this city and Robbinston have abandoned it and gone about some other business. The Robbinston shipbuilders we understand have mostly gone to farming. The Eastport Sentinel published in July of 1857 wrote that the only hammers that could be heard in Robbinston were the hammers of the auctioneers.

History demonstrates that Robbinston was once a successful town with wealthy and industrious residents. Unfortunately, we can find nothing of the 15 shipyards that were located from Red Beach through Robbinston. What do remain as products of the economic boom in Robbinston are the three historical houses, which were built by the wealthiest residents of town, and the Grace Episcopal Church, which are all listed by the National Register of Historic Places.

All of the information on the history of Robbinston has been gleaned from several sources and I have loosely footnoted my sources as I have brought forth the information. The history and descriptions of the three exceptional homes and the church that are the remaining products of the shipping building era in Robbinston can be found on the National Register of Historic Places or in some of the many books that carried bits

and pieces of information.

"The 'Mansion House' was built around 1785 by John Brewer. It is a Federal Period house, which faces southeast toward the river. It is a two-story wood frame with a square main section and a rectangular ell on the north side. It has often been called the "Mount Vernon of the St. Croix." The façade that faces the river is five bays wide. An open single story piazza extends across three bays and is supported by round columns. The main entrance is flanked by sidelight windows topped by a Federal style fanlight window with 1785 etched into the glass. The building has two stair cases, fireplace mantels, wooden wains coating and the ground floor has single planks of pine 30 inches wide. John Brewer was also a general in the State Militia in the War of 1812 and it is said that the cupola of the house was used as look out for the arrival of military forces."

The next house listed in the National register of Historic Places is the magnificent building that I grew up calling 'The Dr. Armstrong House.' John N.M. Brewer, son of John Brewer, built it in the late 1820s. "It is an amphiprostyle Greek Temple residence with temple colonnades both front and back. It is a two-story wood frame building and has been associated with the Underground Railroad's last connection before former slaves were transported to Canada.

"The Henrietta Brewer House, now the Redclyffe, is the most authentically Gothic House in eastern Maine. This two and a half story wood frame was built between 1861 and 63 by John N. M. Brewer, son of John Brewer for his wife Henrietta. This building has ornate Gothic features along with styles for the Greek Revival Period of architecture. It has lancet-arched windows with

carred-hoods. The two major north and south gabled sections are joined by traverse sections. It has the only major example of pointed huge Victorian Gothic style windows." This building is now a restaurant in private ownership.

The Grace Episcopal church was built in 1882. "It is a single wooden frame structure combination of clapboards and board and batten siding. Peter Henry Steenstra of Cambridge, Massachusetts and a summer resident of Robbinston held services there until 1993." In 2000 this building was sold to the Robbinston Historical Society, which has restored it and added another building to the property.

Other buildings from the shipbuilding era in Robbinston will be briefly mentioned next week. I now have to get to the recipe of the week, Rhubarb Crisp.

### Rhubarb Crisp

#### Ingredients:

- One cup light brown sugar, firmly packed
- One cup all-purpose flour
- Three-fourths cup quick cooking rolled oats
- One-half cup melted butter
- One teaspoon cinnamon
- Four cups diced or sliced fresh rhubarb (about one-inch pieces)
- One cup granulated sugar / Two tablespoons cornstarch
- One cup water / One teaspoon vanilla

*Method:* Heat the oven to 350 degrees. Butter an 8-inch square baking dish.

In mixing bowl, combine the brown sugar, flour, oats, melted butter and cinnamon; mix together until crumbly. Press half of the brown sugar and oat mixture into the prepared baking dish. Top with the sliced or diced rhubarb. In a saucepan combine one cup granulated sugar, cornstarch, and the one cup of water and vanilla. Cook together, stirring, until thickened and clear. Pour the thickened syrup mixture over rhubarb in the baking dish. Top the rhubarb filling with the remaining crumb mixture and bake in the preheated oven for 45 to 55 minutes or until the topping is browned and the filling is bubbling.

Maine's forestry community continues to protect water quality during timber harvests

The Maine Forest Service has released the results of a

study on the use and effectiveness of forestry Best Management Practices (BMPs) at timber harvests across the state from 2014-2015. BMPs are voluntary measures used to protect water quality. BMP use and effectiveness at timber harvesting operations is monitored regularly by the Maine Forest Service's 10 District Foresters. The results of these monitoring efforts are reported biannually.

The following are key findings of this year's report:

Eighty-five percent of sites had BMPs applied appropriately on crossings and approaches, or crossings were avoided.

BMPs were effective at preventing sedimentation from entering waterbodies.

Ninety-two percent of opportunities evaluated for sediment input found no sediment entered a waterbody.

Wetlands either were avoided or effective BMPs were used to cross.

"Maine's forestry community continues to take seriously the protection of water quality," said Maine Forest Service Director Doug Denico. "Our ongoing monitoring efforts in-

dicating the value of the education and outreach work we've done with our many partners."

Students and teachers from several schools across the state, in conjunction with the Maine Department of Inland Fisheries and Wildlife, are capturing and radio tagging great blue herons to learn more about herons and their habitats.

The student's job, equipped with binoculars, minnow traps, and fish ID cards, is to locate a foraging heron in their area and then catch fish to use as bait to keep the herons coming back to the site. IFW wildlife biologist Danielle D'Auria, and a small team of researchers will then capture the herons using foothold traps set near the bait, and tag each bird with a GPS transmitter to monitor their movements for years to come.

The project is just one part of IFW's ongoing research into the state's great blue heron population. By marking and following individual adults over several years, IFW will gather new information regarding Maine's herons.

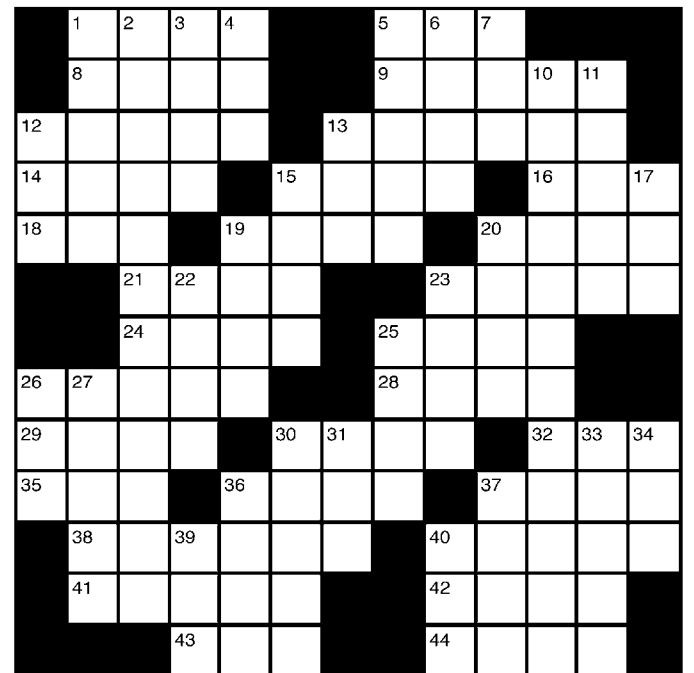

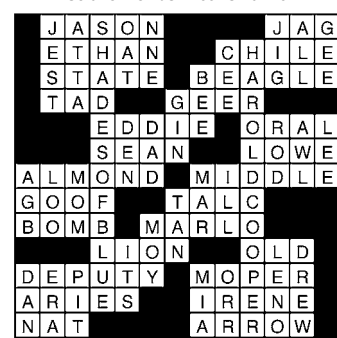
