

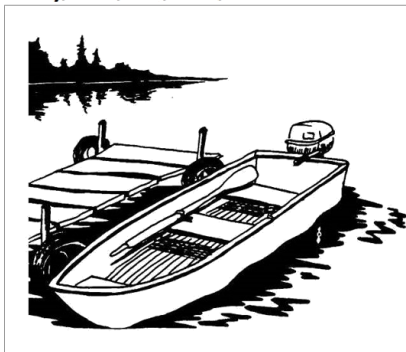

Your Lake Association At Work For You

Our association represents our six lakes and shares the McKeown Creek Watershed, covering an area of about 9 square miles or 5,793 acres. Your lake association membership is probably one of the greatest return on investments you could ever receive. Your \$35 annual membership fee is going a long way and we **Thank You** for being a member of the organization and for your support. Here's a list of many activities the association supports for all of us:

1. **I-Lids monitoring** of the only Public boat launch within our 6 lakes (Baby Lake).
2. **RMB Water Sampling** which is done every other year on every lake. (This helps detect pollutants to our lake system.)
3. **Beaver Trapping** – This is done to ensure lake levels remain consistent to alleviate erosion or other problems that may occur due to high water levels on lake fronts.
4. **Buoy Placement and Maintenance** – Yearly placement and removal of buoys on our area lakes as well as periodic replacement and repair of buoys.
5. **Newsletter** – The creation and distribution of the yearly newsletters to keep all of us informed and up to date on activities happening within our community also has costs associated to it.
6. **Lake AIS/Vegetation Surveys** – These surveys are done to help baseline aquatic plants and also help identify early any AIS infestation.
7. **Signage** – We actively update signage at the Public boat landing as well as install warning signs and add security at other privately used boat launches.

Cass County Infested Waters List as of August 2021

The Minnesota Department of Natural Resources (DNR) maintains an Infested Waters List of waters containing high priority aquatic invasive species. The DNR will add a lake, river, pond or wetland to the infested waters list if it contains one of these aquatic invasive species. The DNR may also list a lake, river, pond or wetland as infested if it is connected to a body of water where an aquatic invasive species is present.

About 8% of Minnesota's more than 11,000 lakes are on the infested waters list. Less than 3% of Minnesota lakes are listed as infested with zebra mussels. As of October 2019, we have confirmed zebra mussels in 214 lakes and wetlands. We have listed 194 bodies of water as infested with zebra mussels because they are closely connected to a waterway where zebra mussels have been found. 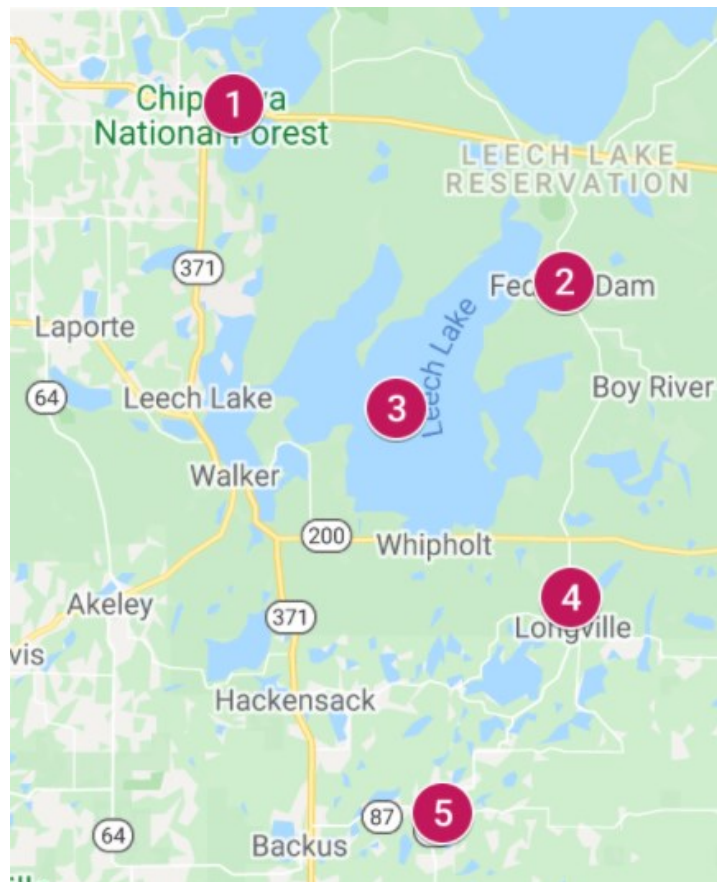

It's Good to Know



CLEAN DRAIN DRY

We all can help stop the spread of aquatic invasive species. Take these steps **every time** you leave a lake or river - whether or not it's infested.

- **Clean** all aquatic plants, zebra mussels, and other invasive species from boats, trailers, and water-related equipment. Spray with high pressure water.
- **Run motor or personal watercraft** for a few seconds to discharge water before leaving the water access.
- **Rinse watercraft** with very hot water. Hot water temperatures will kill zebra mussels and some other AIS according to the MN DNR: 120°F for at least 2 minutes; or 140°F for at least 10 seconds.
- **Drain** water from your boat, ballast tanks, motor, live well and bait container. Remove drain plugs and keep drain plugs out while transporting equipment.
- **Dry your watercraft for at least 5 days before re-launching in another lake**
- **Dispose** of unwanted bait in the trash. To keep live bait, drain the water and refill the bait container with bottled or tap water.
- **Transport fish on ice** – be prepared, bring a cooler.

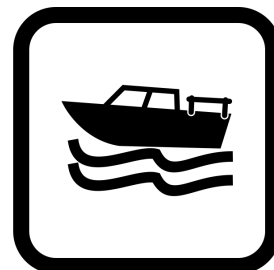
A Friendly Reminder

Thank you for sharing with your families, friends, and guests the importance of following the laws, using common sense, and showing courtesy to others while on the water and near shorelines. Property owners, those fishing, swimming, or in a kayak; all depend on each of us to be mindful of the laws designed to safeguard our flora and fauna, and the experiences we share and value when visiting the cabin. An e-copy detailing [Minnesota Boating and Watercraft Regulations](#), that includes permissible hours to ski or operate personal watercraft, and laws relating to speed and distancing on the lake, can be found on the Minnesota DNR website. It's the LAW: You may not ...

- Transport watercraft without removing the drain plug.
- Arrive at lake access with drain plug in place.
- Transport aquatic plants, zebra mussels, or other prohibited species on any roadway.
- Launch a watercraft with prohibited species attached.
- Transport water from Minnesota lakes or rivers.
- Release bait into the water.

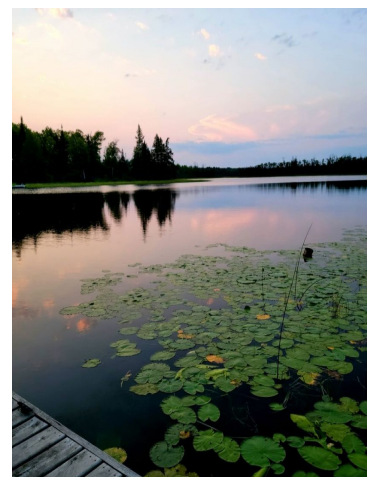

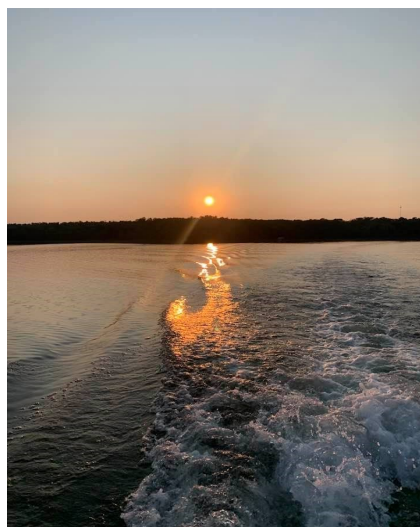

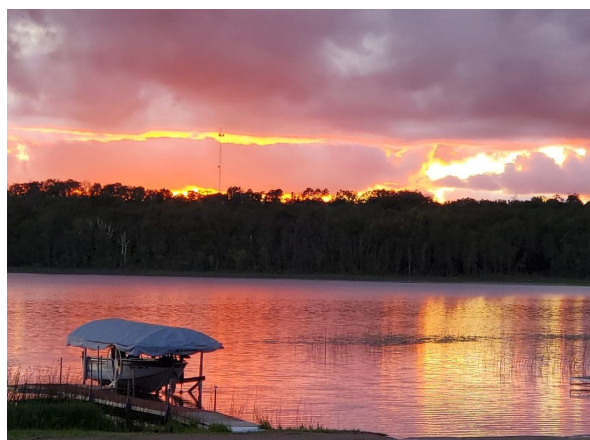

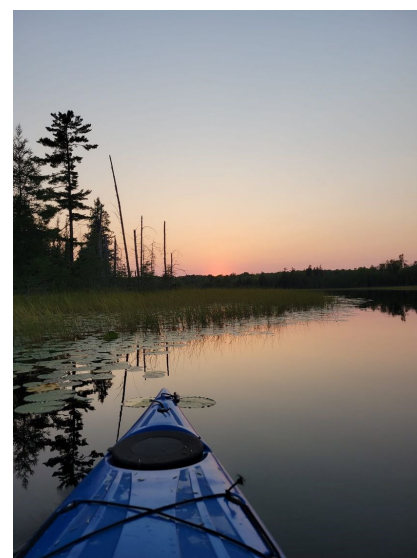

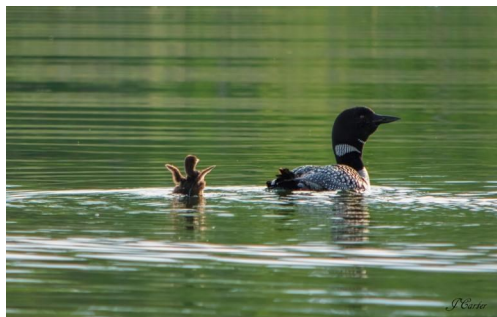

30 years of Community Service: The Third Decade

It has been over 30 years since the birth of our organization and time to reflect. Today we look back on 2009 to 20018:

2009: Annual meeting held at Deep Portage. New bylaws adopted, including one vote for each deeded property. Membership 183. Idea of

emailing Lake Link proposed. Continuing update on Lakes Management Plan. Invasive species a topic, President Tom Lindquist reported seeing 30% to 50% of boats being put in Baby Lake with aquatic weeds attached, even though this is illegal. Creating a common sign board for names suggested for corner of 14th Ave and County Road 5. Member reports that for the first time in 10 years he witnessed parade of 30 pelicans swim by, followed later by his first spotting of trumpeter swans on the lake. Last year, a trapper took out 63 beaver and this year 8.

2010: Annual meeting held at Deep Portage. Buxton Road - Man & McKeown erosion issue reviewed. Received grants from Initiative Foundation (for the second time) to offset expenses related to a comprehensive planning process for all six lakes. Water samples taken. Started working with local software expert Tom Pingel of TCP Management Solutions to develop a database for tracking memberships. No Wake sign installed at boat landing to remind boaters after buoys have been removed from lake. 5 beaver dams and debris removed between Kid and Baby Lake. Following the 2010 BP Gulf spill, loon counts were initiated. Membership: 201.

2011: Annual meeting at Union Congregational Church (UCC). Six loon nesting platforms were anchored near shorelines of our lakes during first week of May. Volunteers continue using Secchi disks to measure water clarity. Membership software is working great! Membership total is 210.

2012: Annual meeting at UCC drew approximately 85 members. Vote was passed to raise membership fees from \$20 to \$25 a year beginning in 2013. Vegetation assessment (over 100 pages long) completed at Baby, Kid, Kerr and Lost lakes. Loon counting (adults and chicks) continues as annual activity. Walleye fingerlings stocked by DNR in October. "Loonledger" electronic messaging system created. 83 members made donations to "Special Projects". DNR baitfish study completed on Baby Lake. Membership increased to 216.

2013: Annual meeting at UCC. Aquatic Invasive Species prevention in our lakes gains increasing attention. Tom Lindquist announces his retirement as president after 6 years. Vote to limit the president's term to 2 years effective in 2014 passed to encourage volunteers. Ron Jandura steps forward as next President. Board members encouraged to recruit and mentor others. More and more turkeys are being observed in our lakes area. Volunteers continue water quality testing and Secchi Disk readings.

2014: Annual meeting at UCC. Multiple vacancies on the board prompted some changes. A 1-year trial was voted to outsource the Treasurer/Membership Chair, with

pay, to a non-member. Several meetings with DNR held concerning results of DNR Musky study. Also apprised by DNR plans to improve walleye stocking on Baby and Man Lakes and private stocking on Kid Lake. Usual Secchi disk readings and loon counts continue.

2015: Annual meeting at UCC. DNR to work on controlling water levels. Board volunteers/recruitment to fill vacancies are a critical issue. Basic activity loon counts, water testing, and newsletter continue.

2016: Annual meeting at UCC. Embezzlement by non-member contracted to fill Treasurer/Membership position hired in 2014 is discovered and reported to law enforcement. Bank account closed and new account opened to safeguard funds. Vacancies on board remained critical; need for vice president, treasurer and membership chair. The Membership Chair position is filled in the late fall of 2016 by a new property owner and is a member of the lake association. New Facebook page created for our members to share information and photos. Discussed and approved cost to repair or replace Clemson Leveler at stream between Kid and Baby lake due to beavers' heavy effect to Kid and Lost lakes. Request for additional watercraft inspectors at boat landing was denied by DNR. Water samples collected this year analyzed by RMB labs and all normal. Meeting with DNR advised they are taking bids to remove existing dam on south end of McKeown Lake and replace it

with a much more fish friendly Rock Weir Dam. DNR agreed to tag walleyes in Women Lake to try and track fish movement from Women into our lakes system. Membership approximately 185.

2017: Annual Meeting at UCC Church. Several members stepped up to fill vacancies on board for upcoming 2018 calendar year. Meeting with DNR concerning statewide Northern Pike spearing. Baby Lake is the only lake in the state to ban spearing for Musky protection. DNR made our association feelings known to legislature. Spearing ban remains in effect for Baby Lake. DNR advises

switching to walleye fingerlings is working (vs fry). Finances restored with \$1,676.74 recovered after the non-member treasurer plead guilty to theft. Steps to audit financials put in place. Rock Weir Dam completed. Membership: 210.

2018: Annual meeting at UCC Church. Rock weir dam completed, some adjustments made to improve water flow and reduce the higher lake water that was noted. Good fish movement noted. Water testing continues. Investigation into installing I-LIDS camera system at boat launch plan is initiated. 40 adult loons counted and 8 chicks.

Another Pig In a Blanket

Cook's Notes: A twist on your classic Pigs in Blanket game day snack using Puff Pastry, Roasted Red Pepper Chicken Sausage and sprinkled with Bagel Everything Seasoning.

There are several flavors of the chicken sausage product to choose from. It's GF, no nitrates, and no added hormones. You can make your own bagel seasoning ahead and store in a covered container or jar. Mix 1 tablespoon **each** poppy seeds, sesame seeds, dried minced garlic, dried minced onion and 1/2 tsp. kosher salt. Bagel seasoning can also be purchased in some stores in spice section and at Trader Joe's.

The recipe makes about 20 appetizers and begs to be served with a frosty cold beer .

Ingredients:

1 box puff pastry sheets, thawed (you will need both sheets)
1 package Roasted Red Pepper and Garlic Chicken Sausage
1 large egg, whisked
Bagel Seasoning
Honey Mustard Sauce

Directions:

Preheat oven to 400 degrees. Line baking sheet with a silicone pad or parchment paper.

Make sure each sausage is wiped dry.

Roll out puff pastry to a 9- 10 inch square on a lightly floured surface. Cut into 7 equal strips, then cut each strip in half.

Cut each sausage link into fifths and wrap a strip of puff pastry around each sausage bite and lay seam side down on baking sheet. Brush each puff pastry with beaten egg and sprinkle with bagel seasoning. Bake 20 minutes or until golden and puffed. Serve with a honey mustard sauce.

Honey Mustard Sauce

Cook's Notes: Takes 5 minutes to make and refrigerate until needed.

Ingredients and Directions:

Mix the following in a bowl using a whisk: 1/4 cup honey, 1/4 cup mayonnaise or Miracle Whip, 1/4 cup Dijon mustard, dash cayenne pepper, 1 tablespoon white distilled vinegar.

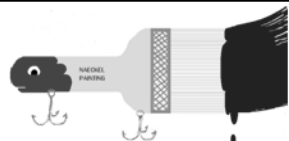

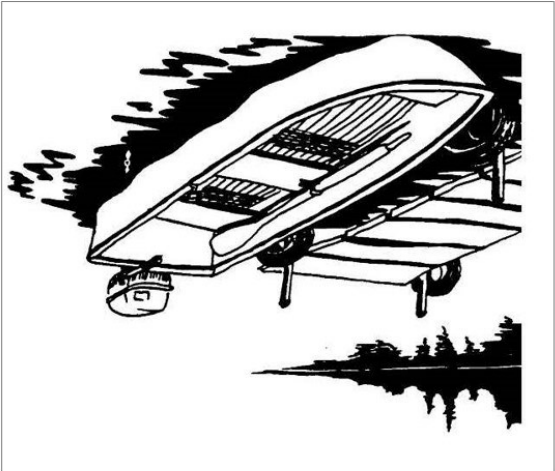
