



3/4-Day Reports from the "San Diego" and "Liberty" Charters

We have been lucky all year with our trip planning and catching fish with most of our charters this year, and these 2 charters were no different. We ended up getting limits of Yellowfin tuna on both trips (limited load of 30) with the last stop on both trips being what they call a "ripper"! Pretty much every bait that hit the water was inhaled. Screams of "use the heavy stuff" from the guys on the bait tank was echoed on both trips as the chaos ensued for a good hour or so on both trips.

When we were done on the "San Diego" trip, Ryan called in the "Liberty" and in they came. The skipper swung the stern of the "Liberty" into the stern of the "San Diego" and as Paul, who was standing on the bait tank of the "Liberty" started brailing the chum, they went solid bendo as Ryan slowly drove the boat away as not to spook the fish away from the "Liberty". It was quite a picture to see the "Liberty" go bendo with every rod and screams of delight from the passengers of both boats as the chaos developed! Quite a trip as many of the club members caught their first Yellowfin tuna and got to experience the pinnacle of tuna fishing as the fish were boiling and the passengers weaved their way around the boat trying to follow their fish so they wouldn't be cut off!

Some of the boats had struck out the day before, so there was a little bit of worry as we steamed south through the Islands checking conditions just in case we had to scoot back to the Islands to save the day. It turned out that game plan was not necessary as Taro found a school about 1:00 PM in the afternoon at 42 miles from Point Loma. They wanted to bite and Capt Taro encouraged every one to use the 40 lb. from the top of the bait tank. It did not take very long before the sacks were full of tuna for everyone! Pretty much the same thing on Sunday as we worked together the best we could with all the adrenalin pumping through our veins putting tuna on the deck! The bite finally died and the long process of stapling the sack numbers on the gill plates as the fish were dropped into the ice water below decks for filleting in a few hours. We hit

Great Job Gang!






PROCEDURE TO APPLY FOR AWARDS:

OCTOBER 2017 BASS SLAM TOURNAMENT RULES AND ENTRY FORM

October 21, 2017

PAGE 1 OF 2

Tournament channel 72

- The official starting time of the tournament is 06:00 am on Saturday, October 21st, 2017. The official ending time of the tournament is 4:00 pm on Saturday, October 21st, 2017.
- Boats may depart prior to the official starting time of the tournament. Boats must depart from and return to any port within the county of San Diego. No tournament fishing is allowed prior to the official tournament starting time. All club tournaments are operated on an honor system.
- The fishing areas of the tournament shall be limited to those waters of the Pacific Ocean within 125 miles of San Diego.
- 4. During the tournament, fishing can be done from any fishing platform, including sportfishing boats.
- Bait may be caught, purchased or acquired as available prior to the official tournament starting time. Bait may be kept aboard tournament boats, used or transferred at the discretion of the anglers or skippers throughout the tournament.
- IGFA angling rules will be used for this tournament. Angling rules can be found in the San Diego Anglers Yearbook under General Angling Rules. Anglers are responsible for compliance with all California or Mexican fishing and boating laws and regulations, as applicable.
- All fish must be weighed on the club scale between 3:00 PM and 4:00 PM at the San Diego Anglers Tournament Weigh Station located at the SOUTH SHORES LAUNCH RAMP in Mission Bay.
- 8. Species: Calico Bass, Sand Bass, & Spotted Bay Bass, Entrants can weigh only one (1) fish from each bass species.
- 9. Prizes will be awarded in the following Categories: <u>Heaviest Sack Weight</u> 1st, 2nd, 3nd, 4th and 5th place for adults; 1st, 2nd and 3nd for juniors. There will be no ties in any category. When two sacks of the same weight are submitted, the first sack submitted is considered the winner. Regardless of weight, a 3-bass combination beats a 2-bass combination, and a 2-bass combination beats 1 bass.
- 10. There will be a \$10.00 optional Jackpot for the heaviest single bass.
- 11. All anglers are responsible to stay aware of current weather/sea conditions. Monitor NOAA weather radio for info.
- 12. All tournament anglers must complete, sign and submit a <u>Tournament Entry Form</u> and a <u>COPY OF THEIR CURRENT BOAT INSURANCE POLICY</u> prior to wetting a line in this fishing tournament. Entrants may sign up any time prior to the tournament starting date and time. The entry forms must be turned in to the locations or persons listed on the back of this form. All entrants in the tournament must be current members in good standing or non-members fishing a one-time introductory tournament as a guest of a club member. Entry forms can be scanned and emailed to Tournament Director (Adam Larson) with all pertinent signatures, boat insurance info (if applicable), and date/time stamp. By signing the application, Applicant does assume all risks of injury or property damage, and does agree to hold the San Diego Anglers harmless should any injury, death or property damage occur.
- Failure to comply with any of these rules will result in the offending angler's disqualification from the tournament and possible termination of club membership.
- 14. Tournament Angler of the Year and Skipper points will be awarded for this tournament.
