1. | Announcements

There are three features to note in this release:

- WAND-175477 Future dating for requisition custom fields is now available. Future dating is used when you need to populate a custom field at a specific date, using the application Effective Dating feature. When the effective date = current date, the value is inserted into the field in the UI, and in the database, making it available in reporting, but not before.
- WAND-176510 For the Revision Approval Routing workflow, the routing now resets to a new/different approver/list
 of approvers when triggered by a specifc field value change. If you have a rule set up that a specific approver/list of
 approvers is used, for example, a department, then modifying the department on a request would trigger that
 approver/list of approvers to be notified to review. The existing approver/list of approvers is removed from the
 request.
- WAND-176538 Previously, client managers, workers, and suppliers had the ability to disable email triggers for their
 user accounts. That meant that when toggled off, actions that would normally trigger an email to configured parties
 would not be sent. This functionality is removed. Note that this is different from the Email Notifications fucntionality,
 which allows a user to disable emails to their configured email address.

3. | Enhancements

WAND-171212 - 'Allow Work Period Adjustment' In WAND I/O Adjustment Integration

A new flag in the WAND I/O Adjustment feed allows you to remove the 'Number of Hrs/Days exceeds 24/1' validation. Setting this flag to true allows you to enter an adjustment for the entire work period instead of one record for each date. This enhancement applies to the following fields:

- Reg Hrs
- OT Hrs
- DT Hrs
- Hdv Hrs
- Days Billed
- Rate Type Units

WAND-172329, WAND-172330 - Invoice Information Extraction Update With WAND I/O

The Invoice Extract outbound feed in WAND I/O is updated with JavaScript Transformation and Post Processing functionality. This enhancement also adds **Source Field** and **Output Field** to the field mapping.

This enhancement also includes the ability to export feed information in .cvs, tab, pipe, and .xls formats.

WAND-175477 – Future Dating Requisition Custom Field Value

You can now enter values in a Requisition type custom field at a future date. When you make a change, and future date the change, on that date, Wand inserts that value in the custom field. On that future date and forward, the value appears in the database for reporting and on the user interface.

This enhancement is enabled by default. For more information about requisition custom fields, see the 'Custom Fields Options by Workflow' section in the Knowledge Base.

WAND-176510 – Update To Revision Approval Routing Logic

Currently, when one of the configured fields for a request revision approval routing is modified, Wand automatically applies the change to the request and restarts the routing to the defined approver/list of approvers. Now, the logic is updated to consider if different approvers are configured for an individual field, for example, Manager A for Department A, and Manager B for Department B. In this example, Wand now routes the approval to the correct manager when the department on the request is modified (if department is the configured trigger). Previously, Wand routed the changes to the department approver on the previous version of the request.

The approval notification on the **Approvals** tab also reflects the change. The existing routing is cancelled, and the new routing is added for the correct approver. Email notifications are also sent to the correct approver.

WAND-176538 - 'Process Emails' Setting Update For Manager, Supplier, And Worker

The **Process Emails** setting for client managers, suppliers, and workers is now uneditable. The **Process Email** setting controls the email functionality in the application. A user completes actions that trigger an email notification to be sent to intended and configured recipients.

Previously, any of these user types was able to edit their user account settings. Now, only MSP users are able to modify the **Process Email** settings for user accounts. Note that this setting is different from the **Email Preferences** settings which controls whether a user receives an email notification or not. Users can still disable specific emails or groups of emails at the user account level.

WAND-190393 - Adjustments For Project Worker Engagements With WAND I/O

You can now submit adjustments for project worker engagements using the WAND I/O Adjustment feed. This enhancement is made in order to add adjustments in bulk.

WAND-191042 - Client Custom Fields In Engagement Data Export

All custom fields that have 'Visible in Views' = 'Client' and 'Display in Client User View' = T now display in the 'Custom – Worker Bin' when configuring the Engagement Data Export report.

WAND-198605 - Estimated Cost As Condition For Approval Routing Workflow Rule

You can now configure an approval routing workflow rule condition with 'Estimated Cost'. This rule is used to activate a specific workflow based on the cost of the request.

WAND-216907 - Project Worker Data Not Sent To ERP

Project worker engagements that do not have time card details configured (but are assigned to positions on a Project engagement) are now not sent to the application ERP (PeopleSoft). This change applies to project workers that are onsite or offsite, and are child engagements of Project or Project BizVal engagements.

This enhancement is enabled by default.
